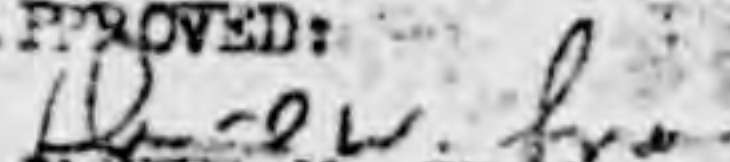

The following information is submitted: (1) Single object, round, bright and shiny. No trail, exhaust or means of propulsion observed. Appeared to be hovering for about 3 or 4 minutes. <u>Observer was driving car and lost sight of object while trying to get out of traffic and stop.</u> (2) Sighted 1045 PST, 11 August 1952 for 3 to 4 minutes. (3) Visual sighting from moving automobile. No optical or electronic equipment used. (4) Observer was driving automobile on George AFB, facing southeast. Object was very high (approximately 20,000 ft) and about 15 to 20 miles away. Appeared to be hovering over the San Bernardino Mountain Range. (5) Observer was 1st Lieutenant William F. Van Steenburgh, 146th Fighter-Bomber Group, George Air Force Base. Observer is 32 years of age, married and rated navigator (Not on flying status). Lt. Van Steenburgh has 12 years total service including 6 years officer status. Officer is considered reliable. (6) Weather was CAVU. Winds 70 degrees at 15 knots. (7) None (8) None (9) None (10) None sighted by observer.

STATEMENT OF OBSERVER

I, William F. Van Steenburgh, 1st Lieutenant USAF AO 2101826, 146th Fighter-Bomber Group, make the following statement concerning a certain unidentified object observed by me on 11 August 1952:

My observation took place at 1045 hours PST on the date indicated. At the time I was driving southeast on Main Street on George Air Force Base.

The bright object appeared almost directly in my line of travel at about 20,000 feet, and seemingly well away and over the range of mountains to the south and southeast of the station. It did not seem to have any noticeable motion.

I had intentions of going through the main gate and parking out of traffic where I could better observe the object with field glasses. Before I could get to the gate, the object had disappeared.

The object was visible to me for 3 or 4 minutes. It is possible that the object was round but the brightness could have given it that illusion.

a. The following information is submitted:

- (1) Sighted bright and shiny object, round, larger than large airplane. No exhaust, vapor trail or means of propulsion observed. Was hovering or in slight climb away from observer. No maneuvers.
- (2) Time of sighting 0801 PST 11 August 1952. Observed for approximately 1 minute.
- (3) Visual observation from F-51, altitude 6,000 ft., speed approximately 215. Observer was number 2 man in flight formation. Observer lost sight of object during turn in formation.
- (4) Location of observer was 34° 50' N, 117° 20' W. Object was approximately 45° at 15,000 to 20,000 feet at about 10 miles distance.
- (5) Observer was Amos F. Riha, Colonel, Commanding Officer 146th Fighter-Bomber Group, George Air Force Base, California. Colonel Riha is experienced, rated pilot. Considered very reliable.
- (6) Weather CAVU. Winds at 6,000 feet, 70° at 15 knots.
- (7) None
- (8) None
- (9) Colonel Riha led flight of F-51s to the area where object was last seen. Climbed to 14,000 ft. Nothing more observed.
- (10) Several flights of F-51s in area.

STATEMENT OF OBSERVER

I, Amos F. Rife, Colonel USAF 4593A, 146th Fighter-Bomber Group, make the following statement concerning a certain unidentified object observed by me on 11 August 1952:

I sighted the object while flying as number 2 man in a formation of F-51s. The time was 0801 hours PST on the date indicated.

The object was bright and shiny and appeared to be hovering or in a slight climb away from me. It was about 10 miles away at about 15 to 20,000 feet in altitude.

I observed it for about a minute until I lost sight of it while making a turn in formation. I led the formation to where I had last seen the object but did not see it again.
