"a flying saucers." We went back down to the camp site and changed clothes for a study meeting & the children could hardly settle down the rest of the day. I tried to explain what we saw to the other adults & they couldn't seem to understand such a thing or even imagine it - the hovering & disappearing part. Of course, all of us that saw it couldn't either [understand.]

I remember looking down & seeing the light so bright in a patch that covered about three of us. I noticed how bright it was on my legs.

The children thought they saw figures waving at us through the middle area of the craft. I think it was pure imagination. The hardest part to see, was the middle area. We argued whether it was windows, or metal or glass or a screen, etc.

There isn't anyone to this report.

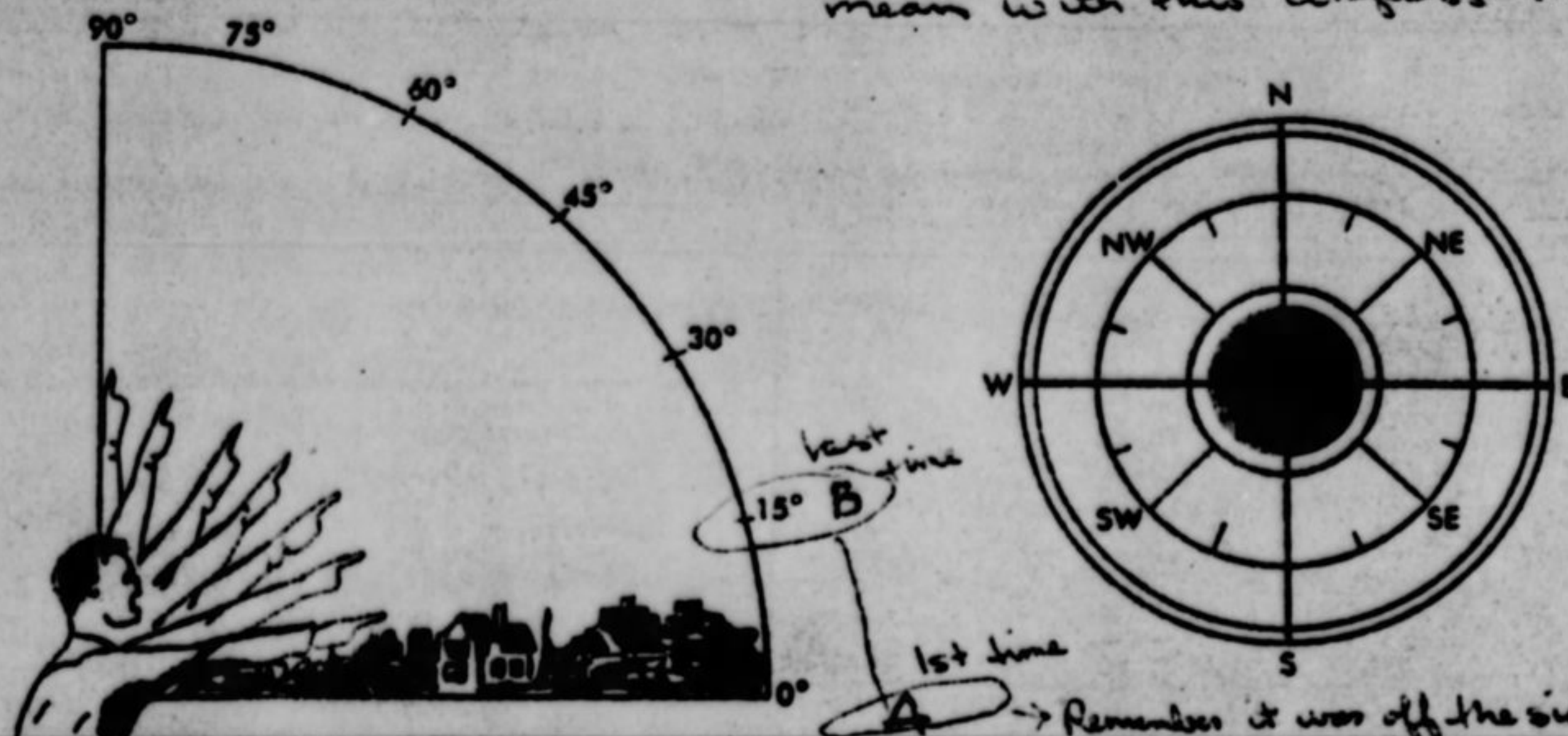

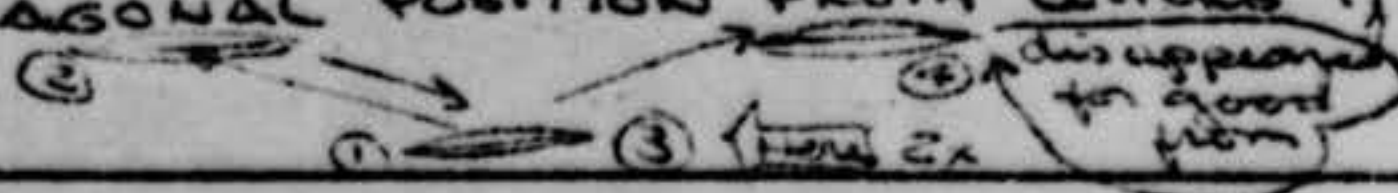

Dear Sir:

I had read of a meteorite in Alabama so I have decided to write you about my rocks: They fell in our back yard last September 1953. It has been learned that commercial a/c do fly nearby coming over nearby Riverdale on their way to Washington International Airport and do turn on their landing lights in this vicinity.

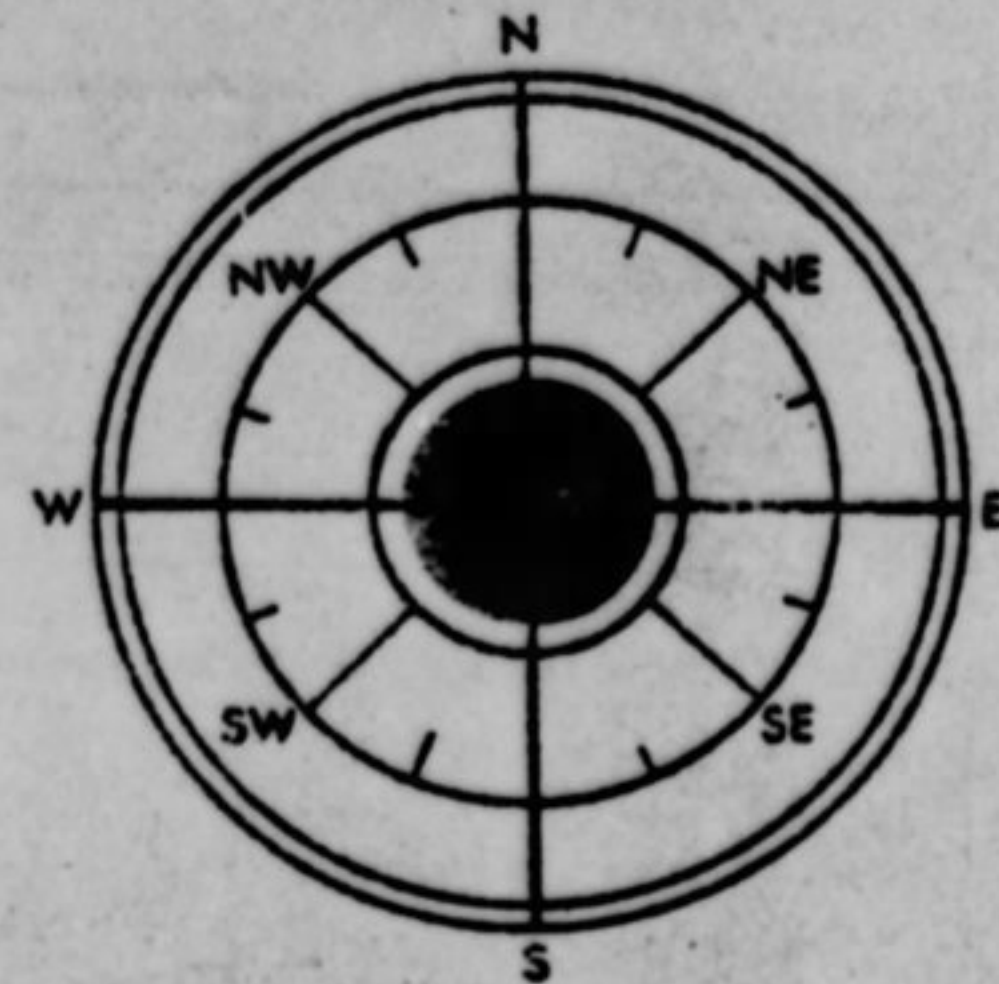
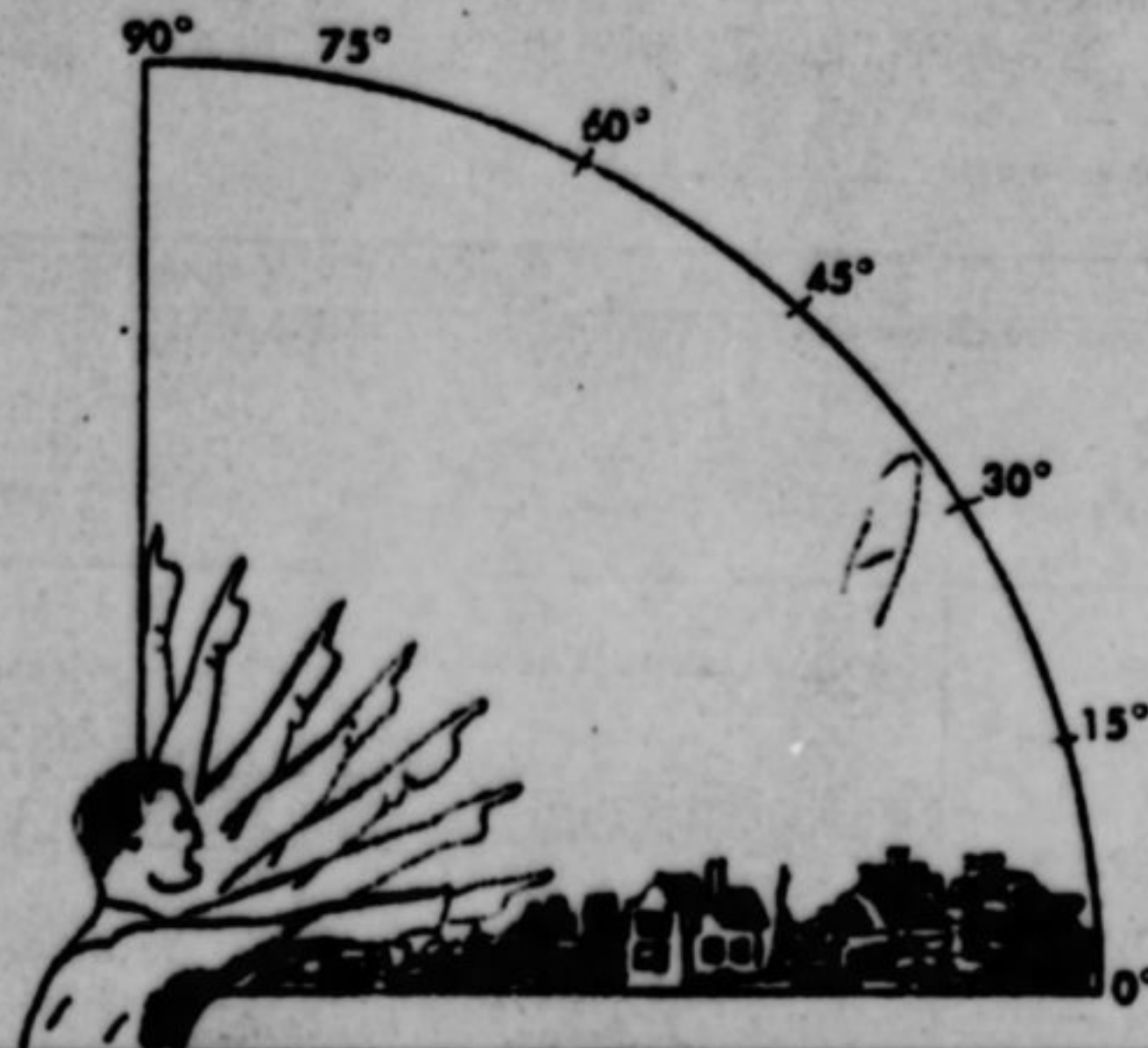
