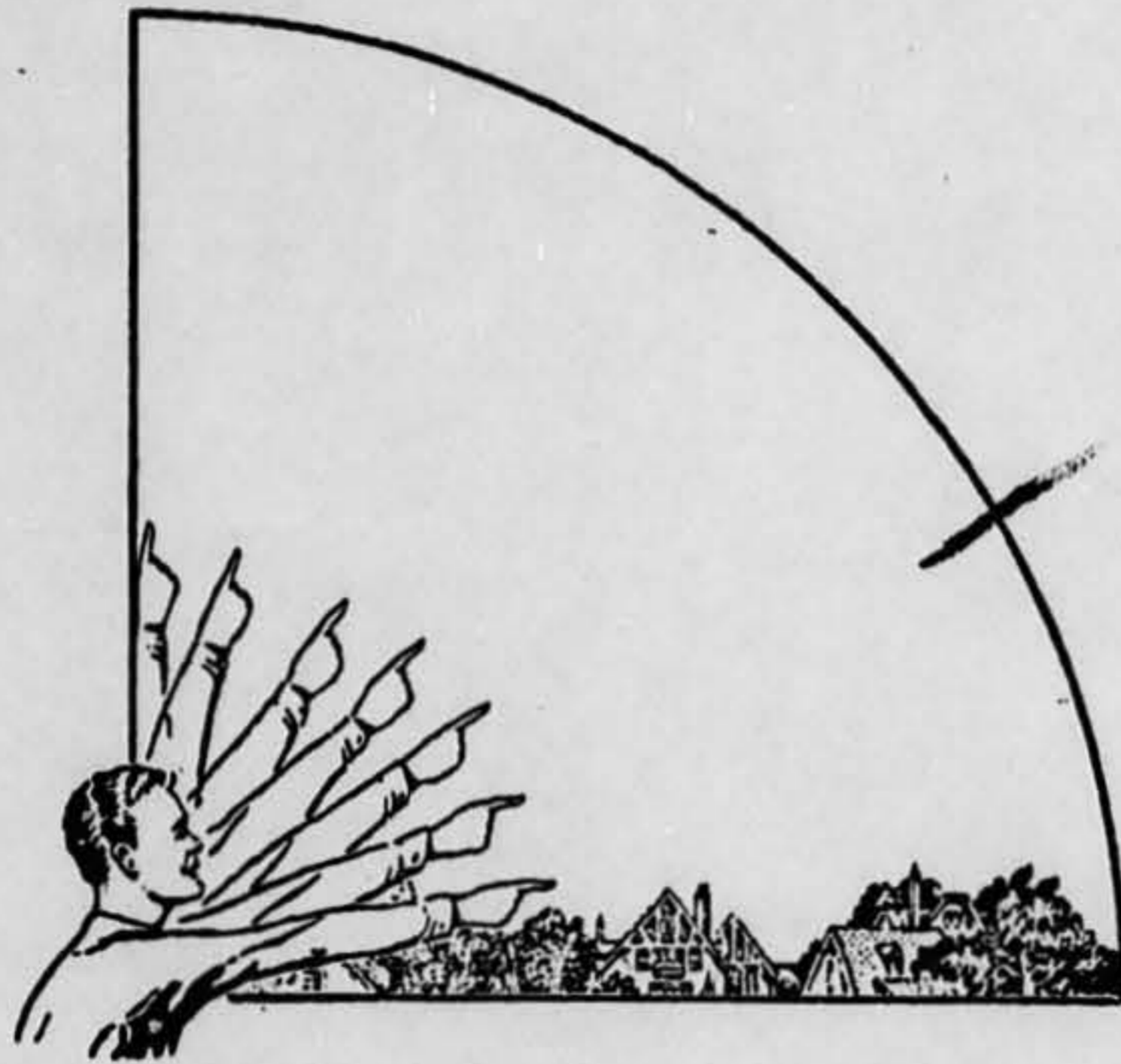

This thing that appeared in the sky was bright green. It first was oblong, then almost round, then oblong again, and finally disappeared as though someone had turned it off like a light. There was about 3 small pieces, or blobs of fuel, or something, that separated from the main body, trailed behind at second or two and then went out. They also were a bright green. I did not see anything like flames that would indicate a burning object. Nor did the green light give off any illuminating effects at any time. It was just there and glowing.

To me this appeared to be an object giving off a bright green light. I have never seen anything like this before and probably never will again.

1. The object sighted on the morning of 29 September 1958, at Gatherburg and Washington, D. C. was also seen and reported by witnesses as far west as Pittsburgh. The description, direction of motion and time were all in agreement.
2. The description of the object and possible sound is typical of a meteor which has made an unusually deep penetration into our atmosphere. The observatory at Georgetown University received several reports of this object and their conclusion was that it was a meteor. The description given by some witnesses that there was more than one object indicates breakup or burnout of the meteor.
3. The ATIC conclusion is that all witnesses saw the same meteor, and that small differences in the description of the item be attributed to the short time of observation, excitement of the witnesses, and a change in appearance due to breakup and the approach of burnout.

Aircraft, Balloons, Airships, etc. Description of flaming or burning round object rules out balloon. Object seen from Washington, D. C. to Pittsburgh at approximately the same time indicates a speed much greater than any of today's aircraft.

Other: No information concerning an errant missile.
The light which was seen on the ground near Washington, D. C. was definitely determined to be a floodlight on a barn.

Evaluation of Source Reliability The number and consistency of reports of this incident indicate the information to be both relatively accurate and reliable. Twelve different persons from Washington, D. C. to Pittsburgh, Pa. sighted this object.

Analysis and Conclusions:

In view of all the data in this case, the logical conclusion is that all witnesses sighted a meteor which made an unusually deep penetration into our atmosphere. The ~~still unofficial~~ report from Pittsburgh indicates possible remains of the item on the ground, but as yet still undiscovered.

This object was seen at Washington, D. C. and Pittsburgh at approximately the same time (possible minute difference depending upon the accuracy of the witnesses in determining the time). The speed necessary to accomplish this ^{in a minute} would be approximately 7,000 knots. The description of some witnesses that there was more than one object indicates the possibility of breakup and burnout of a meteor.



Guidelines for the declassification or extended classification of information concerning intelligence sources and methods shall be reviewed annually and personally approved by each Head of the Department or Agency concerned. Initially these guidelines will apply to all such information originated on or before 31 December 1946. In order to facilitate the systematic review requirement imposed on the Archivist of the United States under Executive Order 11652, these or later-developed guidelines may be provided to the National Archives and Records Service as needed.

3. A major purpose of any classification or declassification review is to make available to the general public the maximum amount of data consistent with the obligation to safeguard national security interests. These interests include the protection of sensitive intelligence sources and methods. Such intelligence is identified as that classified intelligence; the unauthorized disclosure of which could lead to counter-action (1) jeopardizing the continued productivity of intelligence sources or methods that provide intelligence vital to the national security, or (2) offsetting the value of intelligence vital to the national security. "Sources" can be identified as the origins of information and "methods" as the ways by which intelligence data and/or intelligence sources are developed. In many cases, sources and methods are inseparable.

GUIDANCE

1. GENERAL

a. If, upon review under these guidelines, it is determined that a document must remain classified but much of the information therein could be declassified provided certain limited portions were excised, such as those which identify sensitive intelligence sources and methods, this fact should be noted. This will enable the Archivist to provide sanitized versions of otherwise classified documents to the public provided they are otherwise releasable under the law. However, care should be taken to ensure that the sanitization of a document does not change its meaning.

1. On the morning of 29 September 1958 between 0925Z and 0935Z three sightings were made of unidentified flying objects.

2. The first reported sighting was made by a [REDACTED] who reported that he saw two pale blue, circular objects travel from the south-east to the northwest on approximately a heading of 310 to 320 degrees. The objects disappeared behind a house and by the time the observer ran to the rear of the houses the objects were gone. The objects were in view approximately 2 to 3 seconds. The time of this sighting was 0925Z plus or minus a couple minutes. The place of the sighting was in the Mount Lebanon district of Pittsburgh, Pa..

3. The second reported sighting was made by a Pennsylvania railroad worker who was on his way to work. He was parked, awaiting for a rider when he noticed the object. He was parked [REDACTED] Parkway west on route 22-30. The object was round and pale blue in color and appeared to be disintegrating with pieces falling off. It was heading from South-east to North-west. It was visible for about three to four minutes. The sighting was made at 0930Z. The age of the person who sighted the object was 33.

4. The third sighting was made by a Sales Engineer for the Pennsalt Chemical Company of Natrona, Pennsylvania. This sighting was made while the observer was traveling west on the Pennsylvania Turnpike at 0935Z, three miles east of the Allegheny Tunnel, which is approximately 5-70 air miles east of Pittsburgh, Pa., The observer reported that it appeared to be shaped like the head of a 75 M shell. It was enveloped in a blue, green tinted flame and left a fire tail of 50-60 feet. The object appeared to break apart in the air. No noise was heard. The object was visible three to four seconds. The heading of the object was between 310 to 320 degrees.

5. A field trip was made by helicopter to the area mentioned in paragraph #4. The persons living in the immediate area were contacted however no one had seen or heard anything unusual during the period.


6. It is felt by the investigating officer that there was definitely something in the area, however no guess will be ventured as to what it was or where it came from.

On Thursday, 2 October 1958, the Army supplied us with an H-21 Helicopter and we proceeded to the area. Four different families were contacted with no results. A search was conducted on foot but nothing was found.

It is the opinion of the reporting officer that there was definitely a group of unknown objects in the area, however, as to their origin, composition and mode of propulsion, no comments can be made.

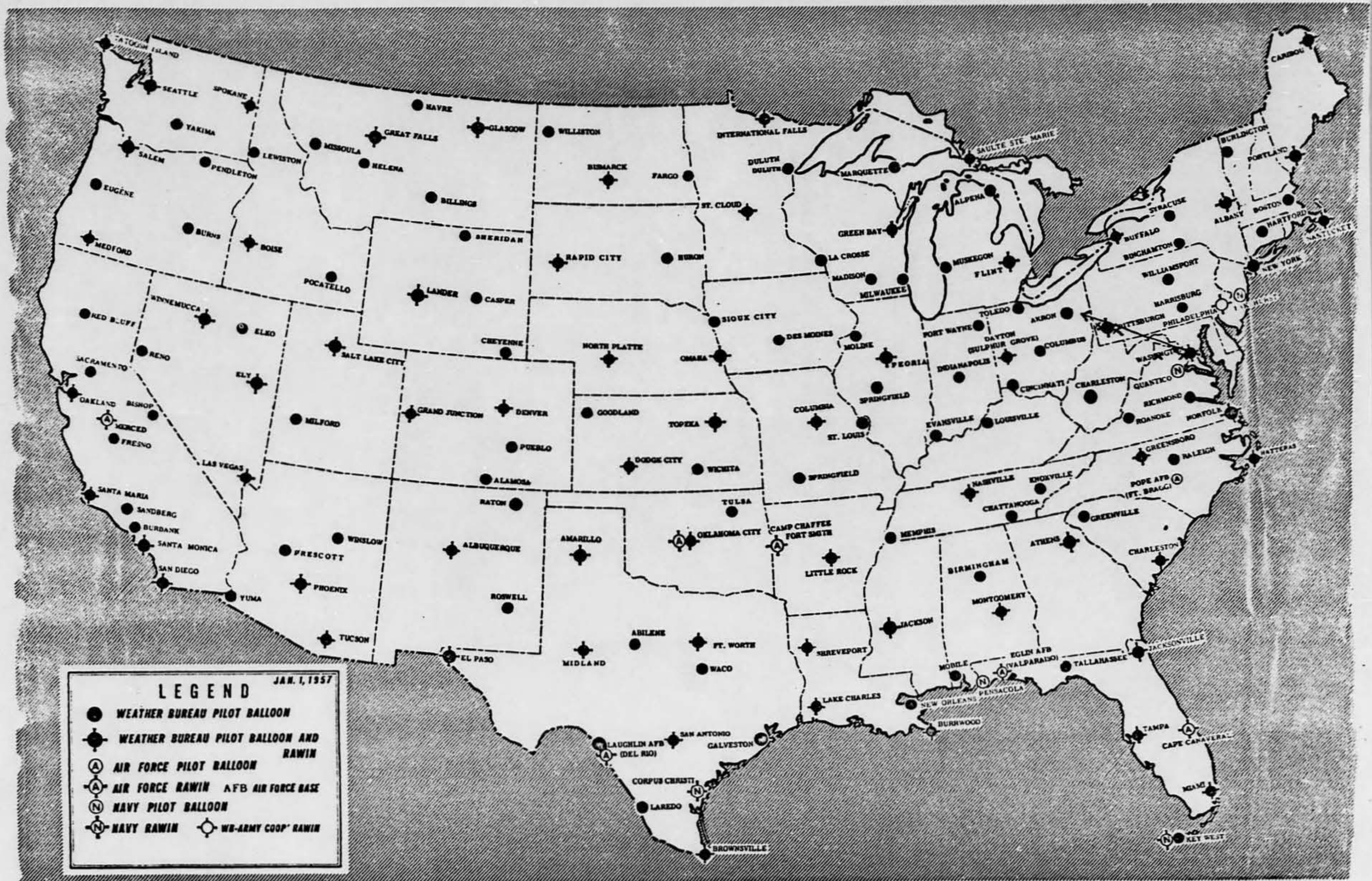

At least a score of persons reported sighting a mysterious flying object in the Harrisburg skies early today.

But as usual, there was no official identification of the object, nor could anyone determine where it came from or where it went.

Olmsted Air Force Base at Middletown had nine reports of the brilliantly lighted object, but officials pointed out there were the "usual differences" in describing its color, shape and direction. In addition, more than a dozen persons called The Evening News to inquire about it.

According to most reports, it flew from south to north at about 5:30 a.m. Some described it as a blazing, white triangle, trailing sparks. Others said it had the shape of a barrel. Another said it had no distinguishable shape.

Olmsted officials said it could have been a jet or a meteorite.



Bright Object Shooting Flame Seen In Sky

HARRISBURG (UPI)—Olmsted Air Force Base today received reports of a mysterious object shooting across the central Pennsylvania skies early today.

The descriptions from nine individuals reporting to the base varied, but most agreed it was a bright object, emitting sparks and spouting an orange colored flame and traveling east to west.

The object was seen by five persons at Middletown and four employes at the base. In addition reports were received by newspaper and radio stations.



I would like to report an experience I had early this morning, about six o'clock


I was driving south towards Frederick, Md. and was about eight miles from the town when a light passed in front of my car. It was about five hundred feet high and travelling from East to West, it's path was toward the ground and on a path that a plane would make when on a twenty to one glide. It's speed was faster than an approaching plane but its approach path was about the same. My reaction to the sight was that I could not remember any landing field Northwest of Frederick, Md.

In about half a minute I came upon a car that I had been following, in this car were my two sons and a friend of their's. They had stopped their car and were standing outside of it and quite excited. The light I had seen had passed directly in front and above them, they could hear it as well as see it. All three were agreed that as the light came very close to the ground and some distance to their right, to the West, it lost it's entirety and became three lights, one large one and two small ones, the latter became extinguished quickly but the main one continued on to the ground. Also they are positive ly agreed that it was not an airplane.

The weather was CAVU. I am a pilot with more than eight thousand hours, being actively engaged as an Army Instructor during the last war and since the have been employed as an instructor in a commercial capacity and for the past five years have held a position as an executive pilot. My oldest son is twenty years old and is now working for Capital Airlines at Washington National Airport, my other son is a Junior in High School, their friend is an Navy electronic student at New London, Conn..

I have referred to it as a light because there was no downward beam customarily seen from a plane's landing lights, and it was more of a bluish light than an amber one.

Radar Analysis (AFCIN-4E1) No radar data.

Natural Phenomena

Ball Lightning, etc. Large area over which this sighting took place, singular type of occurrence, makes it highly improbable that this was a natural phenomenon. Weather conditions at the time add to the improbability.

Aircraft, Balloons, Airships, etc. Description of flaming or burning round object rules out balloon. Object seen from Washington, D. C. to Pittsburgh at approximately the same time indicates a speed much greater than any of today's aircraft.

Other: No information concerning an errant missile.

The light which was seen on the ground near Washington, D. C. was definitely determined to be a floodlight on a barn.

Evaluation of Source Reliability The number and consistency of reports of this incident indicate the information to be both relatively accurate and reliable. Twelve different persons from Washington, D. C. to Pittsburgh, Pa. sighted this object.

Analysis and Conclusions:

In view of all the data in this case, the logical conclusion is that all witnesses sighted a meteor which made an unusually deep penetration into our atmosphere. The still unofficial report from Pittsburgh indicates possible remains of the item on the ground, but as yet still undiscovered.

This object was seen at Washington, D. C. and Pittsburgh at approximately the same time (possible minute difference depending upon the accuracy of the witnesses in determining the time). The speed necessary to accomplish this would be approximately 7,000 knots. The description of some witnesses that there was more than one object indicates the possibility of breakup and burnout of a meteor.

Sept. 30, '58

Boone Co. Airport:

You may, or may not be concerned about this observation.

TIME: Monday Sept. 29, 1958 (yesterday) at 4:30 A.M.

WHAT: a green light - coming from the direction the airplanes travel when leaving Boone Co. airport - and traveling practically horizontal in the east towards the north.

SIZE: \odot h. - about 8 or 10 times as bright as a star

COLOR: A few shades brighter and deeper green than this paper.

BEHAVIOR: Traveling about twice the speed of an airplane. Dropping pieces of green light which trailed a second and went out, like a rocket which was burning. The light itself "burnt out" just about in a due east direction.

Since it seemed to come from your direction, it would seem best to send this observation report to you. My husband also saw it.
