BACKGROUND:

Shortly after I appeared on the Jim Westover "Night-Line" radio show on UFOs on November 30, 1964, I received a phone call from an old acquaintance who works at another Sylvania plant in Needham, Massachusetts. He informed me that one of the women working for him had heard the program and during a conversation had mentioned that she and others had seen two round lighted objects over a field in Maine. I phoned the woman, Mrs. [REDACTED] and later interviewed her and her sister personally and separately. The sighting account is as follows.

SIGHTING:

It was a clear summer's evening. The moon was shining brightly. [REDACTED] was getting something from the car in the driveway when she heard a humming or whirring sound. She glanced across the road and saw strange lights flying low over a field about 1000 feet away. At first she thought it was an airplane about to crash but no airplane motor was heard and the lights appeared to stop moving & remain motionless over the field. She sent her son Robert to alert others in the house. Others came out to see and a pair of 10X binoculars and movie camera were obtained. [REDACTED] sister, got on the phone which was just inside the door and told the telephone operator that they were witnessing. The operator contacted Civil Defense headquarters at nearby Auburn. Meanwhile, Baily and her step-father shouted to her keeping her informed to what the object was doing. [REDACTED] in turn, relayed the information to Civil Defense who in turn said they would notify the Air Force.

[REDACTED] using the binoculars, got a good look at the object which she reckoned must be "one of those Flying Saucers". She exposed a remaining 2 feet of film left in the camera but without the binoculars, only lights could be seen. Later, when the film was developed, that was all that could be seen - some vague lights. However, with the binoculars, [REDACTED] and the others saw clearly what the object was.

The object, after moving back and forth across the field "floated" down onto the field and the lights went out. Then, another object moved across the field and hovered over the landed one. Each one looked like

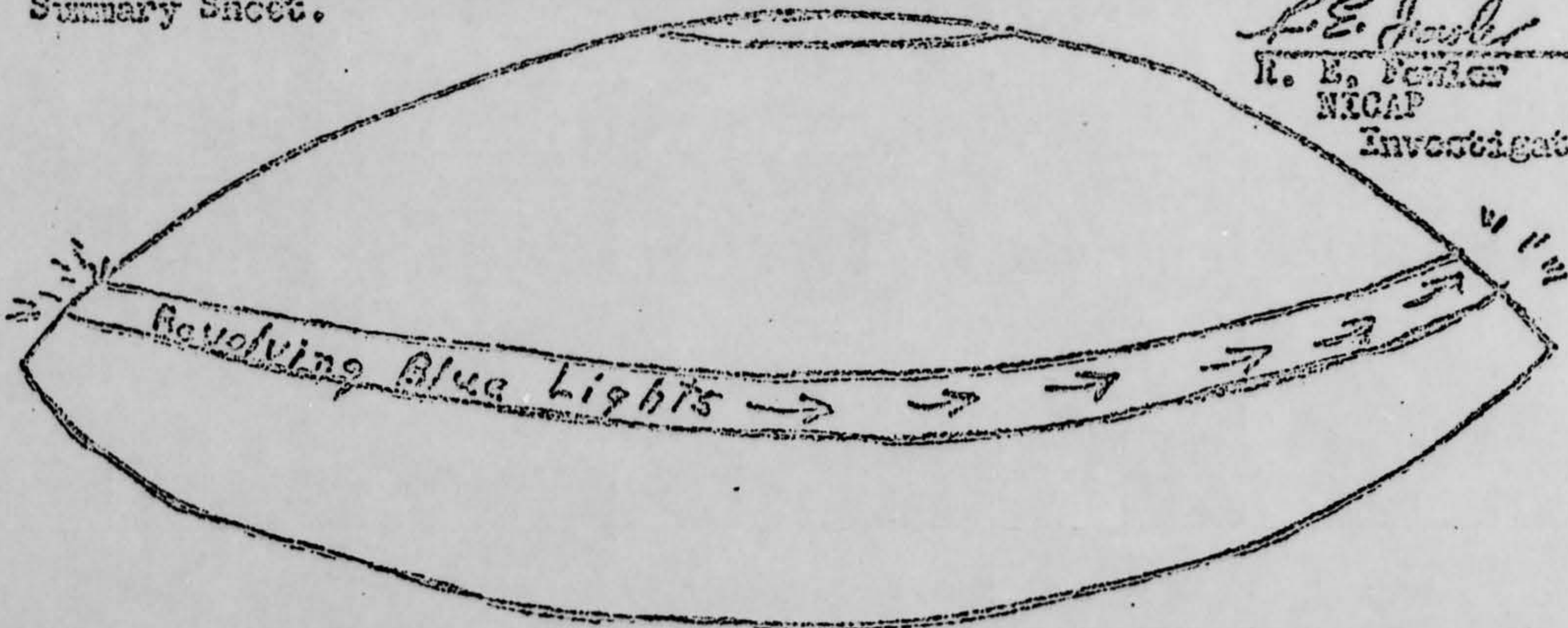
two saucers, one inverted upon the other and joined by a dark rim which looked as if it were made of dark glass. Behind this seemingly transparent rim were bright blue lights which revolved around the rim. They were as intense as a welder's torch and made [redacted] eyes water when she looked at them through the binoculars. The objects themselves seemed a dull silver-gray in color; definitely solid and moved about in a strange "floating" manner. Then, the object on the ground "floated upward", slightly to the left and joined the other one and both took off at terrific speed". Later, 2 jet aircraft flew over an adjoining field. It was not known for sure whether they were attempting to intercept the objects. The next morning [redacted] and her father went out to the field where the objects were. They found a "small area of singed grass" which smelled as if it were recently burned. Later that day, two strangers (men) in sports clothes were seen walking in an adjoining field. They did not come to the house to ask questions so there is uncertainty as to whether they were investigating the incident. The witnesses decided they would try to forget the whole thing and talk no more about it to anyone for fear of unwanted publicity and possible ridicule. However, it was a weird experience and they still remember it very vividly.

EVALUATION:

I checked on [redacted]'s character through two men at [redacted] for whom she had worked. I know both of these men personally and they vouched for her integrity and excellent work. She turned her house upside down in an attempt to find the 2 feet of film she had clipped and set aside in an envelope. She stated that the film sequence was short and showed only vague lights. I have stressed that NICAP would still be very interested to examine the film if she were to find it and she has agreed to let us borrow it for examination and duplication if it is found. In addition to the blue lights on the object, her son says he remembered seeing a red light on the objects as well.

I cross-examined both [redacted] and [redacted] very carefully and am convinced they are telling the truth. Normally, an old sighting like this would not warrant a detailed report but because of its seeming authenticity and detailed description of the UFOs, I felt it would be valuable to have on file for comparison with other UFO descriptions. A copy of her drawing is reproduced below for those readers who receive only this Summary Sheet.



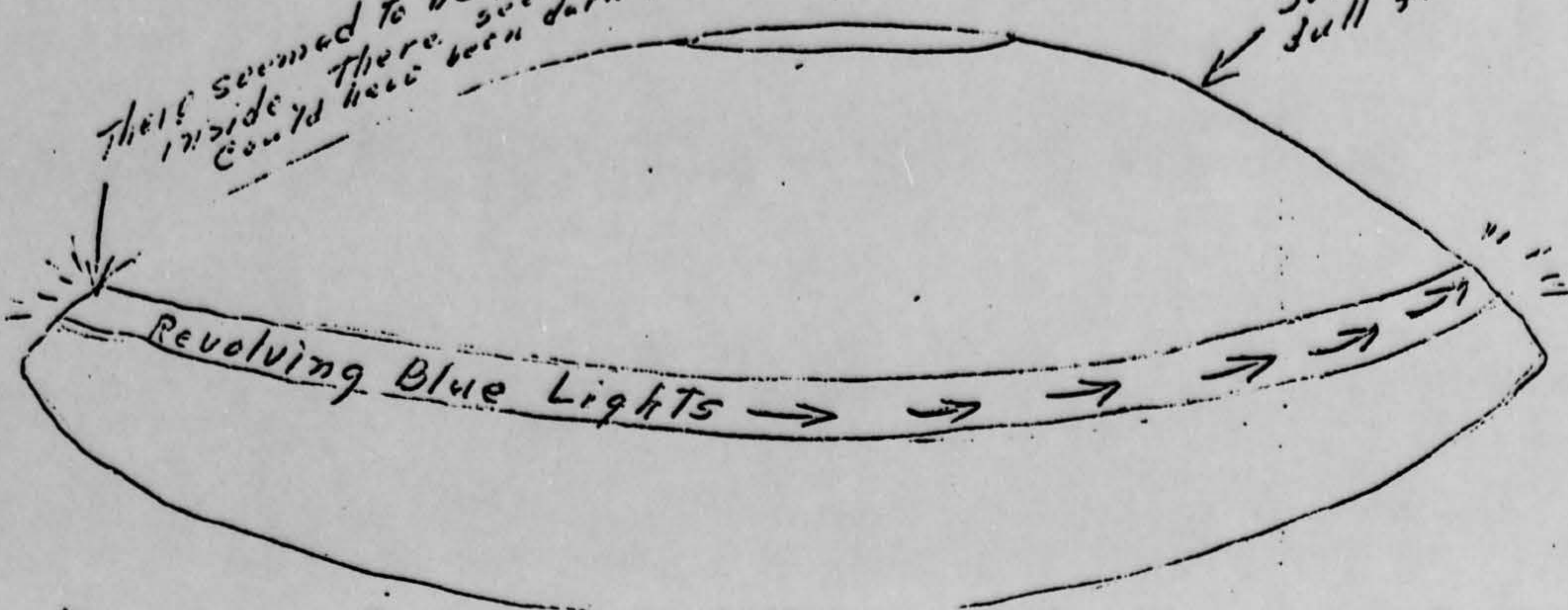

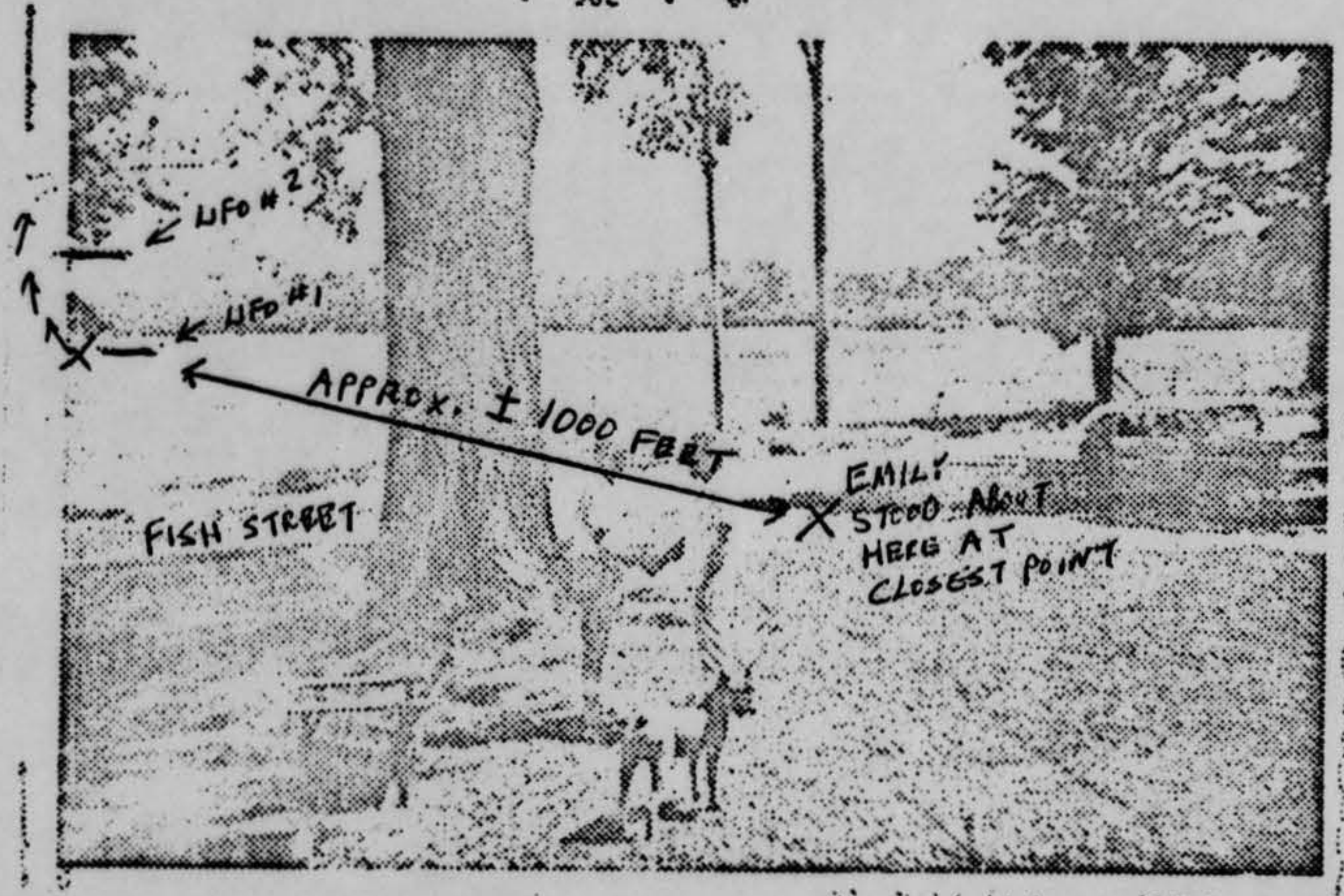
They seemed to be glass here, with the blue lights on the top of it, inside there seemed to be a darkness. I'm not sure of this. There could have been dark glass.

Place - Fish Street, Turrer, Maine

Night time - the moon was almost overhead and bright - no clouds that I can recall. After it was over, and we had settled down - a few days later - it was decided to forget the whole thing and not talk to anyone about it. People who have ever seen such things will understand, but those who have not, are very quick to ridicule. My sister, [REDACTED] had gone out to her car for something - I can't remember if I or my step-father went with her. She noticed the low-flying lights first. We thought a plane was in trouble, but could hear no motor. After watching a minute or so, and making sure they were not going away, I naturally thought the plane was gliding in and about to crash. The phone was right inside the front door - I called the operator and asked for the Air Force Field - told her to hurry. They told me there was no plane reported in that area - While we were talking, my sister and step-father were shouting to me the direction the lights were moving. They changed several times. I was connected with the Civil Defense and they made a note of it.

While my sister had the field glasses most of the time, I could not see as clearly as she. I did think it odd that the lights moved as erratically as they did. They came from the right side of the field and moved to the left - very unevenly. We thought they had gone away, but still watched. Soon other lights came and again we saw the lights - now two rows of lights move off. The color of the lights - a kind of bluish white that penetrates a long way. A tinge of something red was in the first lights. The lights did not ~~blink~~ - blink they pulsed. (Movement reminds me of the way a squid moves in water).
