1. In accordance with AFR 200-2, paragraph 15, dated 14 September 1959, the following Flying Object Report is submitted:

a. Description of the object:

- (1) Shape - slightly elliptical.
- (2) Size of a grapefruit.
- (3) Color - Similar to a star but very bright.
- (4) Number - 1
- (5) Formation - N/A
- (6) Discernible features: Object was traveling on a steady course and appeared to weave slightly.
- (7) Tail or Trail: Non observed.
- (8) Unusual Features: Object seemed to stop and move in spurts.

b. Description of Course of Object:

(1) When I first noticed the UFO at 1845 hours, 19 December 1960 at Capehart Housing, Tyndall AFB, Florida, azimuth  $315^{\circ}$ , it seemed to be stopping and moving in spurts. I observed it for a while to make sure it was not an aircraft. I called Captain [REDACTED] (Rated Pilot) and MSGT [REDACTED] to look at it. I tried to call Captain [REDACTED] (Director of Operations) but he was not at home. The Base Weather Station was notified.

(2) Angle or elevation and azimuth of object: I first noticed the object in the northwest on an azimuth of  $315^{\circ}$ .

(3) Angle and azimuth of object seemed to disappear on an approximate heading of 135°.

(4) Description of flight path and maneuvers of object: The object traveled from northwest to southeast and was very high. It appeared like a bright star moving in spurts and zig zagging slightly. It seemed to be brighter than any object in the sky.

(5) Manner in which object disappeared: Faded out of the southeast at 1900 hours.

(6) Length of time object was visible: 15 minutes.

c. Method used in Observation:

(1) Ground - visual.

(2) Optical Aid: Telescope.

(3) Aircraft used: N/A.

d. Time and date of sighting: 1845hours, 19 Dec 60

Light condition: night.

e. Location of Observer: Capehart Housing, Tyndall AFB, Florida

f. Identifying information on observer:

(1) Civilian - N/A.

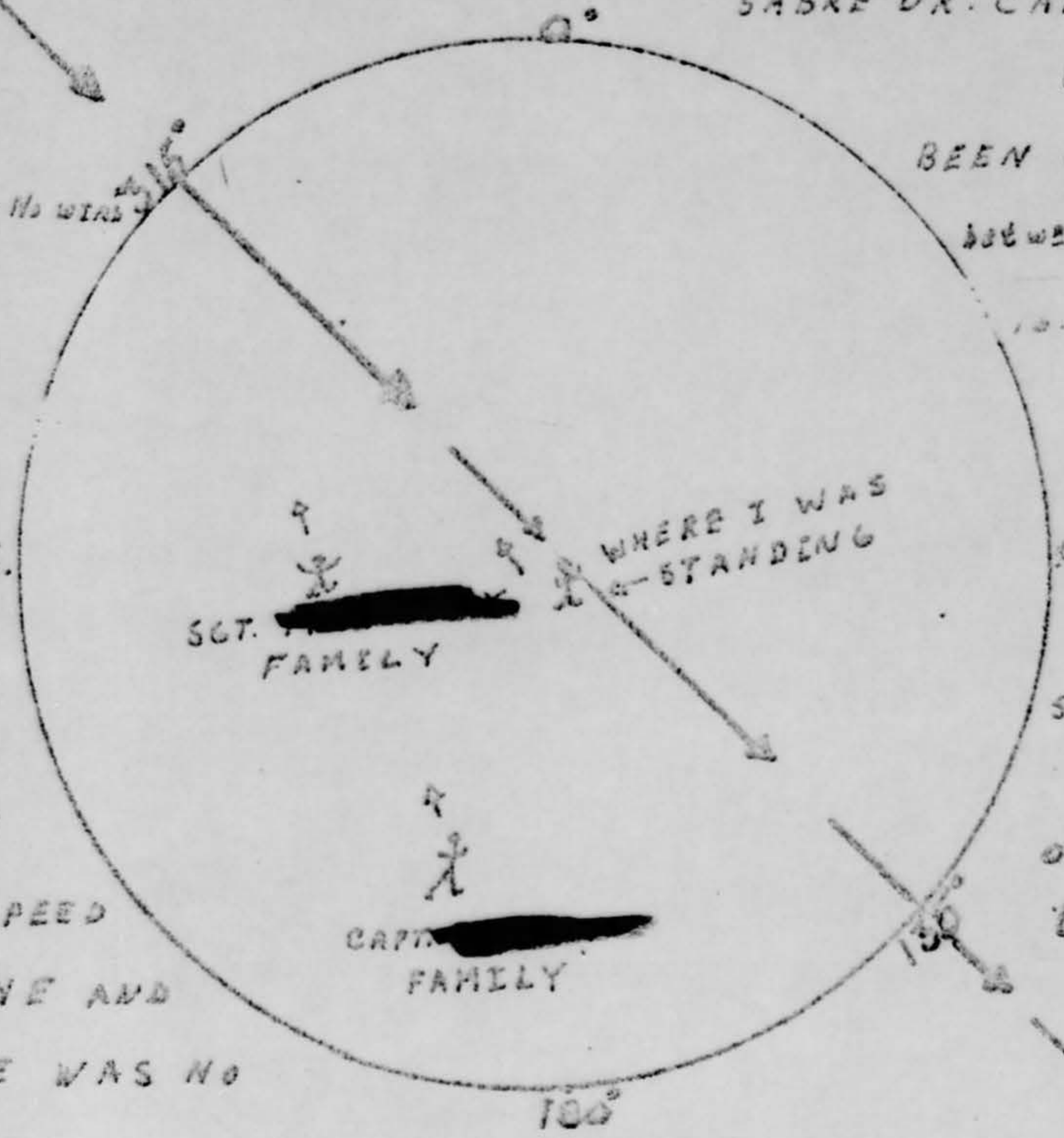

SUBJECT: Report on Unidentified Flying Object (UFO)

TO: Aerospace Technical Intelligence Center (AFCIN) 4E2X)

1. In accordance with AFR 200-2, paragraph 15, dated 14 September 1959, the following Flying Object Report is submitted:

a. Description of the object:

- (1) Shape - slightly elliptical.
- (2) Baseball - larger than evening star.
- (3) Color - similar to star, but very bright.
- (4) Number - 1
- (5) Formation - N/A
- (6) Discernible features: Object was traveling on a steady course, weaving slightly.
- (7) Tail or Trail: None observed.
- (8) Unusual Features: The object seemed to stop and move in a spurt.

b. Description of Course of Object:

(1) When I first noticed the UFO at 1835 hours, 16 December 1960, at Capehart Housing, Tyndall Air Force Base, Florida, azimuth 315°, it seemed to be stopping and moving in spurts. I observed it for a while to make sure it was not an aircraft. I called my family, M/SGT [REDACTED] and family and Captain N [REDACTED] (Rated Pilot) to look at it. I tried to call Captain [REDACTED] (Director of Operations) but he was not home. I called the Base Weather Station and talked to A/3C King. He noticed the UFO.

(2) Angle or elevation and azimuth of object: I first noticed the object coming on an azimuth of  $315^{\circ}$ .

(3) Angle and azimuth of object seemed to disappear on an approximate heading of  $135^{\circ}$ .

(4) Description of flight path and maneuvers of object: The object traveled from northwest to southeast.

(5) Manner in which object disappeared: It faded out.

(6) Length of time object was visible: 10 or 12 minutes.

c. Method used in observation:

(1) Ground - visual.

(2) Optical Aid: Telescope but could not get a good view as it was moving too fast.

(3) Aircraft used: N/A.

d. Time and Date of Sighting:

(1) 1835 hours, 16 December 1960.

(2) Light conditions: Night.

e. Location of observer: Capehart Housing, Tyndall AFB, Florida.

f. Identifying information on observer:

(1) Civilian - N/A.

(2) Military: MSGT [REDACTED] 4756 AB Gp (Training Section), Tyndall AFB, Florida.

g. Weather and Wind: Aloft conditions:

(1) Fair and clear.

2. Additional remarks:

a. The UFO was also seen at 1830 hours, 17 December 1960 by MSGT [REDACTED] and my daughter. I told them to watch for it as I was going to the show.

b. At 1930 hours, 18 December 1960, I spotted the UFO. I called MSGT [REDACTED] and family, also my family. I phoned the Base Weather Station and they also noticed it. I called Captain [REDACTED] and he also noticed it. The UFO seen tonight was similar to the above report. I noticed it for 15 minutes.

c. Special Visual Aid: I looked at the UFO with a telescope (approximately 30 power) and it appeared as a very bright star with a motion like the letter Z. It had a color similar to a diamond when moved in the sunlight. It could also be compared with a Christmas sparkler when waved back and forth.

d. Consolidated Reports: Judging from the information gathered, the UFO's seen on the 16, 17 and 18 December could be considered as one report with the exception of the time and dates.

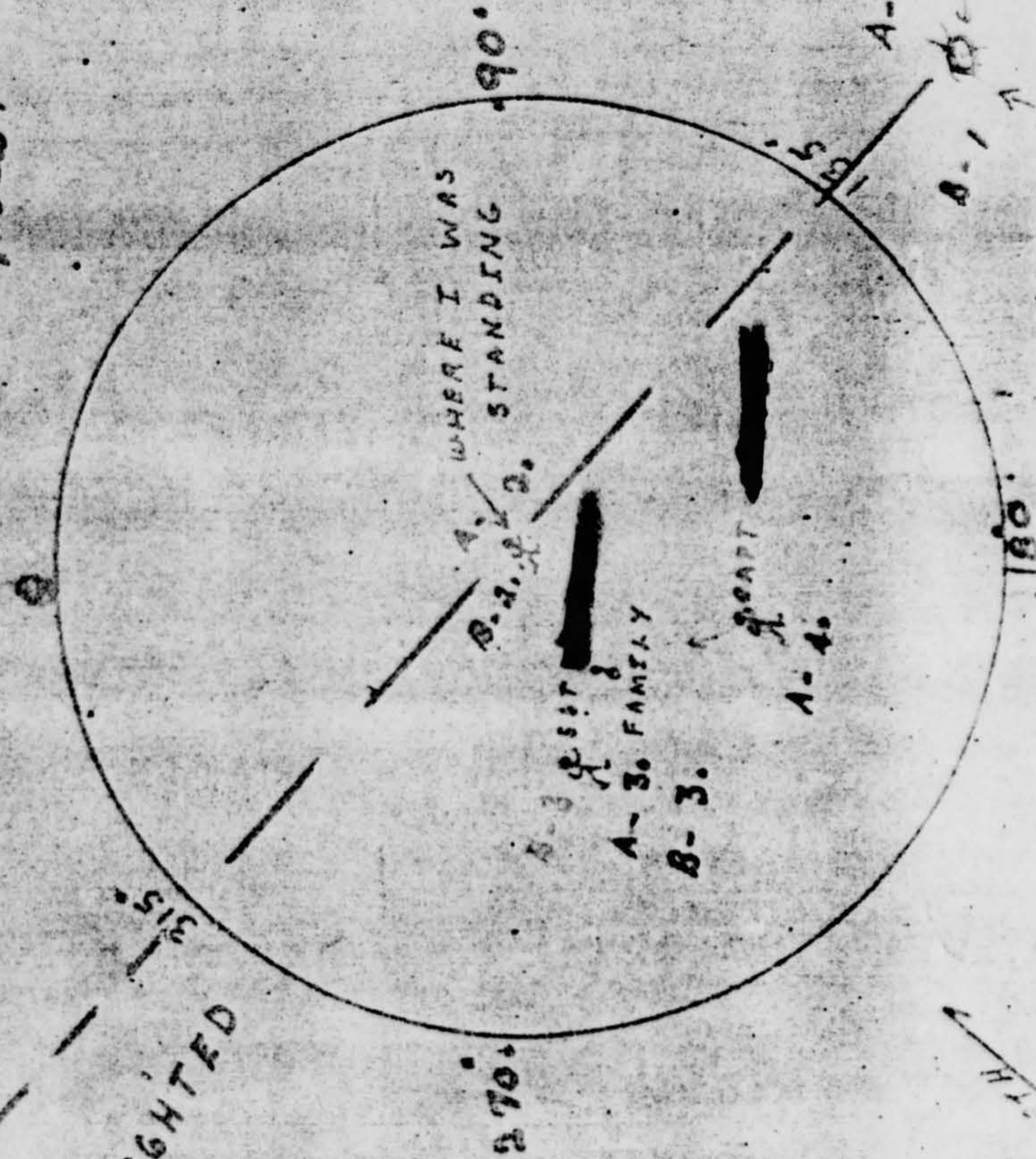
