SUBJECT: Unidentified Flying Object

The following information received from OSI District 12, Chanute AFB, Illinois is furnished for your information and any action deemed appropriate.

" At 1255 hours, 25 May 1962, S/A WILLIAM T. TILLER, Chief, Security Branch, FBI Field Office, Indianapolis, Indiana, telephonically contacted OSI Detachment 1201, Bakalar AFB, Indiana, and advised that a Mr. ██████████ Indianapolis, Indiana, had contacted his office on 24 May 1962, reporting an unidentified flying object. ██████████ stated he was driving along U.S. Highway 100, between London, Kentucky and Danville, Kentucky, at approximately 4:00 a.m., 7 May 1962, when he observed a bright red object with a long, white, even tail go down and disappear in a valley, west of the above location. ██████████ stated the object made no noise and that the white tail was untapered. ██████████ notified the Bardstown, Kentucky Police Department who apparently ignored his allegation and showed no interest. TILLER advised that ██████████ sounded rational and concerned when reporting the above information."
