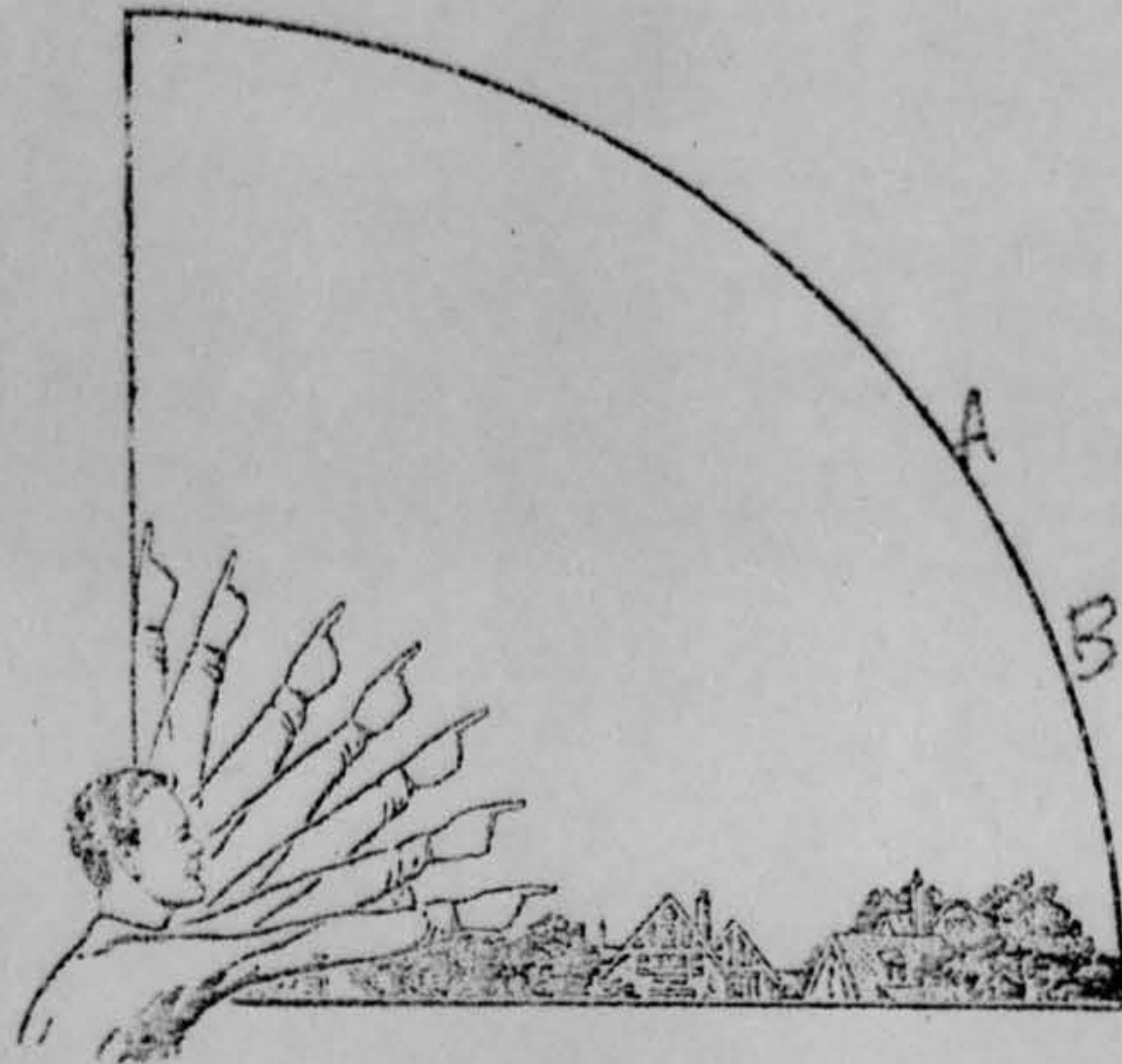

THE "ORRVILLE PHOTO"

In the Spring of 1963, the program called UFO Roundtable, received a photo of a "flying saucer" in the mail. The sender was anonymous; the envelope was postmarked Orrville, Ohio (Wayne County).

The UFO Roundtable featured Mr. Earl Neff, of the Cleveland Ufology Project, and was M.C.d by Harv Morgan, of KYW Radio, Cleveland, Ohio.

It showed a UFO over a cornfield. The stereotyped "flying saucer" has a dome, flat base, and has a metallic shine.

The time, according to the two boy photographers, was between 2:00-3:00 P.M. (EDST). (Sun's position can be ascertained by negative.)

The date of this occurrence was July or August of 1962. The corn's height (1964) observed by the Editor on different occasions, places the time somewhere in the last two weeks in July.

The boys were taking pictures of a new kitten in their back yard, when someone in the vicinity of a truck stop, a short distance (S and W) away on U.S. Rte. 30, shouted that something was up there. They scanned the sky and soon saw an object moving from S-N at a very slow speed. (40 MPH) The object seemed to be about 300-500 yards away. Its angle of elevation was about 15°, and its altitude, low. When the object was directly W of them, it abruptly turned toward them (E). Both boys claimed to have attempted photos of the "flying saucer." Three photos were taken in all. The photo in question was taken through a 1-27 Brownie - Special. The other photos taken by the second photographer (reflex camera) have not been seen by any other UFO researchers as far as we know.

The boys said the "UFO" passed directly over their heads at 500-1,000 feet. Its speed then was about 2-3 times a light plane's speed. It flew almost level, gradually accelerating into the east. The whole sighting lasted less than a minute.

The bottom of the object was dark or lead-colored. One boy thought it had a granulated look. Its dome was aluminum-like. No protrusions of any kind, no details. No trail or exhaust, no lights, no sound.

When Mr. Herman, an officer at Quality Castings of Orrville, Ohio, attended our lecture to the Wayne County Astronomy Assoc., in Wooster, Ohio; he showed interest in, and offered his help in "smoking-out" the anonymous photographers. His interest had previously been piqued when he saw the picture of the UFO in the Orrville newspaper accompanied by an appeal. (Photo placed by Universal Meritician Society of Medina.)

We accepted his offer of assistance, and to our great surprise, we were notified a week or ten days later that he had tracked down the "culprits." Mr. Herman arranged a meeting at which FSIC's chairmen met the boys. They released the negative (permanently) to us, and related the circumstances under which the photos were taken.

Mr. Herman found out in the process, that one of the boys had used a UFO photo in connection with a theme for his science class (Mr. Lyons). But that photo was different than the one in question and apparently just as "authentic."

Mr. Close, a Cleveland private detective, had the "Orrville Photo" analyzed by experts. The findings were negative; the photo was declared a hoax. According to them, the object was nearby; a model about 18 in. from edge to edge. They also found that the reflection effect could only result from the sun shining on a small object, not the large object described by the boys. (20-40 ft. in dia.)

In previous talks with the boys, FSIC's representatives gave voice to a similar theory, but the boys vigorously denied any such speculation.

Although FSIC's representatives found several discrepancies in the several talks with the boys, they were unable to wrangle an admission that the photo was resourcefully concocted. They insist to this day that their story and the UFO are true.

Even though the weight of the evidence is heavily against the picture's authenticity, further analysis is necessary before closing the book on the "Orrville Photo."

THE REGISTER, Storm Lake, Iowa, on August 21, 1962, reports the following experience of a motorist with a small disc.

While returning from Cherokee, Gus Goetsch reported that his car was struck by what appeared to be a flying saucer.

According to the report, Mr. Goetsch was on a gravel road south of Aurelia when he noticed this object about the size of a paper plate spinning along outside his car. He said it had what appeared to be sparks dropping from it.

Goetsch reported that the object struck the rear fender of his car and disappeared. It left no mark on the car and he was traveling about 30 miles per hour when the incident took place." Unquote. (Credit: Wash. State NICAP Sub-Committee, Seattle, Washington).

"La Manana," published in Formosa, Argentina, gave the following account dated August 21st: "A medical doctor named [redacted] was driving to the city of Parana with his wife, when he saw an object with all the characteristics of a flying saucer. It was surrounded by the classic luminous halo which has been described by many people previously. Up until that point, there was no difference between Dr. [redacted]'s experience and other similar ones in our country and around the world. But, to his surprise and amazement, he saw, at that same moment, two strange persons walking along the road. They were over six feet tall, with light hair and huge eyes. They carried luminous objects on their foreheads, and with these they made signals for the car to halt. Dr. [redacted] did not want to stop, as he was convinced that he was looking at extra-terrestrial beings; so he 'floored it,' instead." - The article goes on to say that his wife had a nervous attack as a result of the incident, and had not yet recovered.

APRIL 1962

Light Over Baltimore

On the first of August, 1962, Mr. and Mrs. Finck of North Point Road, Dundalk-Essex section of Baltimore county, also Mrs. Harper and son of Old North Point Road observed an amber light which appeared larger than the disc of Venus, in the eastern sky. Flashes were emitted at intervals of every two minutes, lasting for a few seconds, and proceeded by a soft, crumbling sound. Object visible from 9:15 p.m. until 9:55 EDT, when it disappeared below eastern horizon. Seen again at 10:20 p.m., a bit ESE of its original position by the Harpers and Fincks and one other anonymous couple who also noticed two small planes in the vicinity.

A short time later, a report from the towson area stated that a large, bright object was seen to move from the north to south, then reversed direction, going north, and eventually proceeding west until out of sight.

ENGLAND: The Buxton Advertiser on 8-24-62- reported the following incident: A 20 year old Chesterfield trainee teacher, Michael Vallance, stopped his car when he noticed an object in the sky." He described the object as " box-shaped with rounded corners." It had 3 or 4 lighted windows, and the whole object was surrounded by a glowing light. He estimated its height at between 200 & 300 feet. No noise. Another person saw a cigar shaped object in June, moving slowly and noiselessly over this same town.

UFO Over Milwaukee, Wis.

At 1:45 a.m., CST, on August 3, 1962, Mr. and Mrs. Herb Thrune of Milwaukee, Wis., observed the passage of a huge light from south to north above their home. The couple said it appeared to revolve to the right, going faster than any airplane with which they were familiar. As it approached overhead position, a "huge sunflower-shaped light" blinked on and off. Mr. Thrune went out on the lawn between his house and the one next to him and watched as it sped due north over the Miller Brownig Co. He said the incident happened so fast that it was difficult to determine the altitude. He felt the object was cigar-shaped, and it did not arc, but adhered to a flat, straight course at a very high rate of speed. The color was golden or orange, and there was no sound or contrail of any kind. Thrune is conversant with the types of planes usually in the area, and cannot identify the strange luminous body as anything conventional. Mitchell AFB is 8 to 10 miles south of the Thrune home.

MILWAUKEE, WIS.

18. ...On August 6th, a "mother ship"

6 August 1962
Buenos Aires, Argentina

At 1:45 a.m. on the morning of August 6th, a truck driver named [REDACTED] was traveling at high speed along the highway between Las Inmas and Piran, in the province of Buenos Aires, Argentina. Suddenly his motor went dead, and he got out and opened the hood in an effort to find the trouble. With equal suddenness the motor started up again, and it was then that he looked around and saw a luminous cigar-shaped object only 300 yards away from him. It had orange, green and purple lights, and was a frightening spectacle to Senor [REDACTED], who was alone on this desolate and lonely stretch of highway. Finally, without a sound, the huge object rose at high speed toward the west, and disappeared over the horizon.

UFO Over Titan Site

On or about the 7th of August, 1962, a brilliantly glowing object descended over a Titan missile site near Tucson, Arizona, in the vicinity of Oracle. Because of fear of reprisal the witness first contacted was not willing to give his name for publication and because of this AFRO was in doubt as to the authenticity of the sighting. However, within five weeks after the initial report, two other reports returned us which indicated that indeed something strange had happened at the site on or about the 7th. The first report was that at about midnight on the 7th, one of the night crew while outside the complex spotted the brilliant light overhead which began to appear larger and larger. He realized the object was ascending directly over the site, went inside and notified another man who came out and watched with him. Shortly, the object appeared to be coming so close that the men were somewhat frightened and they took refuge. Davis-Monthan AFB had been notified, and two jets streaked in from the direction of Tucson. As the jets approached, the objects took off fast and was out of sight in seconds. The jets circled the area, then headed for Tucson. Minutes later the "visitor" was back again. Witnesses said the bottom of the object was similar to the color of the moon in the night sky. Shortly after the second ascension over the Silo, the object ascended vertically and moved off at high speed, disappearing in seconds.

Another witness' testimony indicated that the object or a similar one was seen either the night before or the night after the above-described sighting with similar maneuvers taking place.
