10. BRIEF SUMMARY OF SIGHTING Reddish colored object observed several degrees above the horizon in the west. First impression was that object was Mars. A few minutes later the object moved higher in the sky and became bigger reaching about 1/4 apparent size of moon. Object passed over car. Mother of boy reporting argued that obj was delta wing a/c. However, obj moved very slowly, no sound, appeared as two delta wings w/no fuselage. Low Altitude.		11. COMMENTS Duration not reported. Dear Sirs:

I would like to report a sighting of an unidentified flying object. I first noticed this object at 6:05 P.M. Wednesday, February 13th. It was several degrees above the horizon and appeared a reddish color. At first I thought it was Mars but later (a few minutes later) I noticed it had moved higher in the sky. The object then appeared to become bigger, that is, its light did. It grew to a giant size, almost about a quarter of the moon's size. Then it got dimmer and seemed to stop in the sky.

My mother was coming to pick me up at Old Yoke Road Temple Beth Am after Hebrew school. I called her attention to the object which by this time had become brighter and had started moving over the synagogue grounds. We both watched the object pass over the car.

We both agree that the object was a delta wing craft and was moving slowly. My mother was in the car ~~and~~ looking out of the window while I was outside observing it. It appeared to me to have little or no fuselage, but was rather just two delta wings.

The object started in the West and proceeded Eastward until it had passed overhead. Its light then appeared to become too faint to see. We hadn't heard a sound from the craft. It was at a low altitude however.

I called an officer at Willow Grove Air Base and asked if they had any delta wing ~~or~~ planes at the base. He said they had no such plane there that could fly as slow as described.


