10. BRIEF SUMMARY OF SIGHTING Elongated object like an electric light observed for over 2 hrs. Moving from E to NE in steady climb. Looked a little like ECHO except that ECHO moved many times faster. Reported object to Naval Observatory, who told witness to report same to Air Force. Also observed on the 21st, 25th and 26th at same time same place.		11. COMMENTS On 22 July Jupiter was a 1 hr 11 min 55 sec on the Ecliptic. This places it in the East at about the time. It would start to appear at an elevation of 10 deg above the horizon. 2½ hrs later it would climb to about 45 deg elevation. Reported motion of the object was NE, however, the planet is moving to the SE. In same place and in the same time the object reported is characteristic of an ASTRO body. Since Jupiter is in the initial location it is believed that the reported direction is in error and the sighting is evaluated as JUPITER.

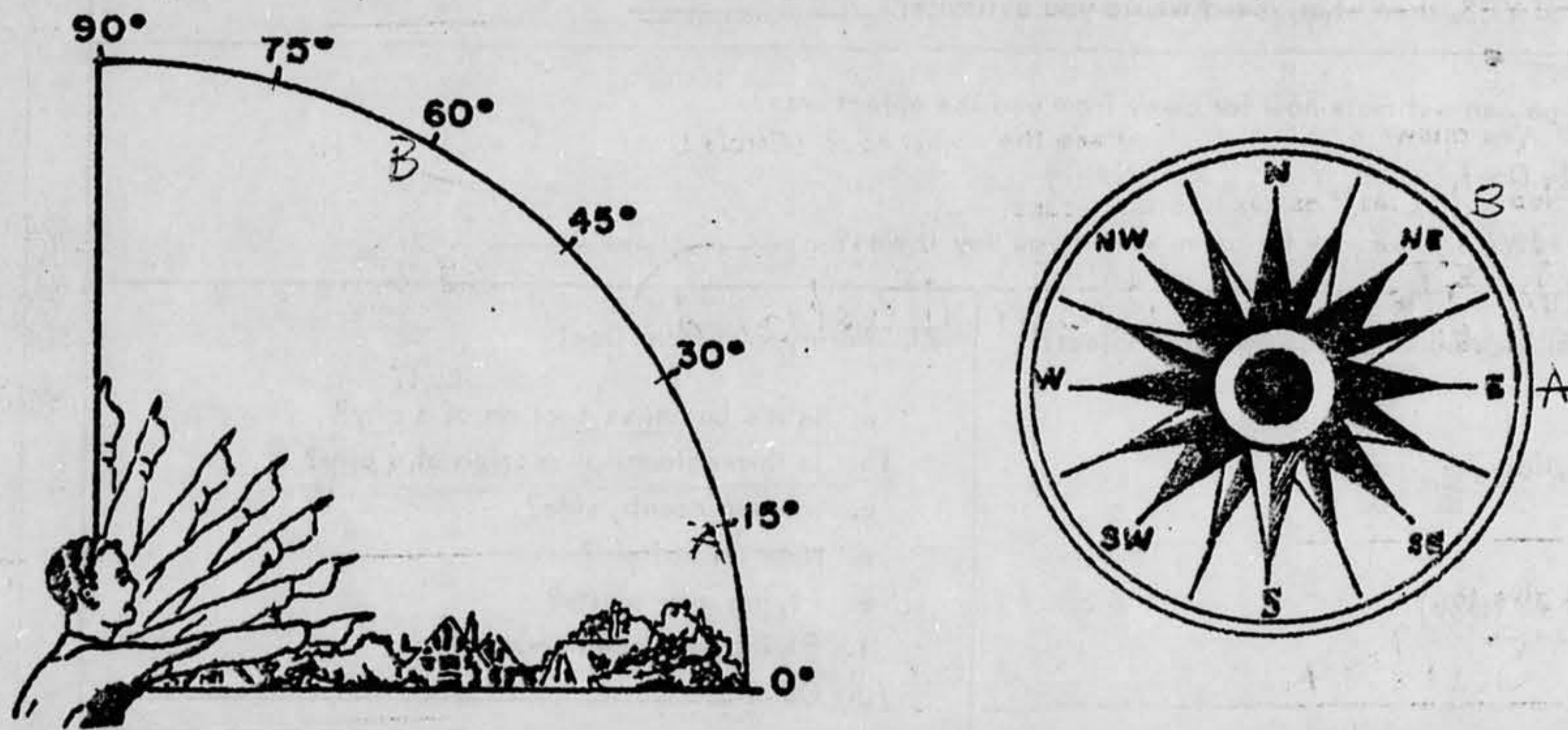

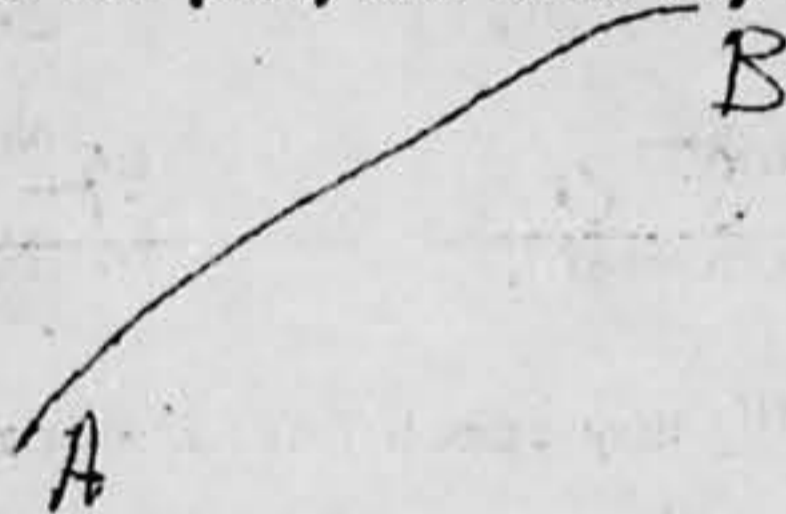
