COMMENTS Star Antares was in the SW at about 20 deg elevation and was the only Astro body of the 1st magnitude in that portion of the sky at the time. WX included haze and the object had the appearance of a star. Motion attributed to atmospheric conditions present. Case evaluated as observation of the Star Antares. (Mag 1.2)

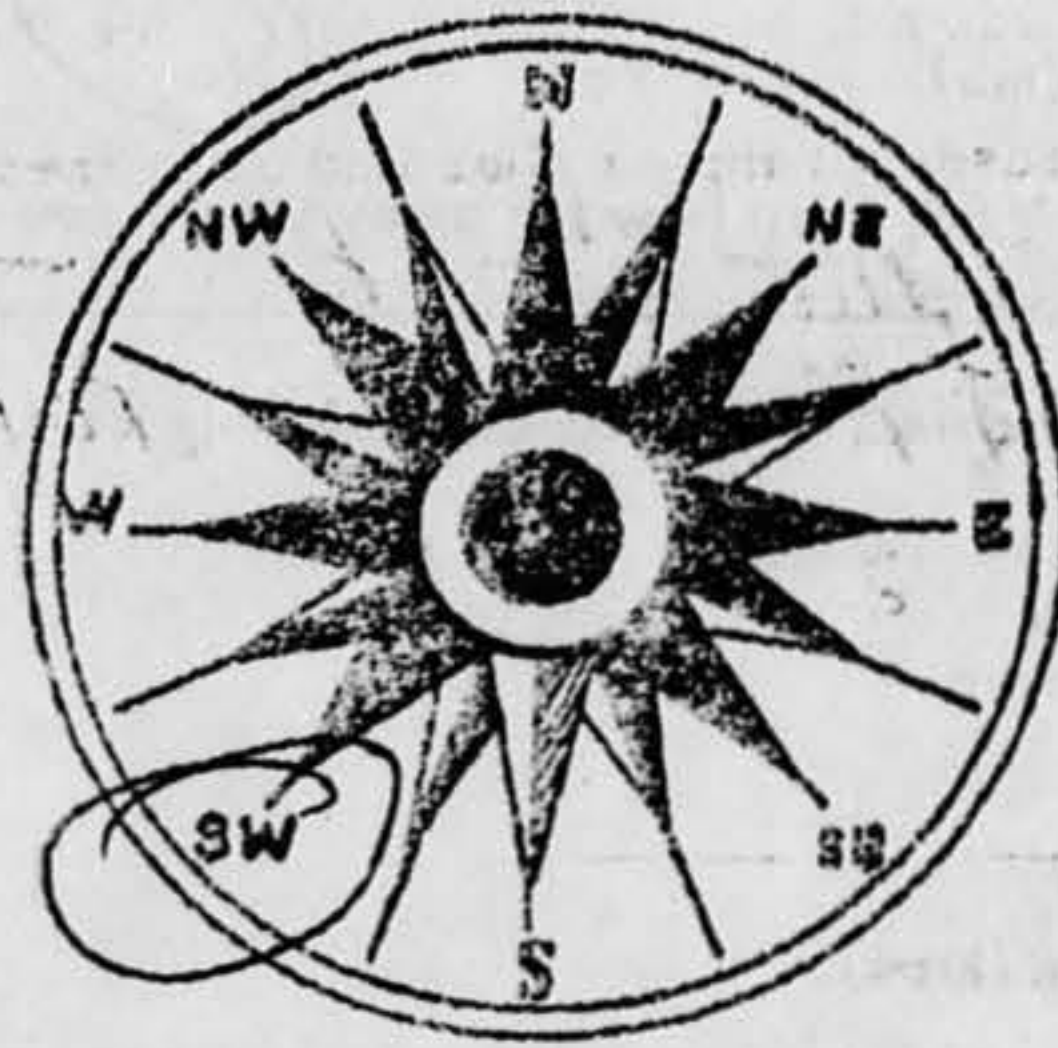
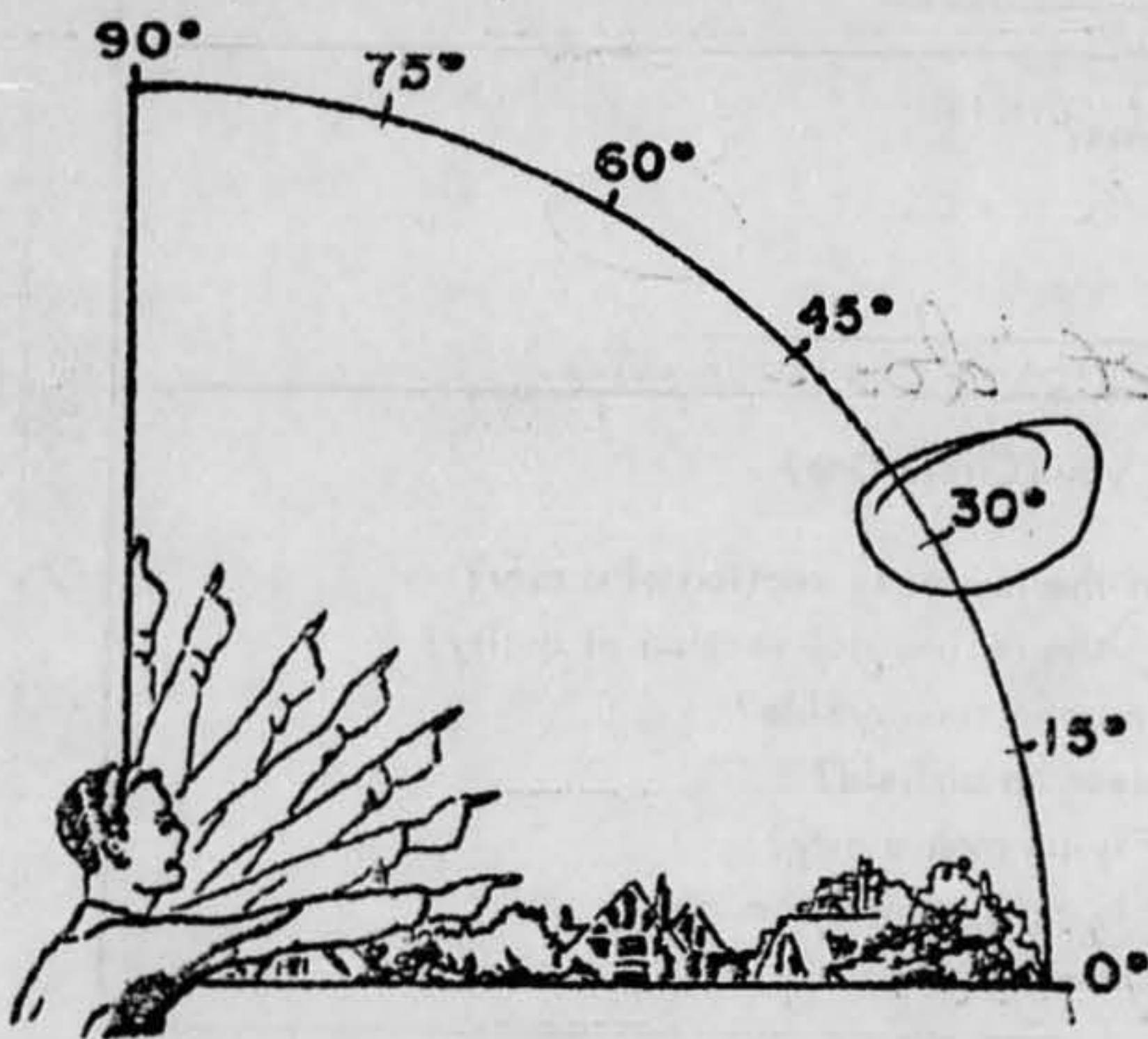
