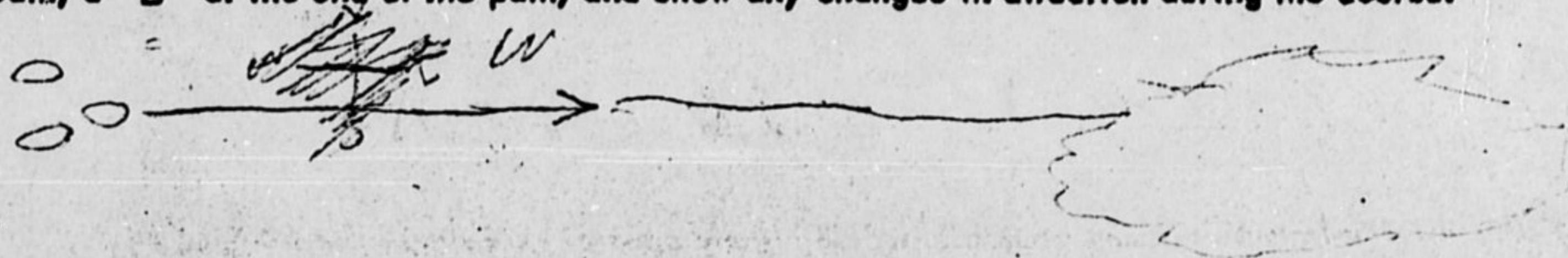


DEAR SIRS,

WAY, THE CIGAR SHIP INTERCEPTED THE RED LIGHTS.

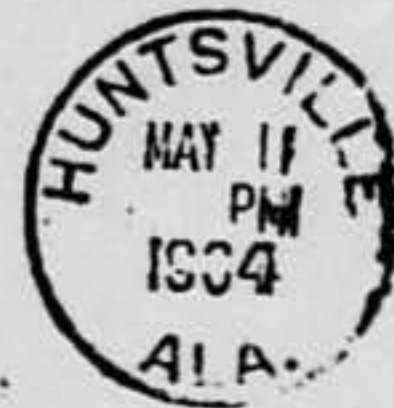
THE WHOLE THING TOOK PLACE IN THE COURSE

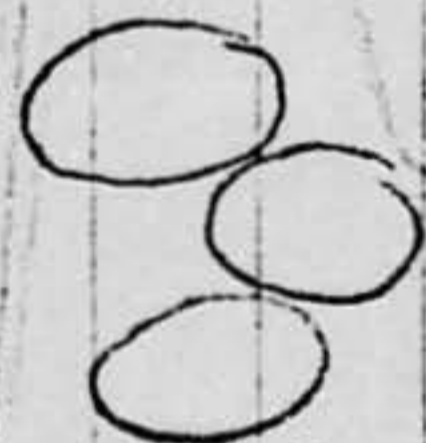

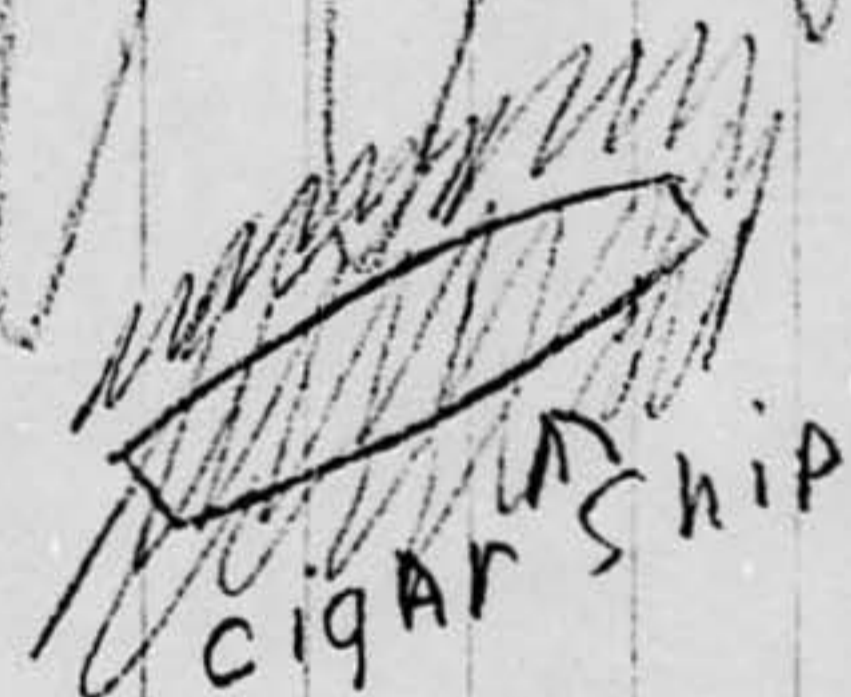


