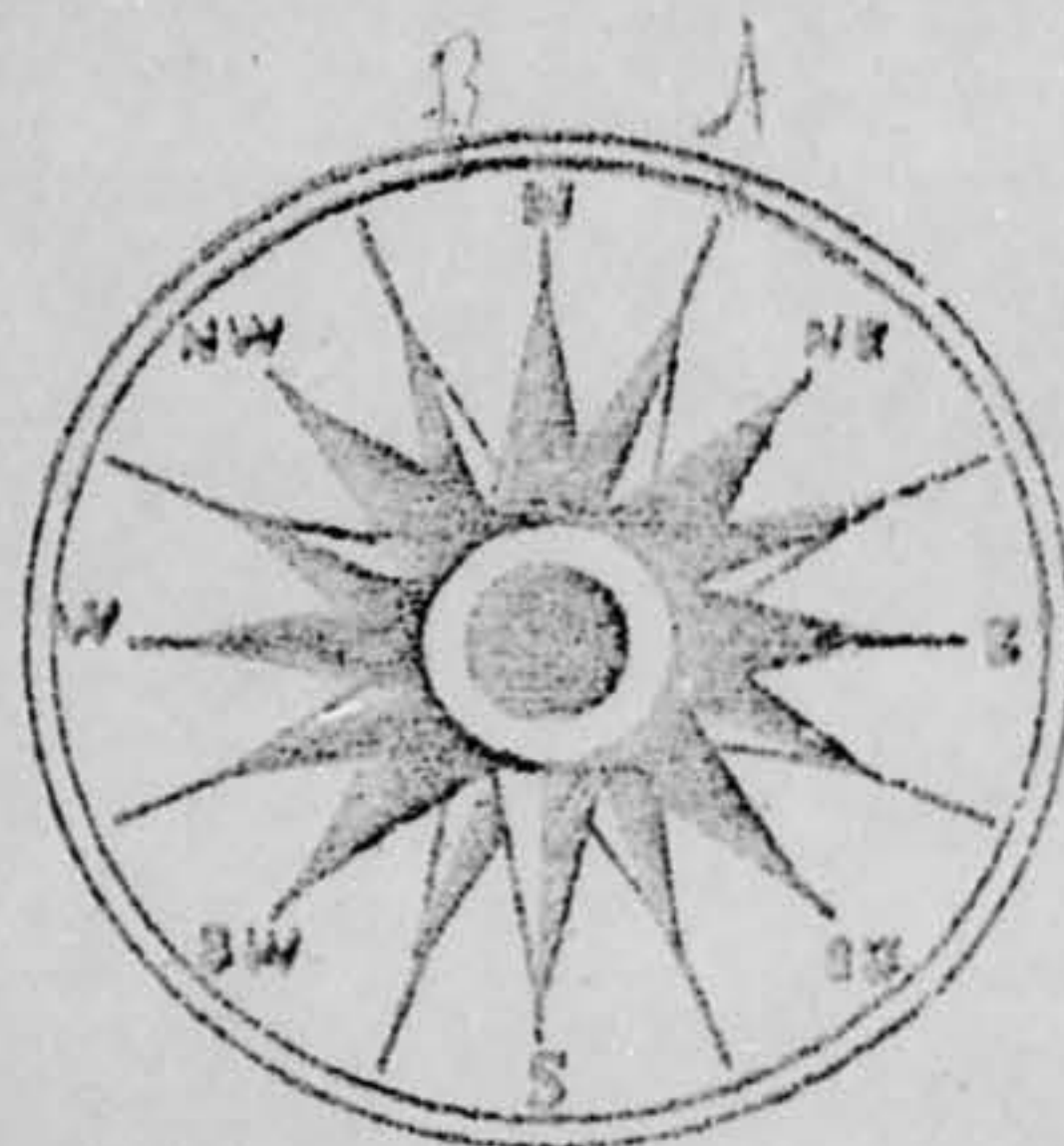
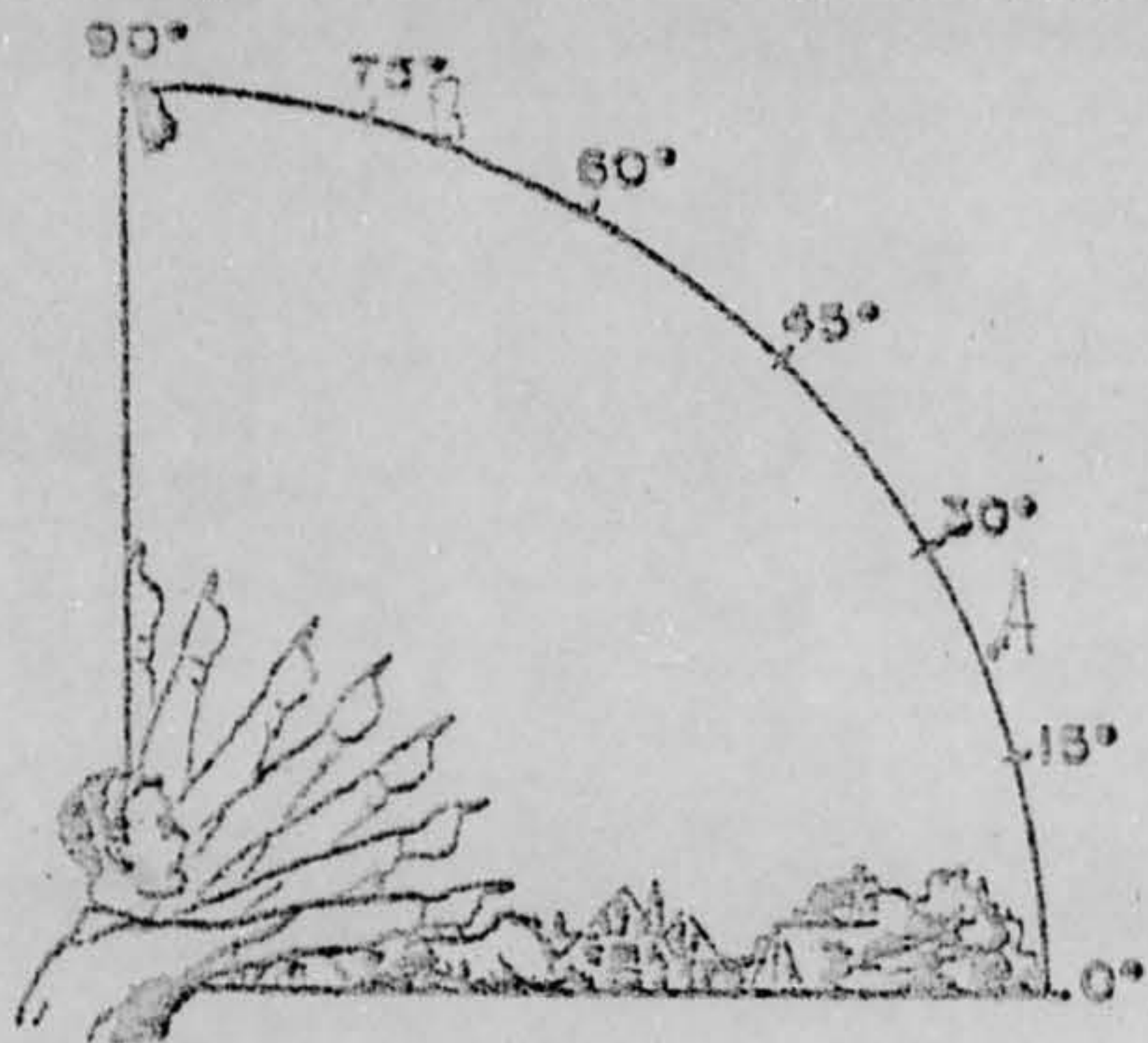

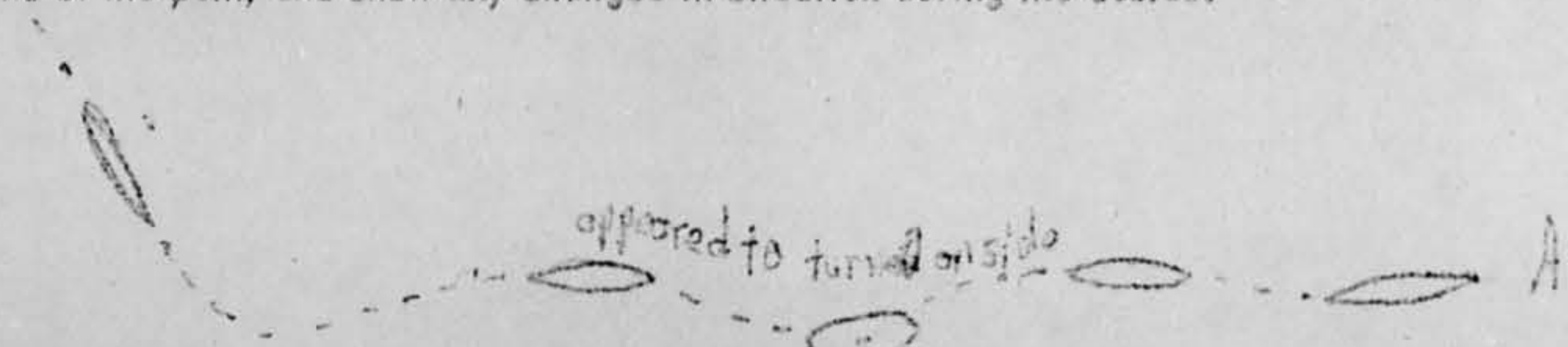

Dear Sirs:

On July 20, 1968, at 12:43 pm, while riding my bike in West Fairview, Pa. (across the river from Harrisburg) I saw a round, silver object (like a plate or disk) traveling north of Harrisburg. It was traveling slowly at first, then it made some violent turns and maneuvers as if it were in trouble. Just as it started to lose altitude, it picked up speed, and at an unbelievable speed it headed almost straight up and was out of sight in a few seconds. The object was too fast for a balloon, was too fast and made too many sharp turns and violent movements for an airplane. And I wasn't seeing things. The object was too far away, so all I could tell you was that it was disk shaped. But it was too close to be recognized as an airplane or balloon. The object was traveling N.E. to S.W. I watched it for about 2 to 3 minutes, then it was gone. I do not want this sighting to be publicised, I have not told anyone, I did not make it up because I'm interested in UFO's, or

because I'm only 12 years old. It was
a clear day with only about 8 small clouds. What
did I see?
