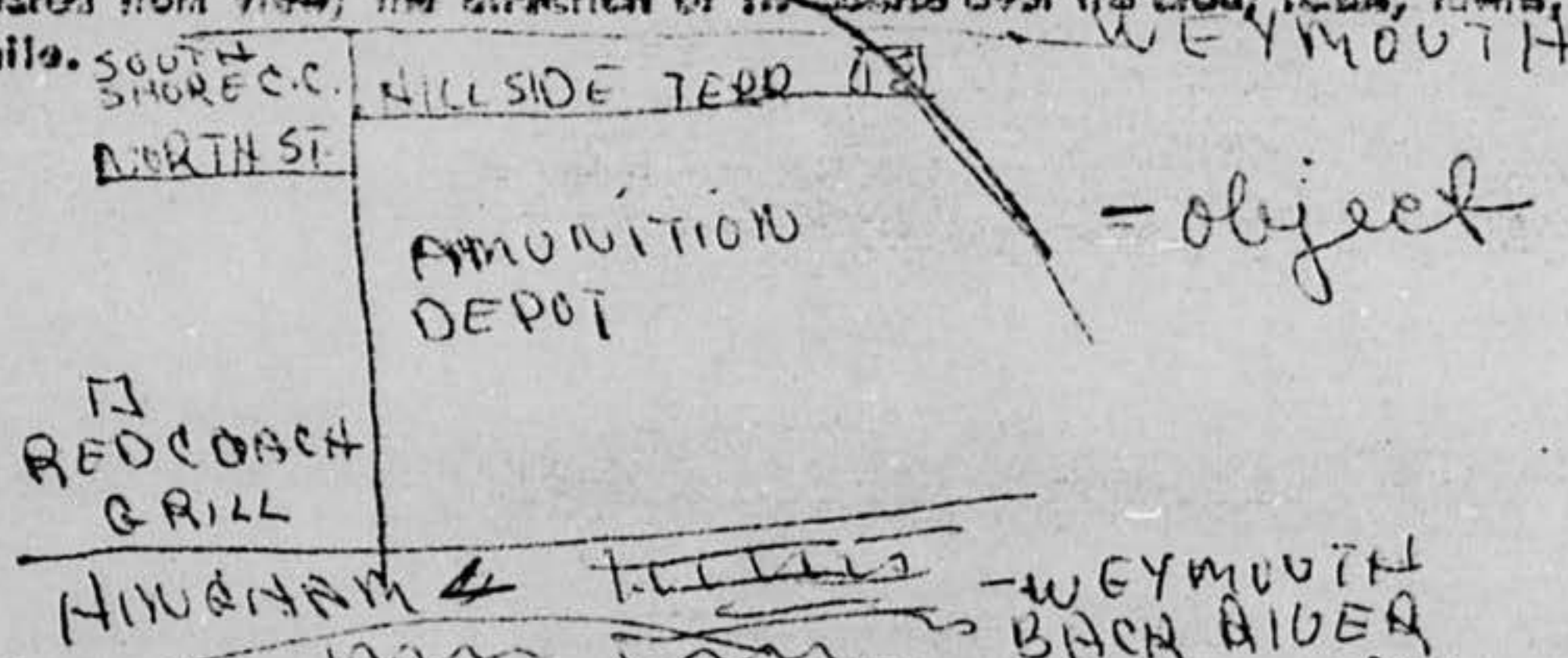

From the *Johannesburg Star* of July 22, we learn that Mrs. E. M. French of Greytown saw an object in the sky while driving home on the evening of July 21. At home, she watched it with her husband and Mr. R. Turner of Hillcrest. The report continues—
"It appeared reddish in colour but seemed to change to green. It moved down and up and then from side to side and at one stage two blue lights appeared to approach it and later moved away.

"Mrs. French said it had four spikes or legs below it.

"Mr. Maurice de St. Pern, a former Mayor of Greytown, also spotted the object from a window while attending a Chamber of Commerce meeting. He saw it performing similar antics."

Columbia River Basin, Washington

On the 21st and 22nd, sightings were made in the Columbia River Basin in Washington. Franklin County Undersheriff Erwin Hood interviewed 10 people who claim they saw orange-glowing objects flying at low altitude north of Ringold. The objects had been seen on Wednesday and Thursday of the two preceding weeks. Hood said all the reports were similar, describing orange, glowing fast-moving lights—from 3 to 20 in a group. Some observers said they saw mountains to the west behind the objects, so the objects could not have been planets or satellites. The Othello Radar Base commander said nothing had been picked up on radar. It might be pointed out that in hilly or mountainous country, radar will not pick up low-flying objects.

SIMULTANEOUS RADAR AND VISUAL SIGHTING IN BRAZIL: A report from San Pablo, Brazil, dated July 22nd, tells of an important sighting by a radar team at the local airport, where a UFO was tracked at an altitude of 1,200 yards. It was on the scope for ten minutes, and was traveling at about 60 miles per hour in an irregular course. At the same time, a resident of a house near the airport made a visual sighting of an orange-colored object which passed at low altitude over his home. The airport authorities ordered a civilian plane to fly over the area where the UFO had passed, but the airplane crew saw nothing.

FLYING SAUCER LANDING IN PERU: A wire service story dated July 24th tells us of a UFO landing on a ranch 30 miles from Lima, Peru, witnessed by a chemist and his wife. They said the machine stayed on the ground for about 45 minutes and then zoomed off, leaving singed plants and

overturned rocks in the area where it had landed. Several farmers in the area supported the couple's story.

Other reports from nearby Chile and Uruguay are referred to in the article, but not described. Meanwhile, a group of men in Peru described as "scientists" have issued a report stating that flying saucers do exist, and are piloted by beings 3½ feet tall who are generally similar to us in physical characteristics. These "scientists," headed by a man named Gustavo Villar Dongo, are members of a group called the Peruvian Institute of Interplanetary Relations; and although we agree that their conclusion is basically correct, we must caution our readers that it sounds to us like a saucer research group rather than a scientific organization.

Several other less sensational UFO sightings were made in and around Lima during the week preceding July 24th. It is obvious that a flap of unusual proportions has been taking place in Peru, as well as in other South American countries.

Caracas, Venezuela, July 25th. Mr. Ismael Ramos Martinez reported that on this date, at 8 p. m. he saw a disc-shaped, silvery object from the window of his home at Guaicaipuro. He called his mother and sister who also saw the object as it crossed the sky in an east-west direction. The object did not speed, taking 6 or 7 minutes to cross the sky. It seemed to fly in a straight line, swerving to the southwest just before it veered sharply upward. Mr. Martinez watched the sky until 10:15 when he saw a fast-moving brilliant point of white light which flew from northwest to southeast. He called his mother and sister and they watched the light as it flew rapidly in an ellipse trajectory, then disappeared upwards.

Dear Sirs,

I am writing to inform you of a strange U.F.O. sighting a friend and I made in the summer of 1965. I would have written sooner, but I didn't know the address, or if just anyone could write you.

It was July 20th 1965. My family and I had just returned from a Sunday outing. It was then around 5 o'clock. It was very warm, so I decided to go swimming at The Sunshine House's pool, a nearby tourist house. The owner, Fred Bell lets the kids around town use the pool for a quarter. There were around 10 people in the pool when I arrived. Most were people boarding at the house, but I knew some. My girlfriend ~~_____~~ was there. Also there were around 14 people playing miniature golf at the time. We swam for an hour and then got out

for a while. My 3 dogs, Tippy,
Princess and King were laying
under the ping-pong table. By
the time we went back to the
pool everyone had left except for
Nancy, my 9 year old sister Cathy (7
at the time) and my little cousin
~~the~~. The 14 people were
still playing golf. Since Nancy and
I are fairly good swimmers we were
at the deep end, and the 2 little ones
were in the shallow end, practicing
underwater swimming. ~~My~~ and
I decided to have a contest to see
who could cross the pool and back
underwater without coming up for
air. ~~My~~ did it, then it was my
turn. I was over to the opposite side,
and on my way back when I heard
~~Go~~ calling me. I came up and shook
the water out of my eyes. "What's the
matter?" I asked.

"Look, look at that bright light in
the sky!"

I turned and saw it. It was
then around 11 p.m. My first
impression was that it was a star.

"It's the first star!" I said, half-believing that is what it was.

"No it's not, it's moving and besides it's too big"

"I know she was right. "An airplane maybe?"

"I don't know," she said.

We stood in silence our eyes fixed on the glowing object. It zig-zagged in a decline towards the earth. It gave me an eerie feeling to watch its jerky moves. No plane could do that. It still had not struck me that we could be watching an interplanetary ship.

Suddenly it stopped, maybe a hundred feet above two leafless trees. For about 5 seconds it hovered, spinning. Then in an amazing burst of speed it went spinning straight up and disappeared. For several seconds back of us stood not fully believing the sight we had seen. It had not occurred to either of us to call to the other 2 girls. It was them, asking us what was wrong that made us regain our senses.

Still staring at the black, moon clear
sky I asked "What was that?"

"I don't know."

It suddenly struck both of us.

"A flying saucer!"

We practically flew out of the post.

My mother was just pulling in to
pick us up. Now panicky we both
screamed "Flying saucer!" The people
on the porch, all elderly, laughed at
us. Worst of all even my mother
didn't believe us. "Oh sure. You
saw about 10 of them." she scoffed.

Right then and there we were decided
not to tell a soul. Our dogs followed
us to the car, (they had not shown any
signs of nervousness, nor had the several
animals including a pig, a horse, ducks,
a donkey and dogs that the Rasmussens
who live next to the post own.

But that night, lying in bed, memories
of the strange vessel haunted me. There
was now no doubt in my mind
that what we saw was no earth-like
machine. Nothing that I knew of could
go through the strange motions this
craft had. Especially its weird departure.

At 11:30 P.M. I went down stairs to talk it over with my parents. To my surprise they had heard on the late news a saucer had been sighted in a neighboring state.

In detail I described it to my mother and father, including its peculiar motions.

The next day we went to Nancy's house. (My mother and her mother are good friends. Nancy had described it in the same way to her mother. Without me saying a word she described it again to my mother. It was identical to my story.

We told Mr. [redacted] about it, as we know how interested he is in U.F.O.s. He works for the Record, our Newspaper, and [redacted], a reporter called and got our story. The next day it was in the newspaper.

The day Mr. [redacted] called at around 6:30 [redacted] I went to see Mr. [redacted] around 10 o'clock in the morning. We found him in the refreshment building (a little tiny place next to the golf course) keeping

scare for I children playing golf. We asked him if anyone had noticed anything strange the evening before. He said "Yeah. This lady from up Highview Mountain came down and asked if I had a balloon flying up over these trees by the pool. She said she'd been driving along main street when she saw this object, hovering over some trees."

We then told him about our sighting. He got quite excited. And the following day reported that another person questioned him about an object over the pool.

Now after the piece appeared in the paper Stewart Air Force Base officials came to question us. They reviewed our report on tape recorders. They had us draw pictures of what we had seen. They took us over by the pool and had us point out the location of our sighted object. After we were finished they warned us not to talk to anyone about this interview or ^{to} anyone we don't know about what we had seen.

When we left they were using Geiger counters to try and pick up radiation

Whether they were successful or not, I couldn't say.

Several days later, miserable days filled with being laughed at, jeered at, and strange phone calls that had me worried. The phone would ring. I'd pick it up or some member of my family. No one would answer, but we could hear breathing. Then it would click in our ear ~~and~~ and I, wishing the whole incident had been just a dream, were swimming in the pool again.

Mrs. called us and said Don wanted to speak to me. I was a little hesitant in answering questions. He noticed this and asked me if the men from the air base had told me not to discuss it. I admitted they had. After a few more questions he hung up saying he planned to call the Base.

The next day another piece appeared in the paper, and from it we learned that 1. True to his word had contacted the base.

2. The nearest air port, about 3 to

8 miles away in Wurtsboro had been contacted. When there reported they had a few shiny planes but certainly none that were disc shaped. ~~And~~ as an expert, Ronald Velton of Astorville, believed we had seen an un-earthlike object.

4. A man at the airport had outlined the complete take-off pattern at the airfield. An officer said what we seen was probably not from the air base.

5. Some S.A.F.B. officials had declined comment.

6. NASA had been tried to reach but had not been able to, for comment.

What we saw, I don't know, but I am certain beyond a shadow of a doubt that what we seen was not an airplane. And all the officials in the world could not convince me I had. (None true. Most believed it was a U.F.O.) And it was no star. Planes and stars don't zig-zag towards earth, spin and go straight up very fast and disappear within seconds. Of that I am certain.

From the *West Australian*, Perth, of August 14, we learn how Mr. A. Kukla and Mrs. A. Lawrence of Nedlands were on a rock-hunting trip near Carnarvon when they were terrified by the attentions of a UFO. It was 7.40 p.m. on July 27, about 70 miles S.E. of Carnarvon when—
"From an angle of about 40 degrees a green object seemed to dive straight towards the vehicle. It changed to an orange colour and then to bright red.

Mr. Kukla switched off the lights and engine and he and Mrs. Lawrence got out. When the lights went off the object seemed to change course and hover in mid-air. It stayed in that position for almost half an hour.

"Mr. Kukla watched it through binoculars. The object did two slow circles round them and went away to the west. He said the object appeared to be shaped like a squashed football or a magnifying glass viewed from the side. It did not change in shape or colour while it hovered near the vehicle."

AIR FORCE INVESTIGATION RESULTS

According to information received from Project Blue Book Headquarters, at Wright-Patterson many of the UFO sightings published in the September issue of the IIR, under "The Invasion Begins" has been explained.

The Wynnewood, Oklahoma sighting on July 31st (This issue page 10) has been identified as the star Capella. The radar returns that Carswell AFB picked up were only microwaved radar returns that were picked up at Tinker AFB. Ft. Worth reported that no unusual returns were picked up by them. The radar returns that were picked up by Tinker AFB were identified as a balloon that was launched from Will Rogers World Airport located in Oklahoma City. All other returns from the Oklahoma area appeared as stationary returns. The radar returns from the 746th AC&W Sq. near Oklahoma City was estimated at 10,000 ft. elevation, range 20 miles to the South. The object was tracked to a range of 29 miles at an azimuth of 205 degrees.

"The majority of the visual reports were to the East and to the Northeast of Oklahoma City." "Our" as stated by Major Quintanilla, release on the cause of the initial reports stands as correct." (Published in the September issue of the IIR page 19). "This evaluation was of multiple sightings from the Cheyenne, Wyoming, Colorado and Nebraska area on the night of the 31st of July. These sightings were made between 2 a.m. and dawn and consisted of 75 reports by military and civilian personnel. At the time of the Air Force release we had no knowledge of reports from the Oklahoma area." (HOUFO Director notified by telephone Wright-Patterson AFB on the morning of August 2nd of the recent sightings. But a full report was delayed for several days. As soon as the Air Force investigation results

were released Hayden Hewes again notified Wright-Patterson AFB, to the effect that most of the people in Oklahoma weren't going for the Air Force explanation. At which time he was told that this did not apply to Oklahoma. That the Oklahoma sightings were just coming in.) "Whoever made the mistake assumed that this release covered all sightings throughout the midwest. The Air Force made a mistake in not specifically stating that the reports were from Wyoming, Nebraska and Colorado."

"SAUCERS" FLYING AND LANDING NEAR MOUNT AIRY, NORTH CAROLINA

In the heels of recent sightings of "Unidentified Flying Objects" statewide, nationwide and worldwide in recent months have come reports of sightings and landings of "Flying saucers" near Mount Airy, North Carolina. The investigations lasted a total of nine hours.

And on hand during his vacations from Boston, Pa. was a Mount Airy native, Mr. George D. Fawcett, a Professional Y.M.C.A. Secretary in Pennsylvania and also a serious civilian UFO investigator and researcher for over the past 18 years.

Both of the sightings Fawcett investigated, occurred on the outskirts of Mount Airy, in the early morning, under perfect weather conditions and with similar cigar-shaped unknown flying objects. Other UFOs had been observed in these same two areas in recent months also.

The first sighting was reported by salesman, Mr. John W. Parries, 40, of F. Ross Co. and a resident of 215 E. Lebanon Street in Mount Airy. Parries encounter came on July 31, when he reported he watched a reddish-orange cigar-shaped object hovering above a smokestack for 2 1/2 minutes at the Flat Rock section of the Mount Airy Granite Quarry. He watched the object, which seemed to be hovering around 150 to 200 feet above a 60 foot chimney at the quarry through one of his house windows. The mystery object, which was fat in the middle and tapered at both ends like a "football" was estimated to be hovering about 2 miles away from his home at around 250 feet above the quarry at 4:15 a.m. under clear skies with stars shining. When the "saucer" finally moved it went like it was climbing a series of steps up vertically and then disappeared in the distant eastern sky.

The landing report occurred early on Thursday morning, August 13 at 3:00 a.m. and was reported by housewife, Mrs. T.E. Schumaker, who was visiting her mother, Mrs. W.H. Blackburn on the Pipers Gap Road area near Mount Airy. Mrs. Schumaker, 48, on vacations from 1314 21st Street S., Arlington 2, Virginia. The Pipers Gap Road runs from Mount Airy to Iredell and the landing incident occurred about 5 miles North of Mount Airy beyond Teast, N.C. The landing area had a radiation count, but it did not show an above normal background radiation count. It was checked by Geiger Counter by Captain Jim Laffon of the Mount Airy Emergency Squad and by Fawcett. However this check came eleven days after the incident and heavy rains recently may have erased such evidence.

Mrs. Schumaker, whose husband Tom is an accountant in Washington, D.C., was awakened suddenly by a sharp noise in the backyard of the Blackburn home. It terrified her so badly that

For a moment she was unable to walk or talk as she tried in vain to wake up Mrs. Blackburn in another room in the house. The object was humming and hissing like a large child's top and had a steady burning sound. Mrs. Schumaker said she could feel the vibrations of the air currents against the side and top of the house.

As she lifted the shade of the window up she was just in time to see a cigar-shaped object having a revolving yellow light disc above the front yard telephone pole and wires to the left of the house and towards the Piper Sap Road to the North. The strange flying object during its maneuvers, moved to the right and to the left and up and down from the South behind the house to the North, then to the northwest and back again towards the West. At this point Mrs. Schumaker said she could distinctly hear the rustling of the oak tree leaves overhead and left of the house. Then she lost sight of the object behind the nearby trees.

She finally managed to get back to bed, but slept little ~~until~~ before dawn. Mrs. Blackburn told Ed Fawcett her daughter was almost scared to death and also that she told Mrs. Schumaker that the incident should be reported to authorities, but they decided not to.

The next morning Mrs. Blackburn, Mrs. Schumaker and other family members discovered a perfect 12 foot circular area surrounded by a six inch ring ^{around its circumference,} which was impressed on the ground about 35 feet behind the house and around 90 feet from the telephone pole and wires in the front yard.

In the inside of the circle the grass remained higher and was left untouched. Green oak tree leaves were scattered to the left of the house all over the ground and many of the trees in this area showed twisted leaves on their limbs, as if done by a revolving force of some kind (the spinning object).

The object evidently landed straight down for about 1/2 minutes and then took off towards the North, then the northwest and moved finally back to the West before disappearing in the distance behind the tall oak trees to the left of the house.

Fawcett after investigating both of these recent Hunt Army sightings stated that he felt, because of the evidence collected and because of the reliability of both of the eye-witnesses and similar descriptions that the encounters were bona fide UFO sightings.

Twenty nine such landings had already been reported worldwide in the past 16 months from scattered locations in France, Argentina, Peru, New Jersey, Canada, Australia, Florida, New Mexico, New York, Saskatchewan, Washington State, Virginia and elsewhere. And because of the fact that the famous "Roswell" did not sound convincing at all.

They See Flying Saucers —Or Something, by Jingo!

MOUNT AIRY — People around Mount Airy are seeing—and in one case hearing—strange things.

George D. Fawcett, a Mount Airy native and self-acclaimed expert on unidentified flying objects, believes these people are seeing space ships, or flying saucers.

The things they are reporting seeing and hearing, he said last week, are remarkably similar to things reported recently all over the country.

Fawcett, a YMCA secretary in Easton, Pa., has been vacationing in his home town. He found himself spending much of his vacation investigating flying saucer reports. He's been doing it for 19 years, since before his Army days.

He has 28 scrapbooks, 400 photographs and 5 filing cabinets full of stuff dealing with flying saucers.

Now he can add three new cases to his scrapbook:

Case No. 1

On Aug. 10, Mrs. T. E. Schumaker, 48, of Arlington, Va., was visiting her mother, Mrs. W. H. Blackburn on the Pipers Gap Road seven miles northwest of Mount Airy.

Mrs. Schumaker was sleeping on a couch in the front room with her mother. Her

husband and her 10-year-old son were sleeping in another room.

At about 3 a.m., Mrs. Schumaker said, she was awakened by a loud noise. In a telephone interview from her home in Arlington, here's what she said happened:

She heard more than she saw. She was confused and frightened when she awoke. She first thought she was hearing a car stuck behind the house, spinning its wheels.

When she was fully aroused, she realized that the noise was too loud to be a car. "It was humming like a top, except much louder. I was scared because it was so loud."

Then she suddenly remembered that there was no way for a car to get behind the house. Her mother lives alone, and she had barricaded the driveway.

"I could hear the whirring noise of air and the air currents hitting the house. I could hear the air in a pine tree near the window.

"I thought about what I should do. I rose and started to call my husband, but I couldn't speak. I couldn't move. I was frightened, but I don't think I was that frightened. I think it did something to me that prevented me from moving."

She was finally able to reach the window, and pull back a drawn shade.

The back of the house is to the south. The window she looked out is at the northwest corner.

At some distance, rising at an angle from south to north she saw a cigar-shaped object "the color of stars."

She said it appeared to be about a foot long in comparison with the stars, which look like points of light. She said she couldn't tell how big it really was because she didn't know how far away it was. It was standing on end, at a 90-degree angle with the earth.

Changed Movements

"It moved to the right, then to the left, then back, then up. Then it moved down and to the left and disappeared behind the trees along the driveway."

Mrs. Schumaker's mother slept through it all. When Mrs. Schumaker finally awakened her, the thing was gone. The mother and daughter lay in the darkness talking about it, afraid to turn on the light. They decided to wait until dawn to tell Mrs. Schumaker's husband and son.

Was she dreaming? "No, sir! I was as awake as I've ever been."

The next morning she told her husband about it. He laughed.

Grass Depressed

But he stopped laughing when they went into the yard.

In back of the house was a six-inch band of depressed grass. The band made a perfect circle, exactly 12 feet across.

Along the driveway, running north-south, the ground was strewn with fresh green leaves from a line of oak trees. The leaves on the trees were disheveled, their pale undersides turned up.

The Schumakers told one neighbor about it. "We were afraid to tell anybody else. They'd think I needed to be committed."

The story spread. Fawcett heard about it and investigated. He had Mrs. Schumaker fill out a questionnaire. He will send the information to two organizations: The National Investigations Committee on Aerial Phenomena, a civilian and military agency; and Project Bluebook, a military agency which investigates such reports.

Remnants of Circle

Last week, 12 days after Mrs. Schumaker's experience, the Journal investigated. The grass in the backyard had grown considerably, but remnants of the circle remained.

Fawcett, using a Geiger counter borrowed from the Mount Airy Rescue Squad, checked a sample of earth from the circle. The radioactivity was normal.

A footnote to case No. 1: The day before Mrs. Schumaker's experience, a man in Thomasville reported seeing a metallic object shaped like a cigar with purple lights. It was about 200 feet off the ground, he said, and made sounds like a sewing machine. He said the object was 75 to 100 feet long, 8 to 12 feet wide and about 10 feet high. After hovering about a minute, the object took off at terrific speed and was gone in 10 seconds.

Mrs. Schumaker estimated that a minute and a half elapsed from the time she awoke until the object she saw flew out of sight.

Case No. 2

John Parries of 215 E. Lebanon Street, a salesman for F. Rees Clothing Co. in Mount Airy, was in the upstairs bathroom at his house at about 4:15 a.m. July 31.

His house overlooks the Mt. Airy Granite Quarry. He looked out the window and, over the quarry, "I saw it hanging there like a bell."

It was bright orange and looked like a football or a fat cigar. It was smaller than the moon but three or four times larger than a star. It had some appendages on top, but he couldn't see them very clearly.

"I thought it was a big star until it moved. When it started moving, I watched it closely. I couldn't believe what I saw.

Goes Step-Like

"It didn't move straight up, but looked like it was going up steps." (He said it moved vertically, then horizontally, then vertically again, over and over.)

"I wanted to go get my wife and show her, but I was too fascinated by what I saw. It was very luminous. It looked to be about two and a half miles away."

When he finally got his wife to the window, it was disappearing upward.

At the store that morning, Parries told some friends about it.

"Yes, they laughed and ribbed me at first. But since then they've read about other people seeing these things, and they don't laugh as much anymore."

Case No. 3

Bobby Puckett, 14, of Mount Airy, Rt. 1, the Buck Shoals Road, has been reading about space and flying saucers for a long time. On many a night he has spent hours gazing at the sky.

Bobby kept telling his parents, Mr. and Mrs. Frank Abernathy, and his five brothers and sisters he was seeing strange things in the sky. They laughed at him until . . .

. . . Last Tuesday night Mrs. Abernathy was away from home until after dark. When she came home Bobby was sitting in the middle of the road, looking at the sky. He saw her and shouted, "Mom! Mom! I saw a flying saucer."

Mrs. Abernathy said she chuckled at him and started to go into the house. But he begged her to look. He pointed out something that looked like a star.

"It was moving toward Winston - Salem," said Mrs. Abernathy, "but suddenly it began to move to the right, toward the river. Then it circled another star, and they moved off in opposite directions."

Bobby ran into the house to get his 16-year-old sister, who was doing her homework: "Diane, Diane, come out. There's a flying saucer," he said.

For the next two hours, Mrs. Abernathy said, she, her six children and two neighbor children were awed by what was going on in the sky.

Mrs. Abernathy said the activity seemed to center around one big star that was red at first and then "tinted off into a bright amber color. It wasn't exactly round, more of an oval."

Parries

"Another Star"

"It was moving from Winston-Salem toward the river," she said. "Another star came from Hillsville, circled that star, and then they both went in opposite directions."

Diane said that at one time a star was moving across the sky when a jet plane passed. "All of a sudden the star plunged down, like it was trying to get out of the way. Then it stopped and moved across the sky again," she said.

"Shooting stars, perhaps?" "No," said Mrs. Abernathy. "Oh, we saw some shooting stars that night, like you'll see any night if you look long enough. But I'll guarantee those things moving around up there weren't shooting stars."

How about lights on airplanes? Diane doesn't think so, and here's why:

Late in the night, she said, about six stars came into view at the same time. The one that seemed to be the center of the group was bigger and brighter. "It had a sort of reddish color," she said, "then it would change from red to orange. Sometimes two of the other stars seemed to have long glowing tails. They stayed in view about two hours. They would move around in different directions, over and under

each other. They would separate, then they would come back together."

The next night, Wednesday, they watched again. But all they saw, said Mrs. Abernathy, was a single star, moving across the sky. It could have been an artificial satellite.

Only Bobby called the things they saw the night before "flying saucers."

Both Mrs. Abernathy and Diane kept calling them stars. But they have both marveled at what they saw. As Diane said:

"It gave me the weirdest feeling."

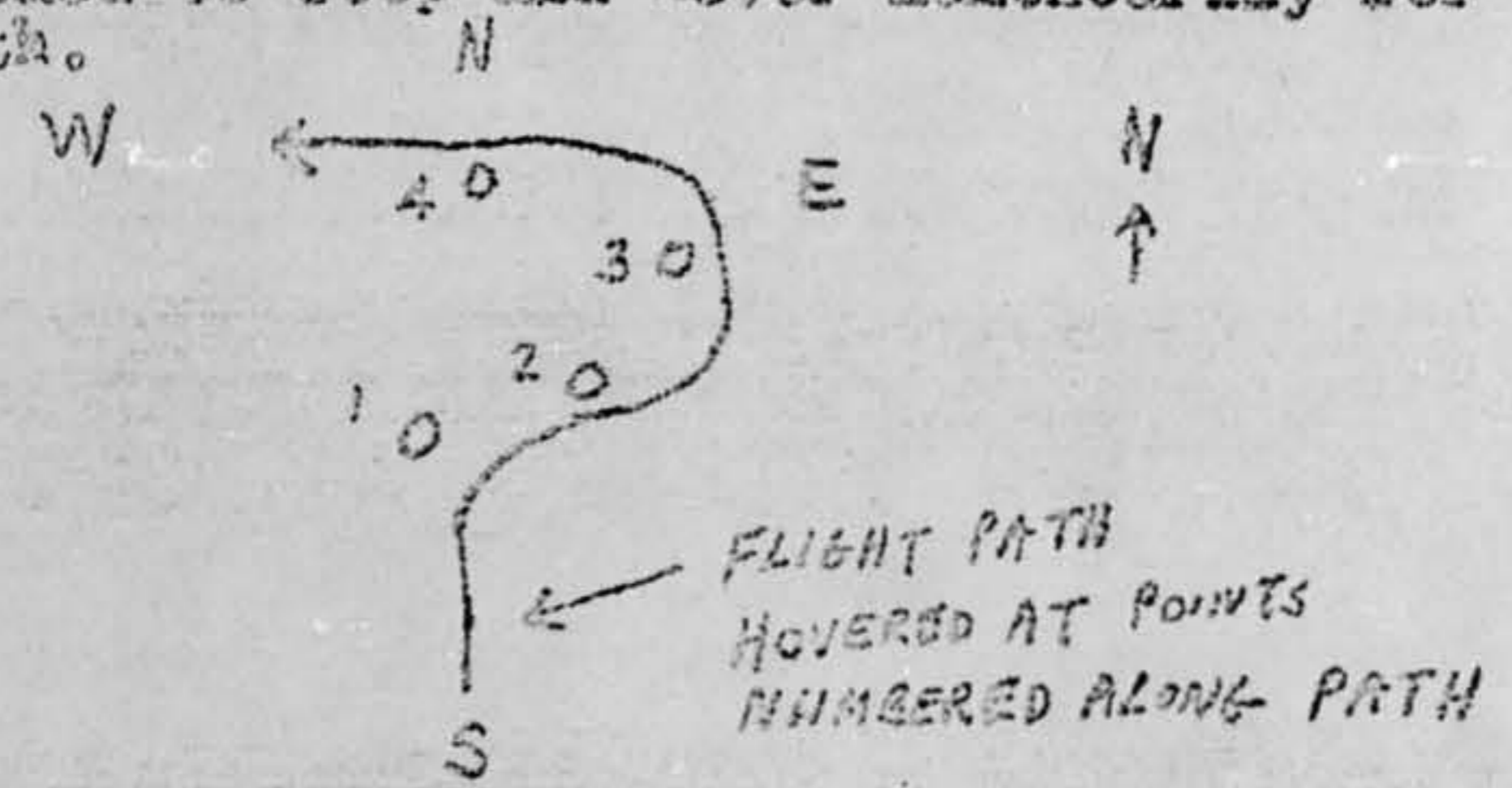
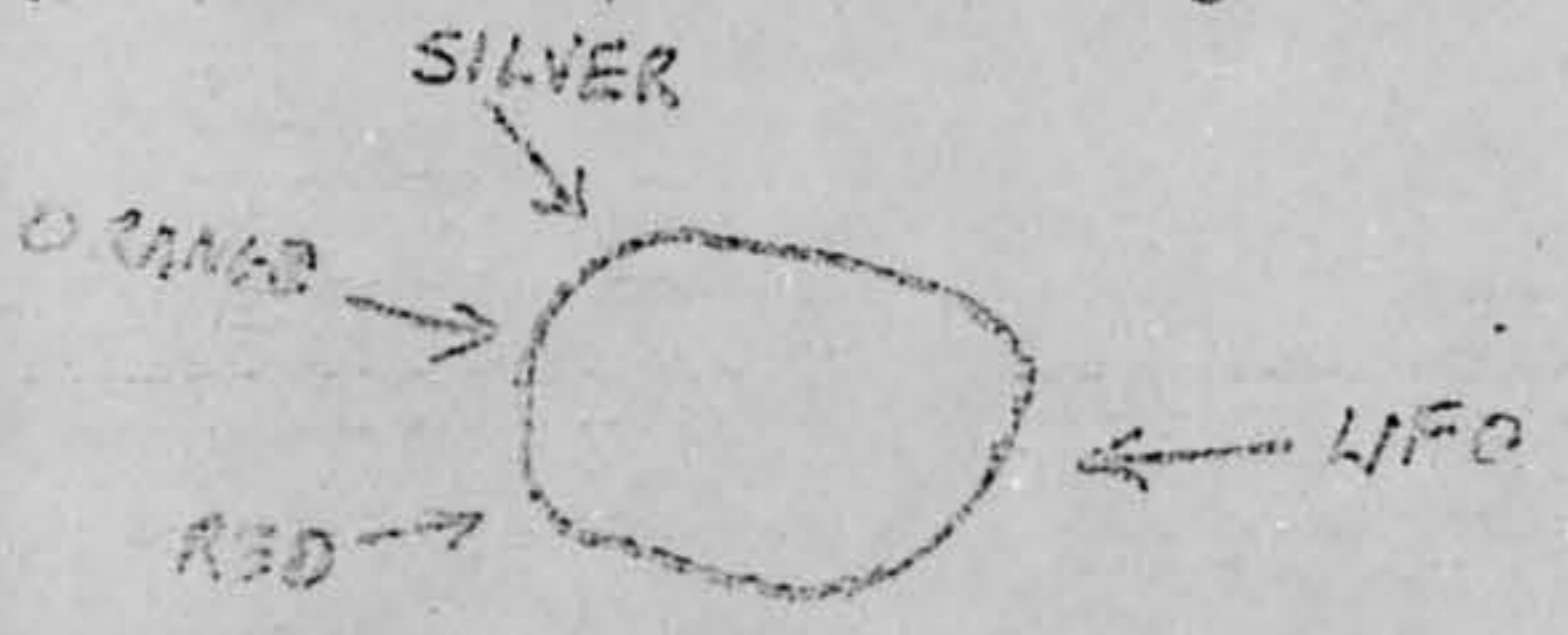

The account of this particular sighting appeared in the 31 July issue of the Quincy, Mass. "Patriot Ledger". I sent subcommittee member Bruce Kinsaid to investigate. Mr. Kinsaid interviewed the witness and had him fill out the standard NISAP UFO report form. Data from the interview and filled-out form is recorded below.

SIGHTING ACCOUNT # 1 (1st sighting)

Mr. Finley, who rises often during the night to care for his wife who has a heart condition, was up just after 3:00 AM on the morning of 31 July 1965. Glancing out of a window at approximately 3:12 AM he sighted a large glowing object in the southern sky. He got a pair of 8 X 60 German navy fieldglasses and observed the object for about 4 minutes. To the naked eye the object had the apparent size of somewhere between a nickel and a half-dollar held at arm's length. Through the fieldglasses the object looked like a glowing "fruit basket" or "old-fashioned wash tub." It varied in color from "silver on top to orange and red on the bottom." No separate lights such as airplane running lights could be distinguished. The object seemed almost as bright as the sun or an acetylene torch when viewed through the fieldglasses. It was sharply outlined with a halo of surrounding light. Its elevation in the sky was 60-70°. It moved slowly on an irregular flight path starting from the south and moving into the north, then to the north-northeast and then moving off into the west at high speed. It seemed to stop and hover momentarily for a total of 4 times along this flight path.



SIGHTING ACCOUNT # 2 (2nd sighting)

Mr. Finley continued to observe the sky at the open window in hopes of seeing the object again. His efforts were rewarded at 4:20 AM when he spotted a same or similar object and two other objects. The large object was hovering in the east when he noticed it again. While observing it through fieldglasses he saw two smaller round silvery objects fly directly over the larger object in a criss-cross pattern. One moved from NE to NW and the other from SE to SW. Then, suddenly, the large object moved fast into the west and disappeared out of line-of-sight. Mr. Finley was at a disadvantage as his view was limited by the window space.

EVALUATION:

The sky was clear and many stars could be seen. Powerful fieldglasses were used in observing the objects. Mr. Bruce Kincaid examined the fieldglasses and commented that they were excellent. He questioned the witness carefully and examined the window area from which the observations were made. Bruce felt convinced that the witness was sincere and competent. Out of the dozen or more UFO sightings he had been investigating he felt that this was the best.

It is quite apparent that the objects, especially the larger one was not a conventional aircraft and does not readily fall into the category of any conventional object. Mr. Finley stated - "I know an airplane when I see it. I'm sure that this was no plane. It makes you wonder".

It is the opinion of the investigator and myself that this sighting was of a UFO. Although most of the Massachusetts sightings in July and early August have been of known objects not recognized as such, this seems to be one of the few good UFO reports.

2nd sighting:

Reappeared some 15 or 20 sec later much lower in sky at about 35° angle.

Brilliant yellow, began to elongate horizontally, & seemed to be in a gradual downward trajectory in ENE course.

Shape  roughly fluctuating but again at great distance but looked like a massive comet 30 or 40 x's as big as any "shooting star."

Then contracted in size & seemed to disappear behind clouds but lowering margins of clouds brilliantly aglow for 3-3 minutes.

Total elapsed time about 10 minutes from initial sighting.

First impression was that a jet exploded high in sky & then as it plunged earthward burst into a flaming uncontrolled descent. But when no news report of such an occurrence it looked like I would imagine the flaming reentry of a spent rocket into earth's atmosphere after dumping its payload.

I hope this description is accurate & uncolored by the obvious excitement I felt at the time of sighting
