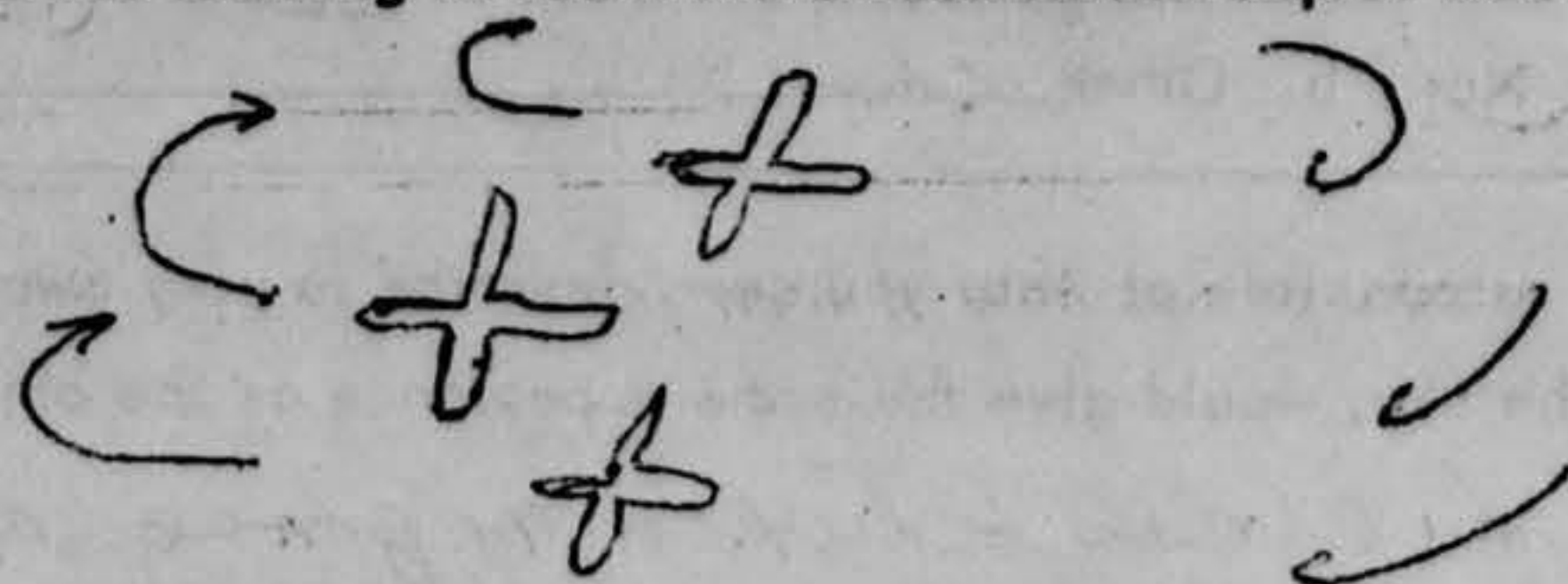

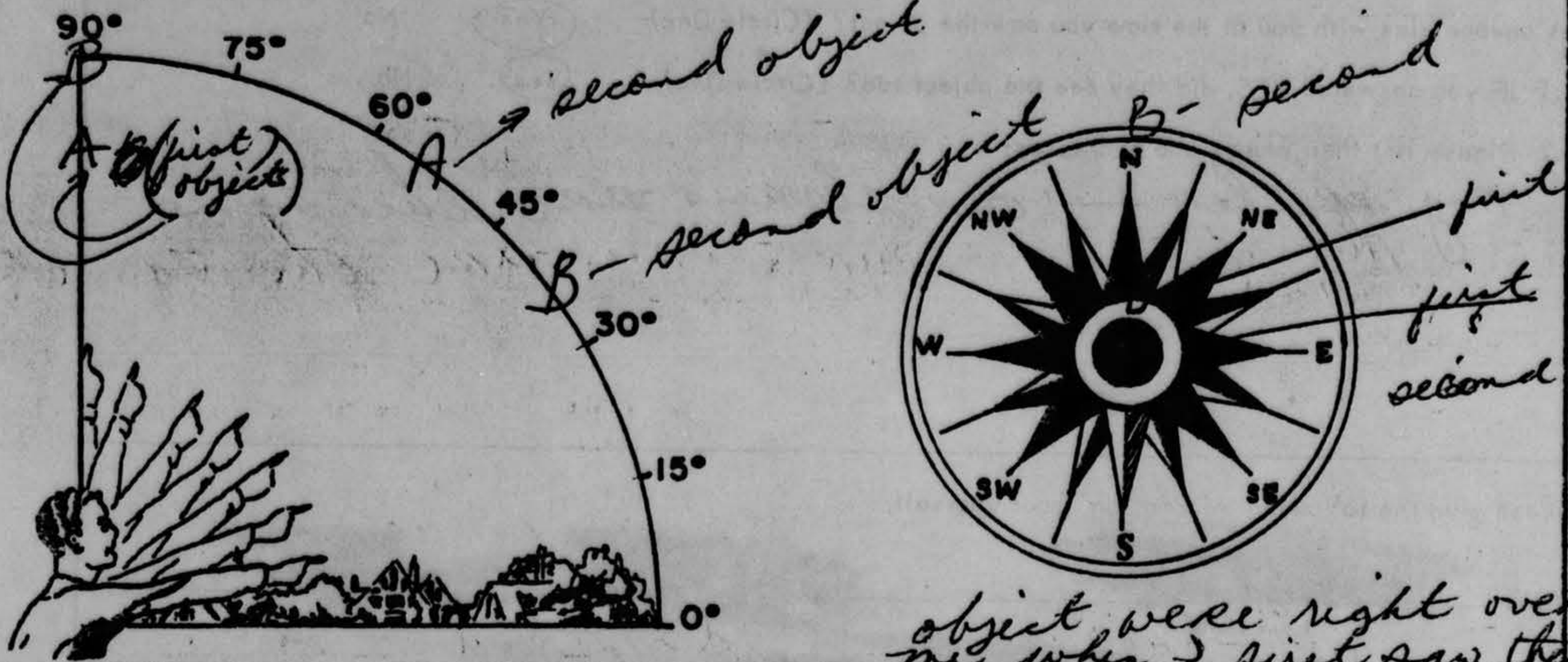

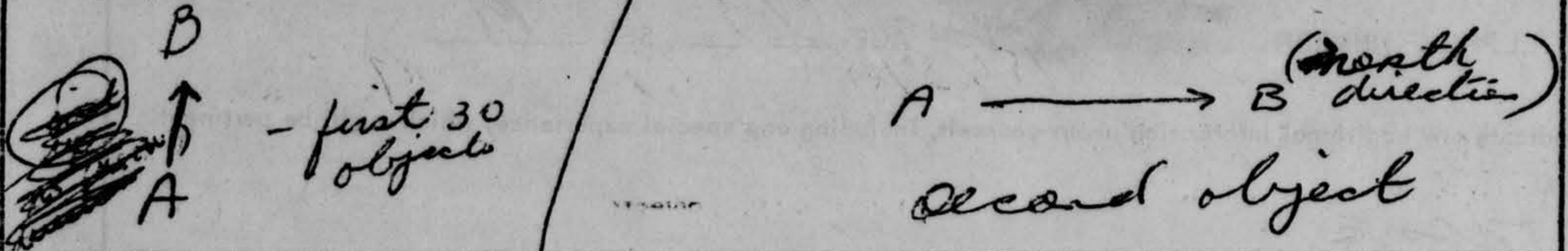

The questions are not adequate enough for my story. I was washing windows and I looked up to see about 30 objects which appeared to be geese. However closer looking showed the objects ~~to be~~ not to be acting as birds (the wings weren't flapping). It's hard to explain by writing it but they had none of the characteristics of a bird (no movement of the body itself). They appeared to be hitting into each other. They flew in a circle and at the same time were gaining height. I went in after watching for about ~~2~~ minutes from the time I first saw them (maybe 1 minute), and got my telescope. I came out 1-2 minutes later & they were out of sight. I then noticed an object like a dim star moving from about the spot the 30 objects had seemed to rise to. The bright object moved in a northern direction. My father also saw the 30 objects (OVER)

The bright object I ~~said~~ ^{said} I saw must be ~~discussed~~ discussed. Now some leaves etc were blowing not far from me. And I saw a number of ashes fly over me. It is reasonable to allow for the fact that the bright object might have been an ash.

However I clearly saw the approximately 30 objects which, by the time I returned outside, were gone. My father also saw these 30 objects (he only watched for about 30 seconds). He didn't see the bright object. Again it is very possible that it was an ash (the bright object, I mean)

That's about the best I can do - the drawing should not be so fat - the object were streamlined.






