AT 8:30 [REDACTED] CAME TO MY HOUSE, AND SAID HE SAW A BIG RED LIGHT BEHIND HIS HOUSE. I [REDACTED] WENT TO HIS HOUSE AND SAW THE SAME RED LIGHT. WE WENT TO MY HOUSE AND GOT A 22 [REDACTED] A 22 RIFLE AND WENT OUT TO THE ROLLER COSTER AND [REDACTED] FOLLOWED THE [REDACTED] OBJECT ABOUT 6 MILES FROM RIO VISTA, THE OBJECT WAS ABOUT 3 FEET OFF THE GROUND IT LANDED AND ROSE SEVERAL TIMES, AND LANDED AGAIN. WE SHOT AT IT ABOUT 6 OR 7 TIMES WE THOUGHT HIT IT AND IT SOUNDED LIKE STEEL, AND AT THE TIME WE HIT, [REDACTED] AND THEY GOT BRIGHTER EVERY TIME WE HIT IT. AFTER WE [REDACTED] IT WE GOT IN THE CAR WENT ABOUT ONE HALF MILE AND [REDACTED] TURNED AROUND, WHEN WE STRUCK BACK WE SAW THE OBJECT RISE FROM THE GROUND AND WENT UP ABOUT 10 FEET OFF THE GROUND. WE [REDACTED] OFF IN A HURRY AND WENT RIGHT STRAIGHT TO THE [REDACTED] THEY HAD ONE OF THE OFFICERS GO WITH US TO THE [REDACTED] WHERE THE OBJECT WE SAW WAS. THE OFFICER WAS [REDACTED]

CALIFORNIA YOUTHS SHOOT AT UFO: On the night of September 21st, in the midst of a local saucer flap, two 17-year-old boys from Rio Vista, California, shot a .22 rifle bullet at a flying saucer which had landed near a water tower on the edge of town. This occurred following a wild chase of eight miles, during which the youths followed the UFO until it finally landed. The bullet made a metallic sound as it bounced off the craft. The UFO was hovering just three feet above the ground at the time. It was glowing, and appeared to be about the size of an automobile hood, according to these and other witnesses. (San Diego Union, 10/1/65.)

At above time and date interviewed [REDACTED] and [REDACTED] in the office of the school superintendent MR. [REDACTED].

Both boys were emphatic in their stories regarding the object they had observed on the evening of 22 September. They both stated that this object gave off a red pulsing glow and that they had shot at it from a distance of about 100 feet and that each time they hit it, the object would give off a brighter glow. When the bullets struck this object, they sounded like they hit metal. Neither boy could give a definite description of this object other than that it appeared to be flat and about five feet across.

MR. [REDACTED], School Superintendent grudgingly admitted that he had gone out to where the object had last been sighted on the following night and apparently a large number of Rio Vista residents who had heard about this object were also at that location. Mr. [REDACTED] states that he saw this object but thought that it must have been the planet Venus on the horizon. His description of the object is the same as the one given by the boys. The object gives off a red pulsing glow, moves swiftly then suddenly disappears. He further states that possibly as many as four hundred people in Rio Vista had observed this object on this same night, September 23, 1965.

Police Chief Manuel Cardoza who was present stated that a woman in town belonged to some organization that investigates unidentified flying objects and claimed to have pictures of some sightings that she has made.

Interviewed MRS. [REDACTED], [REDACTED], Rio Vista. She stated that she is a member of the National Investigations committee on Aerial Phenomena (NICAP) she gave this officer a pamphlet issued by this organization citing numerous incidents of visual sightings of flying objects including one at Rio Vista, May 13, 1964. Mrs. [REDACTED] states that she has a number of color slides of these objects that she has taken herself and includes one that she took sometime ago that shows humanlike things in it. This particular object had landed on the outskirts of Rio Vista and she had taken this photo and when it had been developed she then noted what appeared to be small windows on the side of this object. She states that the interior can be seen fairly well and that there appears to be two small people in the object. Both are dressed in some type of flying suits or coveralls and wear helmets. This officer was shown some slides, however nothing could be made out other than what appeared to be an elongated red glow. Mrs. [REDACTED] was thanked for her cooperation in this matter.

On September 22, 1965 at 8:30 P.M. [REDACTED], [REDACTED], Rio Vista and [REDACTED], [REDACTED] Rio Vista reported to officer JOSEPH MACHADO, Rio Vista Police Department that they had sighted some kind of object behind the residence of [REDACTED] and had followed it out into the country about eight miles. Object appeared to be about the size of a car hood as they put it and gave off a red glow. Officer Machado drove out to Amerada Road with the boys to where they had last see the object, however they did not find anything. Officer Machado had the boys write statements and forwarded them to Deputy James Pennell who in turn forwarded them to the Sheriff's Office Fairfield for investigation.
