Gentlemen:

On March 31, 1966 at approximately 8:45 P.M., I was taking down our trash cans. I looked up in the sky and saw what appeared to be an airplane. It had a giant red light on the tail end. But it made no sound whatsoever. It was headed north to south. After I checked my senses I realized I was looking at a UFO. I have read all about them. One time I sent to you asking for information. You sent me Blue Book, February 1966. I re-read this. After a few seconds a plane was in the area. I couldn't tell where it was. The duration of my sighting was only about 30 seconds. The object was traveling slow, it was low; made no noise, and it was not a helicopter. The way it flew told me this: At one time it seemed to dim the red light and I could see several clear parts in the bottom. They were in two rows. Then the red light seemed to "engulf" the "thing" as it went off. The object was about 60 feet wide and the red light blinked. From the clear part I saw glowing lights. This and the red light were the only things that gave me a notion of a

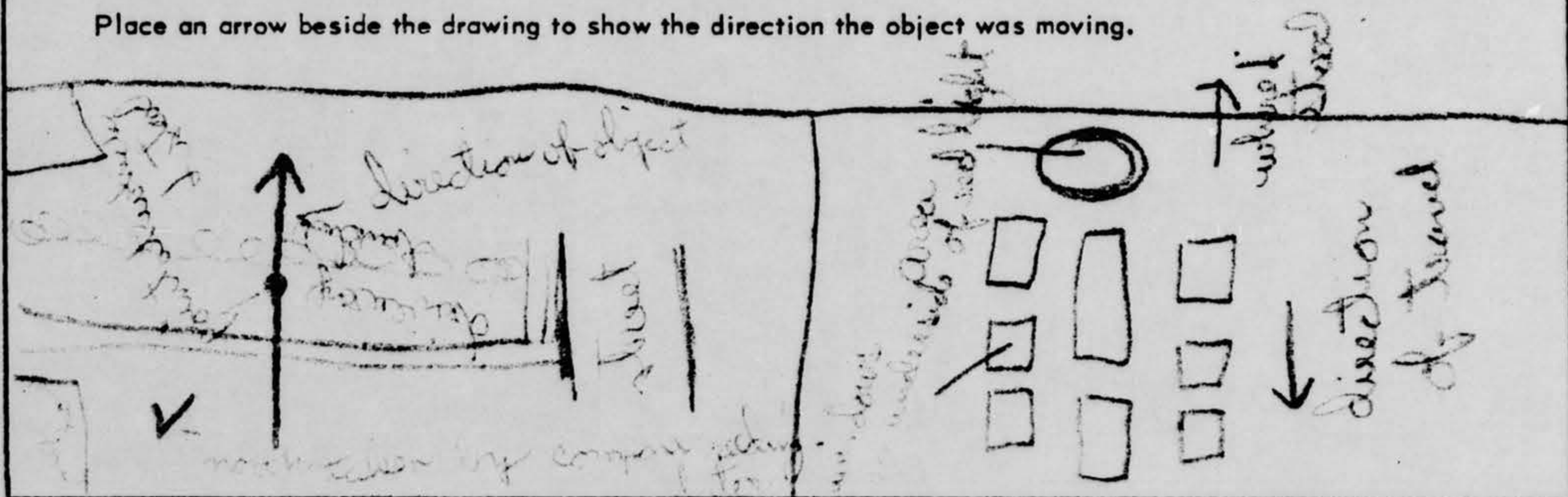

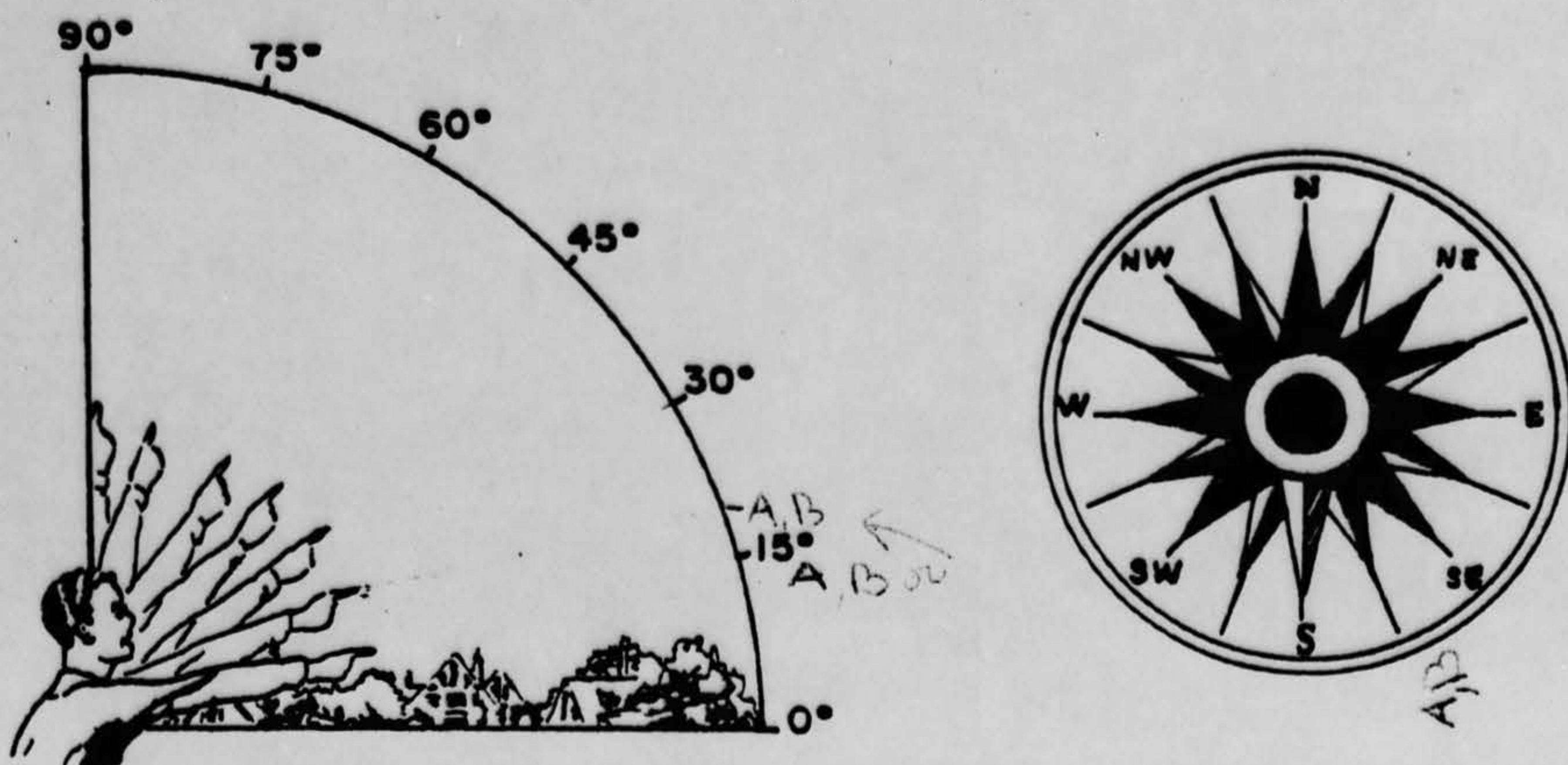
