The owner of the Collier Airport, stated he had knowledge of one A/C landing at approx the time in question. The a/c was a Cessna Skylane belonging to an attorney in Houston. The pilot stated he was on a direct flight from Houston Internation to Collier Airport at approx 2,000 ft. Made a normal rectangular path, landing to the N, but was required to make a rapid descent due to the miscalculation of the base leg. Pilot said his a/c is red and beig and has a rotating beacon on tail. Pilot stated he landed at approx 2030, which is approx 1 hour sooner than the

Mr. [REDACTED] stated he was on a direct flight from Houston International to Collier Airport at approximately 2000 feet. He made a normal rectangular path, landing to the north, but was required to make a rapid descent due to the miscalculation of the base leg. Mr. [REDACTED] stated his aircraft is colored red and beige and has a rotating beacon on the tail. Mr. [REDACTED] stated he landed at approximately 2030 hours which is approximately one hour sooner than the reported sighting and possibly could be explained by an error made in the report or by Mr. [REDACTED]. 
