I have forwarded your letter to the screening center. If they require additional information they will contact you directly. Your interest is indeed appreciated.

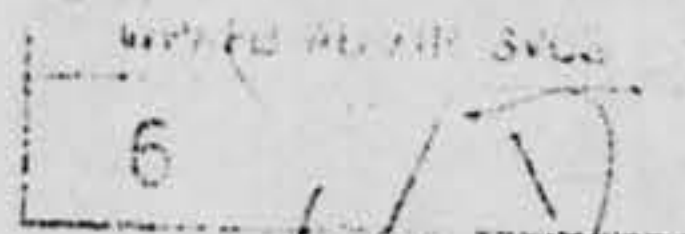
