I feel sure this was what you and the others observed. All of the reports provide quite similar information. There was no unusual objects reported by the local radar authorities.

Conversation with Mr. [REDACTED] (19 Jul 66) of Barnes Aerial Advertising, Winchester, Kentucky was flying the night of 18 July in the Dayton area. Mr. [REDACTED] was flying a 1959 Champion Aircraft with an advertising sign that had a series of lights on the bottom of plane. The plane landed at Montgomery County Airport to refuel before circling the Dayton area. Aircraft was advertising for Borchers Ford's 1966 close out sale. On the bottom of the plane are a series of lights. From either side of the craft in the distance the advertising appears only as a row of blinking lights. Area representative is Mr. [REDACTED] who will call us about [REDACTED] next flight in this and the surrounding area.

Mr. [REDACTED] contacts WP RAPCON on each flight in this area. He has been flying around the Cincinnati Area since April, refueling at the Greater Cincinnati Airport.

Mr. [REDACTED] said that a person would have to be directly underneath the plane in order to read the sign. Mr. [REDACTED] is going to send the Project Office a picture of his plane.

Mr. [REDACTED] informed the project office that he would be flying over the Dayton area on the evening of 19 Jul 66, 2030 - 2230 hours.

Conversations of 19 July 1966 regarding observations on the night of 18 Jul 66

Check with WHIO. The man who answered the switchboard said that he didn't have anything in his script about the UFOs last being a neon sign for a car dealer flying over Dayton. He said to listen to the 8 o'clock news.

Check with the Clinton County AFB, Ohio Weather Bureau - Negative.

Check with the Police Department - specifically Lt Rado. He observed what he assumed to be a sign being towed by a commercial plane. The object appeared to be going East to West, thought it was probably over Springboro. Looked to be at about 1000 ft, probably around 8 and 9 pm. If we want further information check with the Records people, Sgt Hanby. Rado hadn't given any further thought to the observation because it definitely appeared as a/c with banner in tow. He had been down to watch the Cincinnati Reds play ball the other week when Frisch's had a similar banner flying over the ball park for approximately one hour. *Records Section had nothing on it.*

Spoke with WHIO newsroom. They had gotten their information from the newspaper and therefore didn't know who the car dealer was.

There has been a man flying different advertising and he is from Winchester, Kentucky. She is going to have this man call us when he comes in for she didn't know if he was flying last night or not.

A citizen from the Dayton area called on 19 Jul 66. What he observed last night sounded like a piper cub towing pulsating lights, lights would go West to East. Plane was flying SE towards Cincinnati and Virginia. He had called WING radio station and they told him not to worry about it. He said he and his two friends thought it sounded like a piper cub.

An airplane trailing an advertisement for a local auto dealer apparently missed its mark last night, prompting a rash of reports of sightings of an unidentified flying object.

Few saw the lettering even though one man insisted the aircraft was only 200 feet above the ground.

"Apparently the pilot was flying a little too high," a spokesman for the auto dealer said, trying to explain why the advertising was not easily visible.

Callers described the aircraft as a "double-decked disk all lit up . . . and rotating," and a "mess of lights, changing forms, flying high as a jet, egg-shaped, like light bulbs on a pole."

Tom Weber, 413 Forest Park drive, said he spotted the object above North Main street at about 9:15 p.m. seeming to hover about 200 feet above the group.
