Dear Sirs:

In reference to your letter of March 16, requesting photos of, and information on, the UFO I saw at seven o'clock the night of January 18, I am enclosing all available information, and five color slides, in this letter.

I will attempt to answer the questions in the order in which they have been asked.

A. The camera is the BESELER TOPCON AUTO 100, a 35 mm. single-lens reflex, with a behind-the-lens light meter

B. To answer this question, I will quote from my camera manual "The standard UV Topcor lens is a 53 mm. focal length optic, with a fast speed of f/2, and has 6 elements in four groups. The lens focuses down to a close distance of 70 cm."

" All UV Topcor lenses have been specially coated to cut the ultra-violet rays."

C. ANCOSCHROME D-200 color slide film, with an ASA rating of 200

D. Because of the darkness, I used a shutter speed of 1/25th. of a second. It was the slowest speed I could shoot at, and still keep the camera steady.

E. I used the largest lens opening of which my lens is capable, that is, F/2

F. Filters used: none

I must, however, apologize for the poor quality of the five slides I am sending you, because of the cold, I could not hold the camera steady enough.

I am enclosing a separate slide that was taken last year, unfortunately, I can't remember when. It is a picture of the Moon in it's crescent phase, but a few months ago I projected it under high magnification, and found in one corner, a strange bluish cylindrical object. When I took these pictures of the Moon through my 3-inch reflector telescope, I had made sure that there were no aircraft around, I have marked the corner of the slide where the UFO is located with a black arrow.

Although this object was near the edge of field of vision of the binoculars it did not move out of the field of vision. Both of these facts made me believe the object was stationary. After going a short distance toward the southwest, the object made another turn and while in motion went off in a southerly direction, after which it was lost to view because of trees and houses in my neighborhood.

I took four photographs of this object, using Anscochrome D-200. The first three photos were taken with a 53MM normal lens linked to a Beseler Copton Auto-100 camera. These photos were taken while the object was stationary. I used a shutter speed of 1 second, aperture F-2. The fourth photo was made while the object was moving off to the south. It was made with my regular lens coupled with a 7 power Glanz Samigon monocular. This monocular has a 40 MM objective, same shutter speed as before.

My Mother and friends also saw an unusual object on February 3rd while going north on Route 73, at Norristown Road about 6:15 AM. It was hovering just ahead and slowly moved down and then went back up. She and her friends were on their way to work and did not see if the object moved in any direction.

1. PURPOSE: This report is written in response to Work Order Number 67-44 submitted by Major Quintanilla, TDETR, requesting photo analysis of six slides to determine what the unidentified objects may be.

2. ANALYSIS: The six slides submitted are from two separate processing dates. Five slides, numbers 13 through 17 were apparently processed in January 1967, and one slide, number 17, was apparently processed in May 1966. The image located near the corner of slide number 17, May 1966, described by [redacted] as "a strange bluish cylindrical object" is possibly the result of a processing defect. When viewed under 50 power magnification, three separate images are visible. The other five slides having a January 1967 processing date, all appear to have a very small image located near the center of the frame. Image size precludes a detailed analysis and a satisfactory explanation as to their origin.

1. Reference your unidentified observation and subsequent photographs. Please excuse the long delay; however, our present heavy workload has prevented an earlier reply.
2. Examination of the slides revealed that the image located near the corner of slide number 17, May 1966, is possibly the result of a processing defect. When viewed under 50 power magnification, three separate images are visible. The other five slides having a January 1967 processing date, all appear to have a very small image located near the center of the frame. Image size precludes a detailed analysis and a satisfactory explanation as to their origin.
3. Although a positive explanation has not been made, investigation revealed that an aircraft could have been responsible for the sighting. Of course, without essential data such as flight characteristics, angular velocity, etc., such an explanation would be only a possibility.

Dear Sirs:

About two months ago, I sent you some color slides of a UFO, and have had no word from your office since. Of course, there are probably thousands of sighting reports ahead of mine, and I realize that you must have quite a job on your hands, but I am concerned about my slides, so I am sending you a description of these slides, and the UFO itself.

I sighted the UFO on the night of January 18, 1967 at 6:55PM, it rose out of the North-west, it was a bright blue-white light, round, and with a bluish tinge to it's edges, and I cannot state it's exact size, and can only say that it seemed to be about one-quarter or one-half the diameter of the Moon.

I thought it was some sort of satellite, that rose in the north-west and set in the south-east, and from what I could make of it's course, it seemed as though it would pass close by the Moon, so I went inside to get my camera, in order to photograph what I thought would be a satellite passing by the Moon.

When I came back out however, the blue-white light had disappeared, and, instead, there was a dim reddish-orange light about one-eighth the diameter of the Moon, maybe smaller.

This reddish light moved in the same direction as the blue-white light, for a short distance, and then stopped. I verified this by watching it through a pair of 7x50 binoculars, the UFO stopped just opposite a small star, and did not move in relation to that star for several minutes, and it did not move out of the 7x50's field of vision either. It stayed motionless for several minutes.

When it did move again, it moved off to the south-west, and then gradually swung 'round to a southerly course, which it maintained till I lost sight of it.

The slides of the UFO are on Anscochrome D-200, exposure was 1/4 of a second, at aperture F/2, the slides are numbered 13, 14, 15, 16, & 17 respectively

There is also a separate Anscochrome slide that was taken through a three-inch astronomical telescope at about thirty power. It is a picture of the Moon in it's crescent phase, but in one corner of the slide, a corner marked with a black arrow, there is an unidentified object.
