2. X-ray emission spectroscopy revealed the presence of strontium, barium, potassium, and sulfur. Other minor chemical elements such as iron, boron, aluminum, and calcium were also found. It is suspected that the specimen was the aftermath of a flare or fireworks display since the principal chemicals found were strontium and potassium which are major elements of some types of fireworks.
3. Request that you inform the local citizen of our results. There was no evidence disclosed to indicate the material was extraterrestrial in nature.

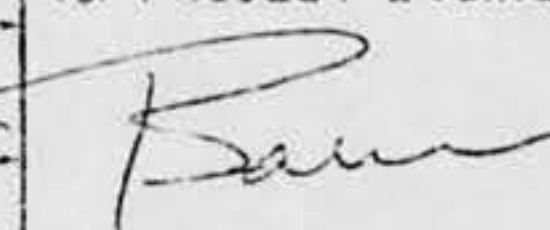
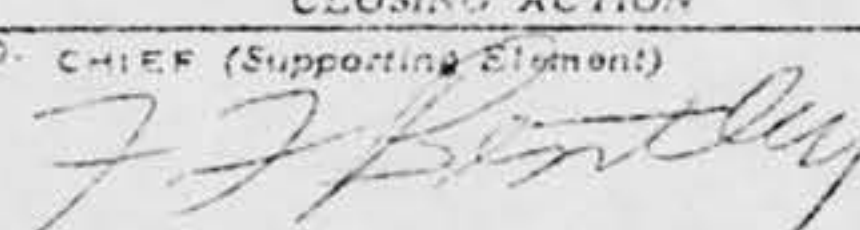

1. X-ray emission spectroscopy showed Sr, Ba, K, S, and Cl to be present.
2. X-Ray diffraction gave a very complex pattern that could not be identified. The sample was separated into a water soluble sample and an insoluble sample. The insoluble sample was identified as Sr SO₄ plus a small amount of unidentified phase. Infrared spectroscopy showed a sulfate present. The soluble phase could not be identified but appeared to be a carbonate.

No other unidentified flying object reports were submitted to the Air Force from the vicinity of Clawson, Michigan for February 8, 1967.

At this late date a meaningful scientific investigation is not possible. It is important for an individual to report his observation to the Air Force as soon as possible after the sighting.
