OF THE PREPARING OFFICER: MR. ROBERT T. BARRETT, INVESTIGATOR, SECURITY POLICE DIVISION, ROBINS AFB, GEORGIA. DURING THE COURSE OF THIS INVESTIGATION, BASE OPERATIONS, ROBINS AFB, GEORGIA, WAS CONTACTED WHICH REVEALED NO AIRCRAFT IN CITED AREA AT THE TIME REFERENCED UFO WAS SIGHTED. WEATHER STATIONS AT MACON MUNICIPAL AIRPORT REVEALED NO WEATHER BALLONS WERE ALOFT. INFORMATION FROM MACON RAPCON (FAA) REVEALED AIRCRAFT AROUND THE AREA; HOWEVER, NOEN WERE TRAVELING IN THE DIRECTION OF CITED UFO. PER A DISCUSSION BETWEEN THIS INVESTIGATOR AND MR. AB. B. DOMINGAS, DIRECTOR OF THE MARK SMITH PLATARIUM, MACON, GEORGIA, REGARDING CELESTIAL BODIES IN THE AREA OF THIS SIGHTING, IT WAS DETERMINED THAT AT APPROXIMATELY 1915 HOURS, LOCAL TIME, THE REGULAR STAR "LEO WAS LOCATED APPROXIMATELY 20 DEG TO 30 DEG EAST OF NORTH AND WAS APPROXIMATELY 30 DEG TO 35 DEG ELEVATION AND WAS THE SAME COLOR OF THE REFERENCED SIGHTED UFO.
