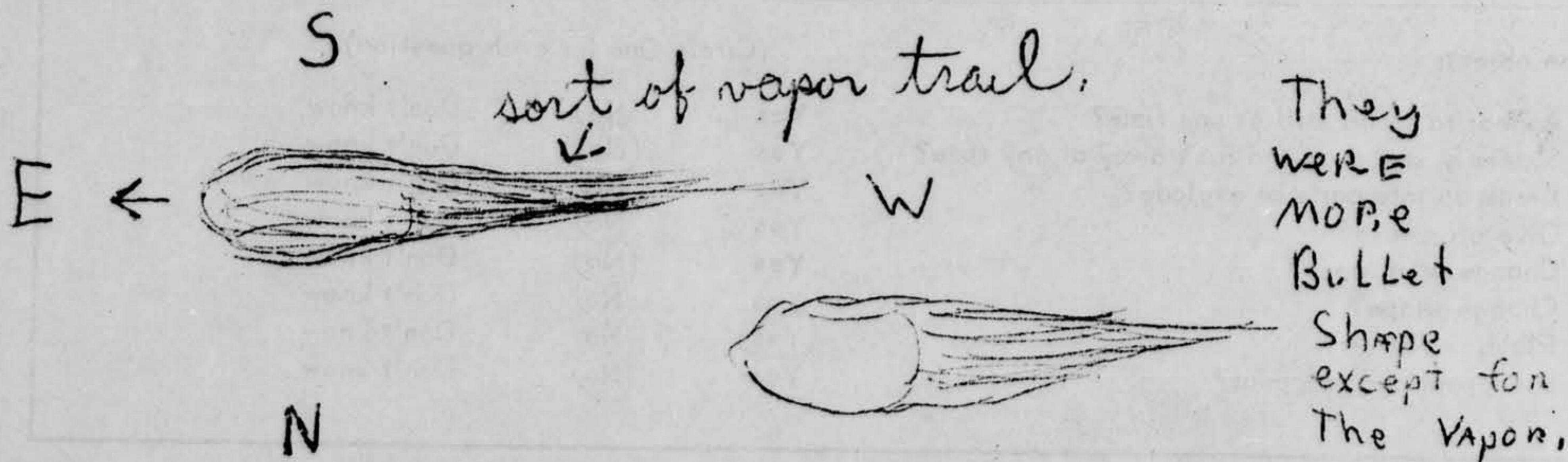

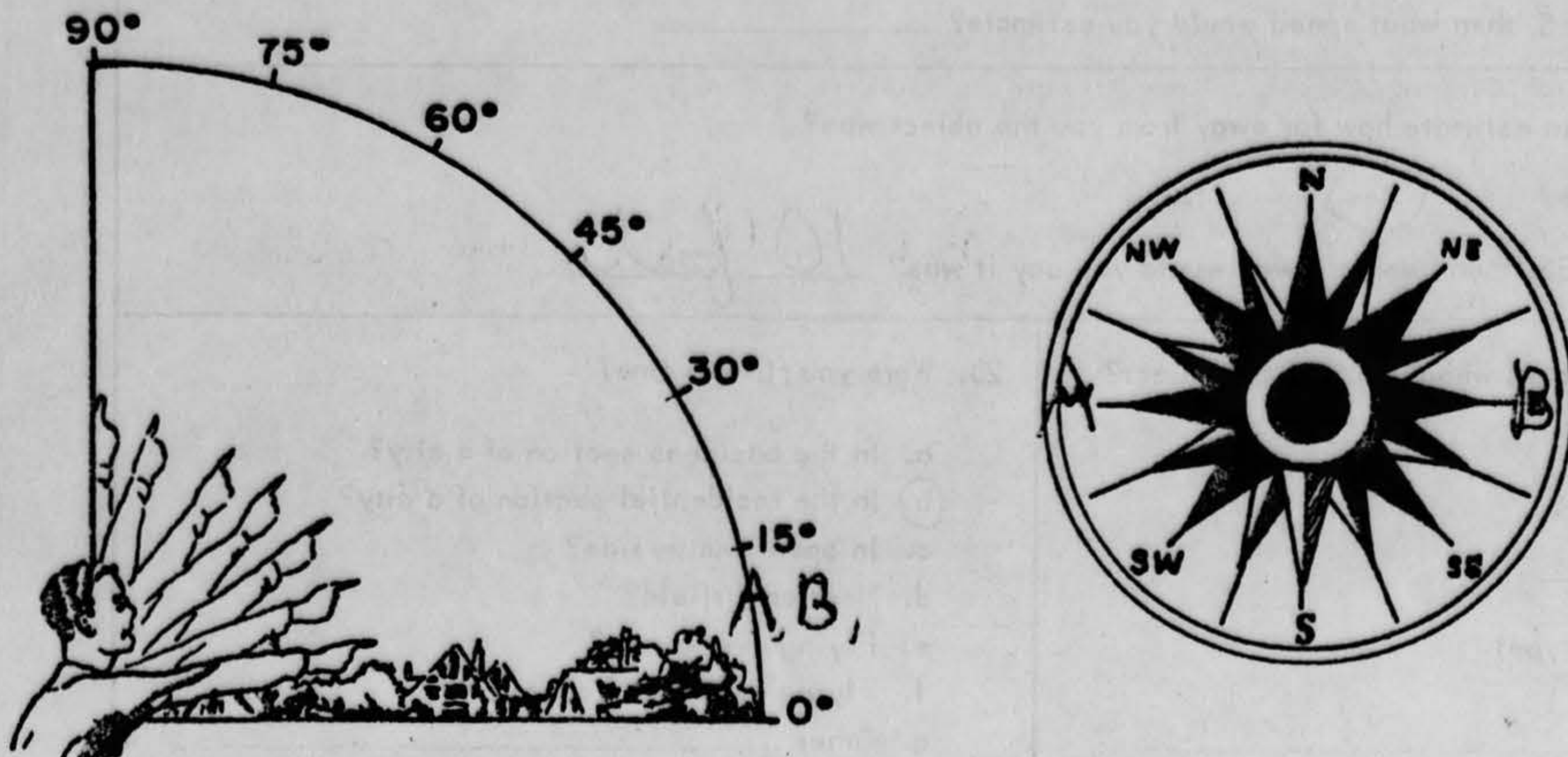

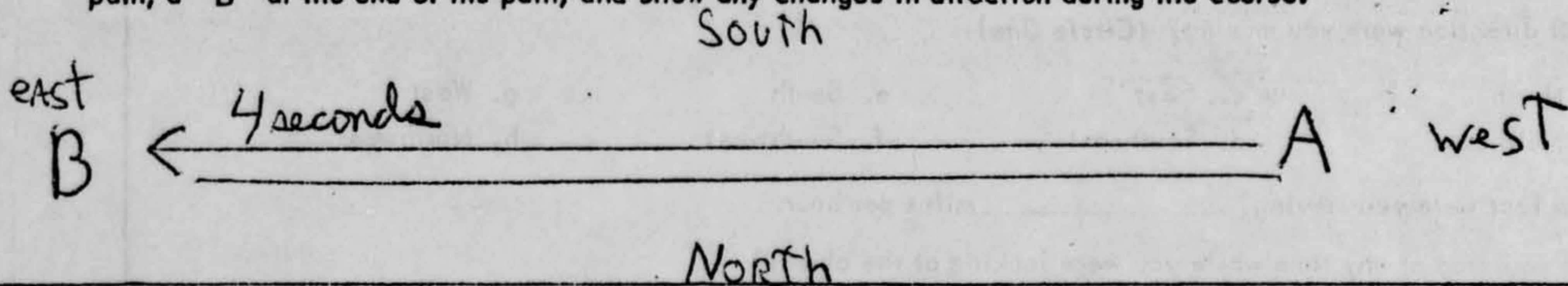

*It would look like a marble that was very bright, streaking across the sky with a vapor trail that would disappear almost immediately.*

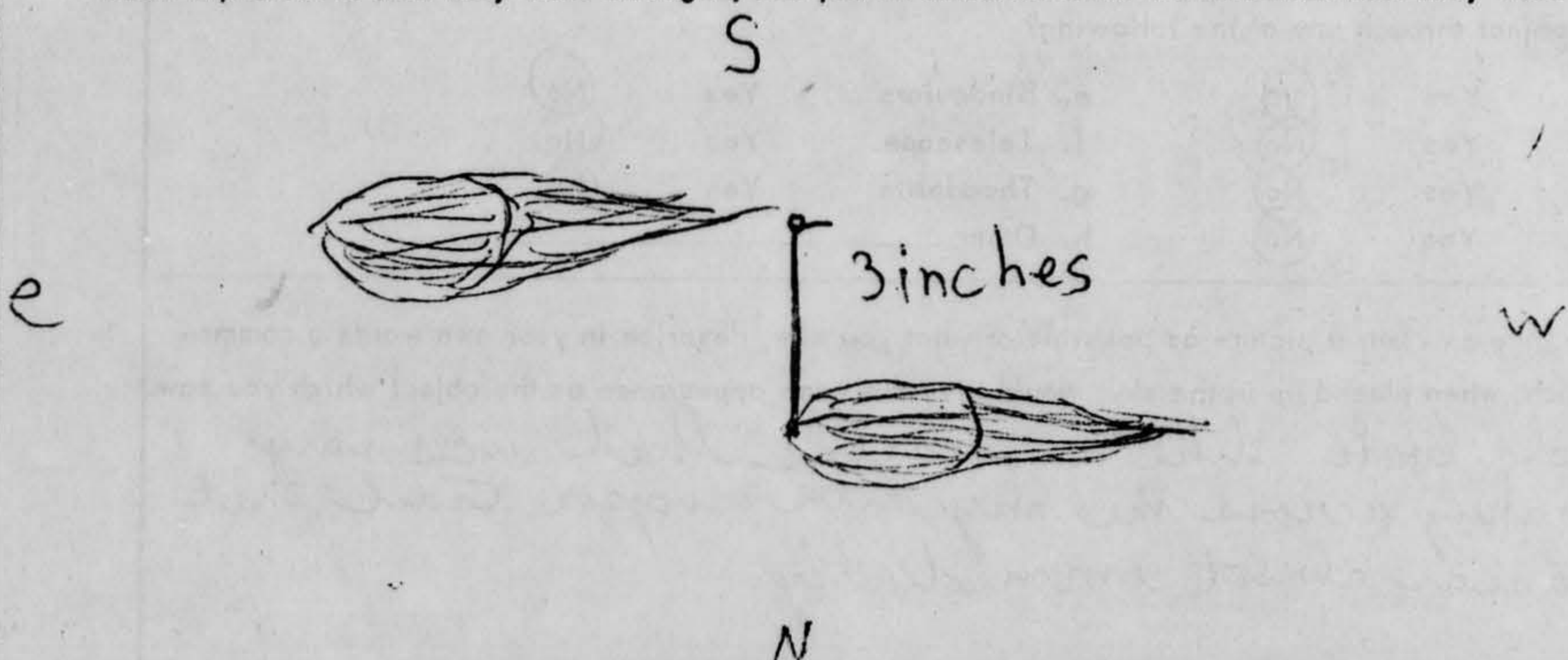
