

Description:

Mr. [REDACTED] stated that he was working the night shift at the [REDACTED] Truck Stop at Hwy 287 at Pullman Switch Road. At about 0530 to 0545 hours he went outside the station to put a package of fruit in his car. As he was returning, he noticed the tail lights come on on two tractor-trailers, which were traveling East on Hwy 287 on the overpass over Pullman Switch Road. While watching the trucks, an object to his right (East) caught his eye. The object was described as being like the edge of a plate but quite thick in the center. It remained stationary briefly then tilted, taking the form of the top view of a plate and sped rapidly away Eastward at about a 30° upward angle and disappeared into the clouds. He further described the object as being the color produced by shinning a white light through a glazed glass. No colored lights were noted.

Description:

Major Hottinger stated that she left her residence at 2500 S. Spring Street in Amarillo at approximately 0610 enroute to Amarillo AFB where she is a nurse at the base hospital. She was driving North on Eastern Street and was about to turn East onto Highway 287 when she heard a loud noise she described as similar to a wind tunnel or a tornado. She stopped her car, stepped out of it and looked around. She said she observed an object an estimated 1000 feet above and to the East of her. She looked around for other people and seeing none, she reentered her car and started driving East on 287 to find someone to which she could report the sighted object. The object preceded her Eastward at a position where she could see it just below the top of her windshield at speeds up to 90 MPH. After driving 3 miles, she pulled into a Shelly Truck Stop at Pullman Switch Road and Highway 287, went into the service station and asked the manager, [REDACTED] to come outside and observe the object. Major Hottinger said that she preceded [REDACTED] out the door and as she stepped outside, the object moved Eastward at extremely high speed. [REDACTED] got into his car to follow the object and Major Hottinger followed behind in her car. She said she continued to observe the object until she turned off Highway 287 North onto Spur Road at which time it went out of sight. Major Hottinger stopped at the South Gate Guard House and asked the Air Policeman on duty, ALC Joseph F. Winfield, Jr. if he had seen anything unusual and he said he had not. Major Hottinger then informed him of her experience and then proceeded to her duty station at the hospital on base.

Description:

[REDACTED] stated that he arrived at work at the Skelly Truck Stop about 0600. A night shift attendant, [REDACTED], related his experience of sighting an object a few minutes earlier. At about 0625, Major Hottinger came into the station and asked him to come outside to observe an object in the air. [REDACTED] said that he saw a glowing light above a farm house approximately 1 mile East of the station. The farm house has two flood lights and the glowing light was located between these lights. The object was glowing bright and then dim alternately. [REDACTED] could not distinguish any colors as he is color blind. He decided to chase the object and got into his car and started East on Hwy 287. However, by the time he started his car and headed East, the object had disappeared from his view. He drove to the first turn off to the right (a dirt road) and returned to the service station without further sighting of the object.

Description:

ALC Joseph F. Winfield, Jr. was on duty at the South Gate at approximately 0645 hours, when Major Hottinger stopped at the gate to report an object following her. Major Hottinger told him that yellow object with a red light had followed her from the time she had left her home. She reported that she stopped at a filling station to make sure of what she had seen. The station attendant then followed the object. The object stopped following the Major when she turned onto the South Gate road. About 15 minutes later Airman Winfield was looking to the rear of the gate house when he saw a yellow light or object with a red flashing light on top, drop from a dark cloud and then make a right angle turn, and travel horizontally and then go straight back up to the cloud. At that time he called Security Police Desk to report what he had seen. The size of the object was about that of a semi-truck and did not have any noise or sound at all. The location of the object was Northeast near the golf course. The object came out of the cloud about half the speed that it traveled horizontally. He guessed the object to be about 700 to 800 feet high. He saw the object for only 5 to 6 seconds from the time it appeared to the time it disappeared. He called the desk and asked for the Flight Commander but he did not come. He made a report when he got off duty.

## WEATHER CONDITIONS

A shallow inversion existed over AMA this morning from surfact to 4000 feet MSL due 3.5c to radiational cooling. A thin layer of smoke was in the area trapped under this inversion. Winds were light and variable. Sky condition, 10,000 high overcast visibility 15+. Temperature was 41° at 0600C.

### Summation:

a. This series of sighting occurred during a 1½ hour period over a distance of approximately 5 miles in a general East-West line. Times of the sightings being from 0530 to 0700.

b. A temperature inversion occurred in the sighting area during a closely corresponding time; 0530 to 0800.

c. Sunrise was at 0710 CST.

d. Aircraft in the area of sighting and bearing flashing lights and/or exhaust flames are as follows:

e. All four descriptions vary either in size, color, shape, or sound.

f. No radar sighting of unusual objects were observed.

g. A low cloud cover related to the inversion lay Southeast of and parallel to the area of sighting.

h. The sighting occurred along a line paralleled on the North by lights from the City of Amarillo, Texaco Refinery and Amarillo AFB.

No contact was made by the object with ground, persons or property nor was any residue found. No electric magnetic phenomenon was associated with the sightings.

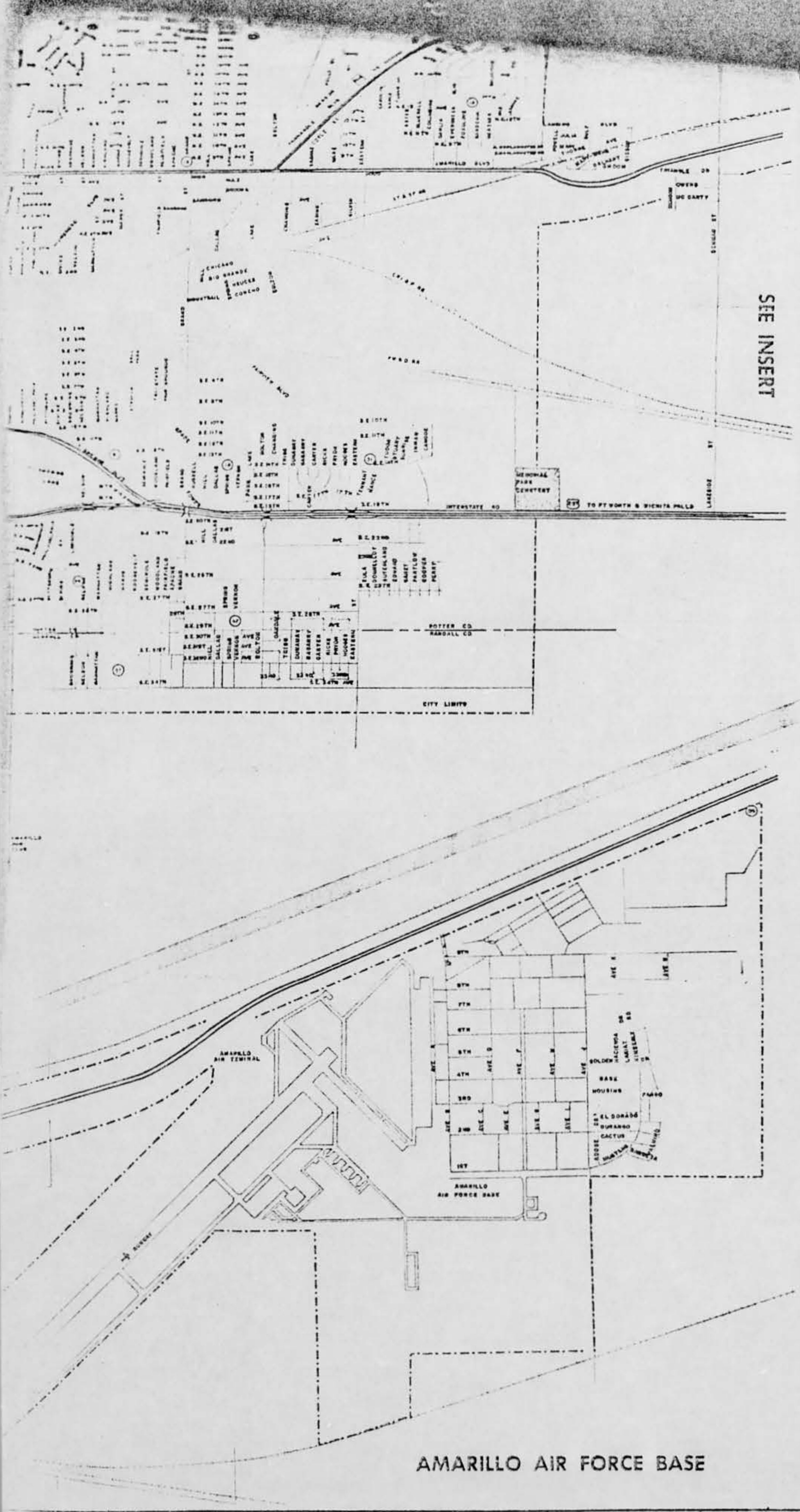
Conclusions: Based upon the conditions and circumstances cited above correlated to guidance provided by the AF - University of Colorado Conference, it appears most likely that these sightings were perceptual distortions in the form of mirages created by the temperature inversion. The loud noise described by Major Hottinger cannot be identified but could have been from one of the aircraft operating near the point of sightings.
