My next door neighbor Mr. [REDACTED] first sighted only one flying object, which he thought was a falling star. When it stopped moving, he got his pair of binoculars and watched. It had come from the south at a rapid rate of speed. He called, to us to see this object, which appeared round and had a constant glow around it. It seemed to me to have green and red lights around the base. Also there seemed to be a lot of orange flashes from the sides. The object moved up and down at a very slow rate. It moved below our tree line and then returned to the original position.

Mr. [REDACTED] went back to his home. My husband and two boys stayed outside and watched. During the time Mr. [REDACTED] was with us, my husband made the remark, Maybe we should call the Air Base. No one seemed to move, so I did call myself. I do know the object had to be seen over an hour.

When my husband and I saw a plane coming from the West. Both objects immediately left.

When I walked out to the road to get a better view of the one, we were watching, I noticed another one and called to Mr. [REDACTED], Mrs. [REDACTED] and her husband. They also saw the second one.

2. Our base investigation revealed the following:

a. Base Control Tower personnel stated that a bright star or planet was in the night sky in the general bearing of the reported "UFO" (Kewanna, Ind).

b. Base RApCon (Radar Approach Control) personnel stated that there was a temperature inversion phenomenon noted on their radar scopes in the direction of Kewanna during the period of the "UFO" sighting and may have been the source of the appearance of reflected lights.

c. No further investigation was made into this reported sighting.

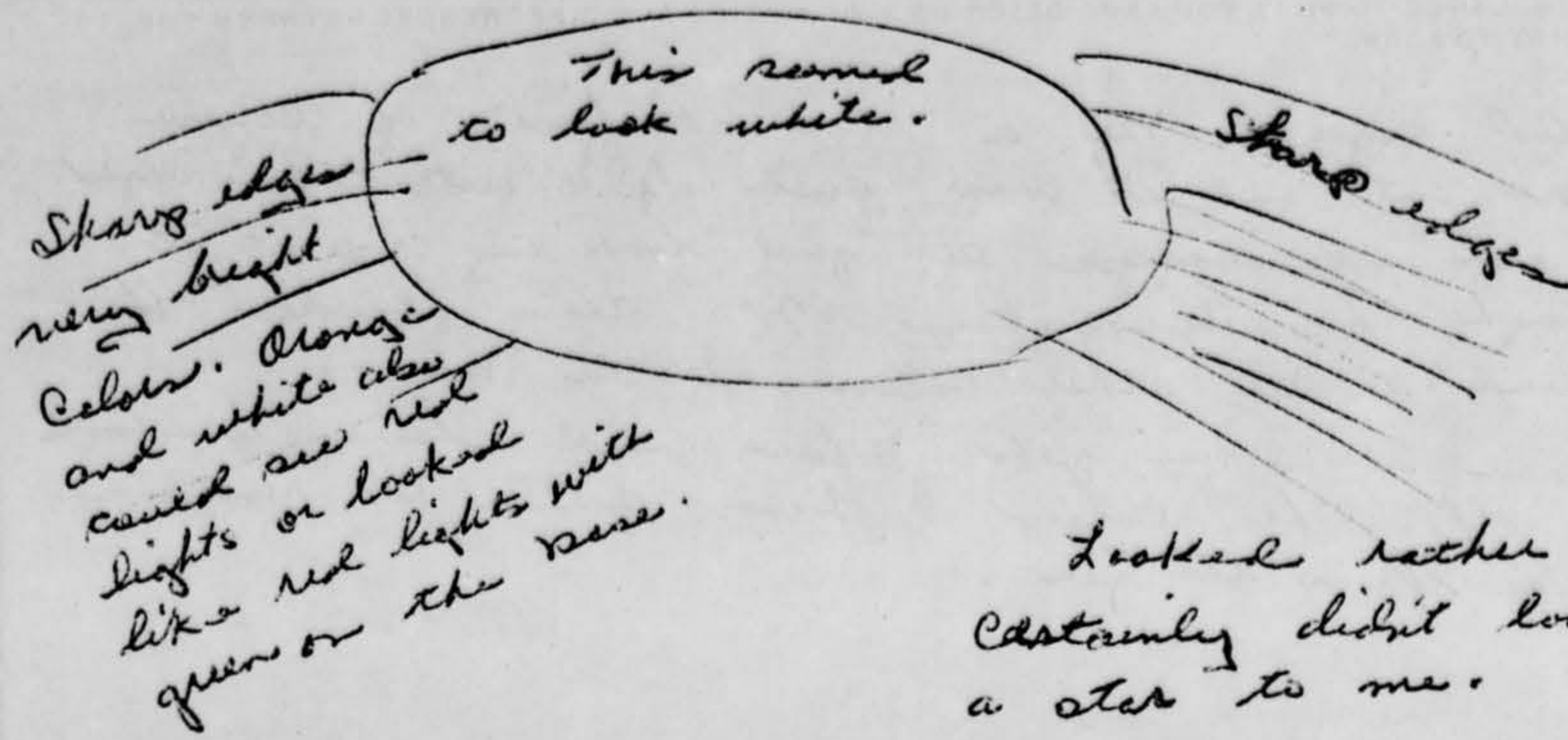
