Dear Section 40

Thank you for your report of an 'unidentified flying object' seen on 19 September 2009 over Burnley. I have been asked to reply as this office is the focal point within the Ministry of Defence (MOD) for correspondence related to UFOs.

Firstly, it may be helpful if I explain that the MOD examines any reports of 'unidentified flying objects' it receives solely to establish whether what was seen might have some defence significance; namely, whether there is any evidence that the United Kingdom's airspace might have been compromised by hostile or unauthorised air activity.

Unless there is evidence of a potential threat to the United Kingdom from an external source, and to date no UFO report has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for them if resources were diverted for this purpose, but it is not the function of the MOD to provide this kind of aerial identification service. It would be an inappropriate use of defence resources if we were to do so.

The MOD does not have any expertise or role in respect of 'UFO/flying saucer' matters or the question of the existence or otherwise of extraterrestrial life forms, about which it remains totally open-minded. I should add that to date, the MOD knows of no evidence which substantiates the existence of these alleged phenomena.

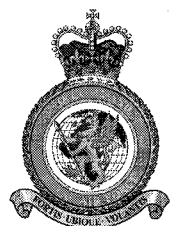

To continue. I ran to the fish and chip where the Greek **Section 40** and five other people were. Some were eating fish and chips. I said at the door, 'Quick, Quick, you all must see this, a UFO has landed in the King George IV resevoir.' With this five or six people, including **Section 40** the Greek ran to crossroads where we observed the objects darting about 60 feet above the resevoir for about 45 minutes. At this point **Section 40** and the others agreed with me that it was a UFO landing. We did not know what to do, if we should call the police or not for fear of being ridiculed. The lights had then gone. Although I think the police already knew. They do know now.

After 45 minutes the two site objects with darting about movements descended inside the retaining bank of the resevoir, still connected to the cable.

After this we all went home our own ways. Very quiet indeed.

Two days before this happened the whole Lee Valley was a pea-souped, fog, in other words, covered the area. Being a Sunday it was very quiet indeed. I think that this is when UFO came down into the resevoir being 29 feet deep and what I and the others saw was a form of scanner, so to speak. Looking at logic, breaking down logic, and working at what you have left with it would seem to be a good UFO landing report.

I did inform **Section 40** of BEFORY. In 1972 after contacting **Section 40** I became an Area Investigator for Befory. Before I left London in 1974 I became an Assistant National Investigations Co-ordinator. **Section 40** deputy.

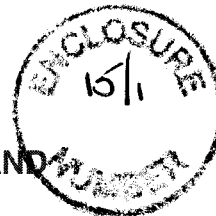

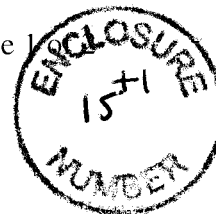

Unless there is evidence of a potential threat to the United Kingdom from an external military source, and to date no 'UFO' report has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for them if resources were diverted for this purpose, but it is not the function of the MoD to provide this kind of aerial identification service. It would be an inappropriate use of defence resources if we were to do so.

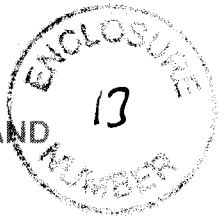

Thank you for your recent letter to Secretary of State for Defence, Bob Ainsworth, concerning the views of the Disclosure Project. It has been passed to this office to deal with as we have responsibility for answering questions relating to UFOs.

Firstly, it may be helpful if I gave you some background about the Ministry of Defence (MoD) role in UFO matters. Despite what many people think, the MoD does not have any expertise or role in respect of 'UFO/flying saucer' matters or the question of the existence or otherwise of extraterrestrial life forms, about which it remains totally open-minded. I should add that to date, the MoD knows of no evidence which substantiates the existence of these alleged phenomena. Consequently, we hold no information about extraterrestrial technologies.

However, the UK Government is naturally concerned about energy use and to this end we are committed to reducing carbon emissions. We are fully committed to meeting cross-governmental targets to reduce emissions from the defence estate and business travel and are a key player in efforts to ensure that government procurement is increasingly sustainable, and have carefully monitored targets to ensure we are fulfilling our obligations to the government. Additionally, the MoD is looking to develop new technologies that reduce our carbon footprint. For example, we are currently investigating the use of synthetic aviation fuel including fuel made through the hydrogenation of vegetable oils.

Returning to the MoD's role in UFO matters in general, we examine any reports of 'unidentified flying objects' we receive solely to establish whether what was seen might have some defence significance; namely, whether there is any evidence that the United Kingdom's airspace might have been compromised by hostile or unauthorised air activity.

I would add that the MoD is being open on the matter of UFOs. We make it quite clear to anyone who asks what our limited role in UFO matters is and are currently undertaking a three year programme to release some 160 UFO files covering the period of the late 1970's to 2007 to The National Archives by the close of 2010. It is hoped that files for the period 1992-2000 will be transferred by the end of this year and they will be made available for viewing on the internet. The National Archives can be contacted at www.nationalarchives.gov.uk.



In addition to this programme, since 1967, following an increase in public interest in this subject, "UFO" report files are now routinely preserved. Files for 1967 to 1992, and any files prior to 1967 which did survive, are already available for examination at The National Archives, Ruskin Avenue, Kew, Richmond, Surrey, TW9 4DU, Telephone: 0208 876 3444. Details of how to access these records and The National Archives on line catalogue can be found on their website.

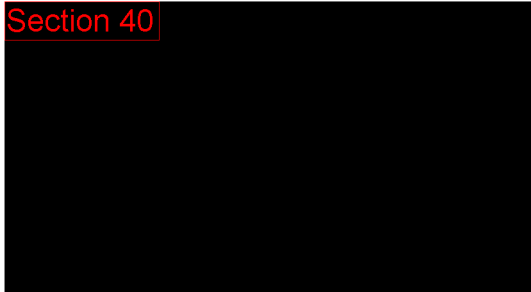

Thank you for your letter to Her Majesty The Queen stating your concern that the government are refusing to reveal the truth behind its UFO files or to act on the seriousness of the UFO issue. 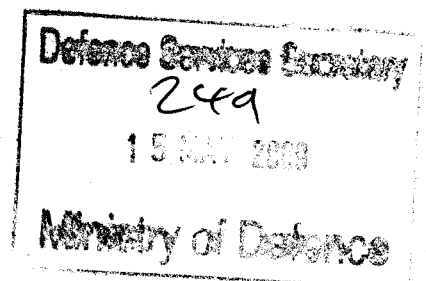

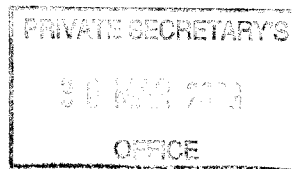

UFO spotted by police helicopter

A police helicopter crew has spotted what is described as an unusual aircraft in the Vale of Glamorgan.

The helicopter was above St Athan, which is home to an RAF base and close to Cardiff International Airport.

But three-man crew could not capture any images before the object vanished over the Bristol Channel on 8 June.

South Wales Police said the helicopter did not give chase and described the crew as very experienced. The sighting has been reported for investigation.

The helicopter was hovering in the sky at 0040 BST above the base, waiting to land.

A police spokesperson said: "The crew are very experienced and responded in a professional manner in relation to what they saw.

"In today's skies, there are a wide variety of aircrafts which come in a range of different shapes and sizes and in all probability, this sighting has just confirmed that one of these was in the area at the relevant time," the spokesperson added.

A Ministry of Defence spokesperson said it had heard nothing about

the incident.

"But it is certainly not advisable for police helicopters to go chasing what they think are UFOs," the spokesperson said.

Cardiff International Airport said air traffic control provided a service to the police helicopter to ensure it had appropriate air space, including allowing it space to return to RAF St Athan to refuel.

Meanwhile, a Cardiff pensioner says he also saw something "peculiar with lots of flashing lights" on the same day.

George Withrington, of St Mellons, said he reported the sighting to police and was given an incident number.

The ex-RAF glider pilot said he was sitting in his garden reading a book on 8 June when he spotted the object at around 1620hrs.

"I was looking at an aeroplane overhead when I spotted this thing was in the corner of my eye.

"It shifted direction very quickly, in the blink of an eye.

"I looked at it for quite a while, i was watching it for at least 10 minutes. It flew off towards the east, towards Newport."

Author Richard Foxhall, who lives in the Nantlle Valley, Gwynedd, has written a book about his experience of seeing a UFO in 1996.

Mr Foxhall has called for the report into the Vale of Glamorgan sighting to be made open to the public.

"The helicopter crew, who are experienced, saw something which was in the air space around Cardiff International Airport and St Athan air base.

"If this was Heathrow there would be an inquiry," he added.

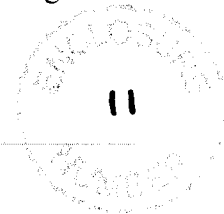
Mr Foxhall said he saw a low-flying object over Tal-y-Mignedd in Snowdonia over the May bank holiday weekend, 12 years ago.

He was returning home at around 2030 BST and saw an object similar to "nothing he had seen before".

Mr Foxhall contacted all local airports, RAF Valley and checked with the authorities and found no flight records had been logged.

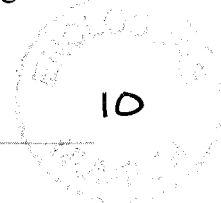

Thank you for your e-mail of 7 February 2009 to Secretary of State for Defence, John Hutton, reporting a UFO sighting. It has been passed to this office to deal with as we have responsibility for answering questions relating to UFOs.

Firstly, I think it would be helpful if I gave you some background about the Ministry of Defence (MoD) role in UFO matters. Despite what many people think, the Ministry of Defence (MoD) does not have any expertise or role in respect of 'UFO/flying saucer' matters or the question of the existence or otherwise of extraterrestrial lifeforms, about which it remains totally open-minded. I should add that to date the MoD knows of no evidence which substantiates the existence of these alleged phenomena. The MoD examines any reports of 'unidentified flying objects' it receives solely to establish whether what was seen might have some defence significance; namely, whether there is any evidence that the United Kingdom's airspace might have been compromised by hostile or unauthorized foreign military activity.

Unless there is evidence of a potential threat to the United Kingdom from an external military source, and to date no UFO report has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for them if resources were diverted for this purpose, but it is not the function of the MoD to provide this kind of aerial identification service. It would be an inappropriate use of defence resources if we were to do so.

I hope this helps explain the MoD's position.

At the Ministry of Defence we receive a lot of UFO reports but I want to reassure you that we have never received one that we thought was a threat to people's safety.

We only ever investigate a handful of reports like yours a year because it would be very expensive to investigate them all, but we suspect that if we did, most of them would be caused by aircraft, stars or the light playing tricks with people's eyes. When we do investigate them, it's only to see if the country's airspace might have been affected but we haven't any evidence of this so far.

I have checked our records but I can't find any trace of any other reports of UFOs at Chesham this year.

Thank you for your e-mails of 15, 16, 17 and 21 February 2009 to Secretary of State for Defence, John Hutton, expressing your belief that the Ministry of Defence (MoD) should investigate UFO sightings more thoroughly. They have been passed to this office to deal with as we have responsibility for answering questions relating to UFOs. You also wrote direct to this office on 17 February 2009 along similar lines. This response will cover all your correspondence.

As I explained in my letter of 13 February 2009, the MoD does not have any expertise or role in respect of 'UFO/flying saucer' matters or the question of the existence or otherwise of extraterrestrial lifeforms, about which it remains totally open-minded. I should add that to date the MoD knows of no evidence which substantiates the existence of these alleged phenomena.

The MoD is not complacent about the integrity of the UK's airspace which is maintained through continuous surveillance of the UK Air Policing Area by the Royal Air Force. This is achieved by using a combination of civil and military radar installations, which provide a continuous real-time "picture" of the UK airspace. Any threat to the UK Air Defence Region would be handled in the light of the particular circumstances at the time (it might if deemed appropriate, involve the scrambling or diversion of air defence aircraft).

From that perspective, reports provided to us of 'UFO' sightings are examined, but consultation with air defence staff and others as necessary is considered only where there is sufficient evidence to suggest a breach of UK air space. The vast majority of reports we receive are very sketchy and vague. Only a handful of reports in recent years have warranted further investigation and none revealed any evidence of a threat. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for UFO sightings if resources were diverted for this purpose, but it is not the function of the MoD to provide this kind of aerial identification service. It would be an inappropriate use of defence resources if we were to do so.

As I am sure you can imagine, the Secretary of State and the Chief of Air Staff are both extremely busy and it will not be possible for them to speak with you.

It is the Royal Air Force's responsibility to ensure the protection of your country the United Kingdom's airspace from any possible threats, including investigating the truth behind classified UFO reports, to ensure the United Kingdom is protected, even possibly against extraterrestrials. It is your job, you have an obligation You could act now, but it seems that most Government bodies around the world that are approached by Ufologists' regarding the high chance of the threat of extraterrestrial UFOs, simply think we are crazy. I can personally assure you that most Ufologists are well respected PhD scientists.

You must investigate immediately. I would personally speak with your Secretary of State for Defence or the head of your Royal Air Force, but unfortunately air travel is expensive due to the

It is a pleasure to be writing to you, sir. I am writing to you in from Australia. The reason I am writing to you is in regards to a subject I wish to bring to your attention. To be honest, what I have to say may sound unusual, but please hear me out. I am a UFO researcher, it is a hobby of mine, and I study UFO sightings as best I can through research. I believe I have the answers to the unexplained UFO (extra terrestrial craft) encounters across the United Kingdom.

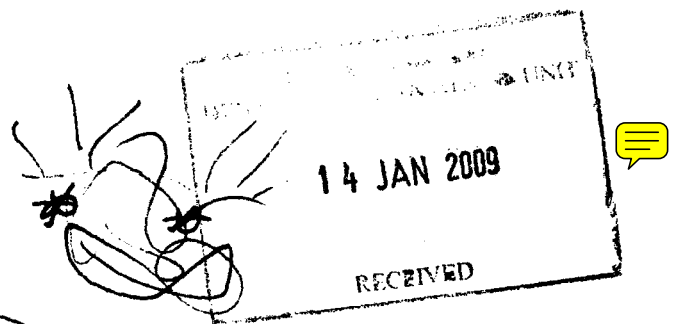
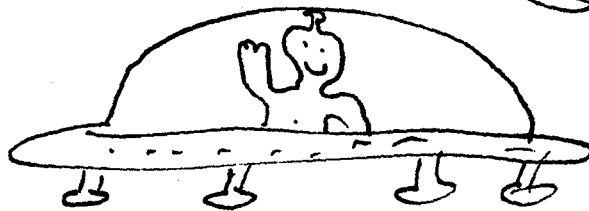

It has been passed to this office to deal with as we have responsibility for answering questions relating to UFOs.

Firstly, I think it would be helpful if I gave you some background about the MoD role in UFO matters. Despite what many people think, the Ministry of Defence (MoD) does not have any expertise or role in respect of 'UFO/flying saucer' matters or the question of the existence or otherwise of extraterrestrial lifeforms, about which it remains totally open-minded. I should add that to date the MoD knows of no evidence which substantiates the existence of these alleged phenomena. The MoD examines any reports of 'unidentified flying objects' it receives solely to establish whether what was seen might have some defence significance; namely, whether there is any evidence that the United Kingdom's airspace might have been compromised by hostile or unauthorized foreign military activity.

Unless there is evidence of a potential threat to the United Kingdom from an external military source, and to date no 'UFO' report has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for them if resources were diverted for this purpose, but it is not the function of the MoD to provide this kind of aerial identification service. It would be an inappropriate use of defence resources if we were to do so.

I can however, tell you that the MoD received no other reports for Scunthorpe on 21 December 2008.

The MoD examines any reports of 'unidentified flying objects' it receives solely to establish whether what was seen might have some defence significance; namely, whether there is any evidence that the United Kingdom's airspace might have been compromised by hostile or unauthorized foreign military activity.

Unless there is evidence of a potential threat to the United Kingdom from an external military source, and to date no 'UFO' report has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for them if resources were diverted for this purpose, but it is not the function of the MoD to provide this kind of aerial identification service. It would be an inappropriate use of defence resources if we were to do so.

The MoD receives in the region of 100-200 UFO sighting reports each year. Whilst some do indeed appear to be near military bases etc, the great majority do not. You may be interested to know that details of UFO sightings received by the MoD for the period 1997-2007 are available for viewing on the MoD website at www.mod.uk by searching under "UFO Reports". Details for 2008 will be available in the near future.
