**February 24, 2009 Albuquerque, New Mexico** - At the end of Part 18, of my June 29, 1998, interview with Stein at his Florida home, he was talking about the Wackenhut

security firm that worked with the CIA in the 1950s. It was also Wackenhut in Coral Gables, Florida, that his phone manager friend told him [ See Stein [Earthfiles Part](#) ] was the source of the first call to Stein warning him not to talk with me further about the name of the southeastern military base or its activities during the Cuba stand-off with the Soviet Union or its alleged assassin squad assigned to termination missions. During his work for the Army/CIA unit that studied *real* UFO Blue Book cases, Stein said, “We could call Wackenhut for background checks on civilians coming to do work. Wackenhut is a worldwide security firm with offices in Europe.”
